JOURNAL OF OPERATIONS

DATE: 1 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0020A to 1730A

PLACE: MENCHHOFFEN, FRANCE (826291)

0020 - 1st Bn S-2 called S-2 and said he thinks the artificial moonlight has been adjusted as well as possible. He also said that he planned on going with the patrol this morning.

0100 to 0700 - Negative reports given to G-3.

0930 - Div informed us that Rcn Troops will fire 37-mm gun at 0930 into 20 ft bank at (826259). (Battalions and Spec Units notified by Lt. HUGHES).

1004 - 00 lst Bn called S-6 and told him the fox holes on his front line are caving in. As to a raid on ROTHEACH it will have to be a night raid. Co "A" will do the job but lst Bn 00 said he'll need a Res. S-6 said he would be up to the lst Bn OP or send his S-3 up.

1145 - New OP opened at INGWILLER.

1254 - S-3 called Major GILLMAN and told him that we wouldn't need any more tanks on this raid.

1400 - G-3 called S-6 and said the Div Comdr thinks we may need more of tank unit. S-6 told him plans not quite sufficiently developed yet but would have S-3 call him regarding this later this afternoon. Also Div Comdr directs G-3 that he (G-3) talk to officers commanding tonight's raid and tomorrow's also. S-6 arranged for him to meet raid Commanders at 1st En CP at 1600 or to be guided to where they will be present.

1432 - S-3 called Ex 0, 1st Bn and told him G-3 wants to see the leader of your raiding party at 1600 tonight. If he could not meet him at your CP take G-3 up to where your raid leader is. Have G-3 call 2d Bn when he is done with you.

1530 - S-3 called 409th S-3 andasked them if it would be OK to leave one company of 411th in ZUTZENDORF. They said it would be OK.

1615 - Lt RITTMAN called and gave the following information on PW taken by Co "K":
He was a deserter from 3d Bn, 15th Co, 6th SS Div. Same outfit that pulled raid on SCHILLERSDORF. His Battalion has pulled out with approximately 60 men out of the original 300. Bn moved out 2 days ago to reorganize in BARRNTHAL.

1705 - 411th S-3 called and wants his Battalion attached to us assembled in OBERMODERN by 0800.

1720 - 00 2d Bn, 411th ordered to close his Battalion into OBERMODERN by 0800 tomorrow at which time they will be relieved from attachment.

1730 - 409th S-3 wants a copy of our old RRL on 1/25,000 all the way across our Zone.

TIME: 1750A to 2359A

PLACE: INGWILLER, FRANCE (809304)

1750 - 1st Rn S-2 reports that their "B" Co observed a German soldier harrying along the road from ROTHBACH to BISCHHOLTZ.. He was on foot and they didn't fire on him as they wanted to see where he went. "B" Co men think he was a messenger. They couldn't observe what building he went into.

1827 - Asst G-2 (Capt DREXEL) called and said G-2 thinks the 2d Bn of the 118th Regt is now in MUHIHAUSEN. S-2 told him if the 4th and 5th Co's are in there it is possible that it is the 2d Bn with the 4th Co attached, although he thought it was the 1st.

1840 - German prisoner captured belongs to the 6th SS Mountain Division. Says his outfit is going up to BRANDEMEURG to recondition and refit. Says a Volka Grenadier Division is now on our front but doesn't know which one.

2200 - S-3, 409th called S-3 and informed us that 2d Bn, 409th completed relief of our Co "I" and one Plat of Co "L" on MLR. Command of sector assumed by CO, 409th Infat this time. (G-3 informed)

2300 - S-3 to 00 lst Bn; Was informed that Co "A" raiding party is back from ROTHBACH with no PW's. We had one man killed and 2 wounded. (G-3 informed).

2359 - Informed G-3 that we would not turn on artificial lights as our Co "B" and 2d En of 409th on our right were digging.

DATE: 2 February 1945

ORGANIZATION: 410TH INFARTRY

TIME: 0117A to 0905A

PLACE: INGWILLER, FRANCE (809304)

Oll7 - 1st En to S-6: There was a fire fight in the neighborhood of MUHLHAU SEN that lasted from 0055 to 0105. A lot of automatic weapons fire was heard some of which was believed to be Kraut.

0200 - Sgt WIELAND (1st Bn) reports an OP observed rocket-type artillery fire heading SE from UHRWILLER. From the trace of the shell the range was estimated as 3 miles.

3d Bn had nothing to report. (Above given to G-3.)

0300 and 0400 - Negative reports given to G-3.

0411 - 1st Bn OP reports fire fight now on both flanks of MUHIHAUSEN.

0500 - Negative report given to G-3.

0549 - 2d Bn CO turned in this preliminary patrol report: "Didn't get into the town (MUHLHAUSEN). No prisoners taken. Had two men wounded. Estimate 4 or 5 Krauts killed or wounded. Germans were waiting for our patrols and opened on them with American MG's. Apparently they were alerted by patrol action in BISCHHOLTZ. Drew some mortar fire and upon withdrawing patrol called for artillery on it. Mortar fire was believed to be coming from the woods."

0600 - 1st Bn turned in negative report. 3d Bn reported that their Co "K" carried out their part of raid (Co "F" raid) successfully. Reported same to G-3.

0730 - 328th Engr S-2 said they called off painting vehicles white but if we wanted any whitewash to do so, we could get it from them. Lt HUCHES said he didn't think we would be using any.

0825 - C/S to S-6: You are to come down to Asst Div Comdr at 1015 to discuss the two raids of last night.

0845 - S-6 informed 1st Bn that he would be at their CP at 0945 and wanted the latest information on their raid. Informed 2d Bn he would be at their CP at 0930 and wanted more detailed information on their raid.

0855 - 3d Bn S-3 called S-3 and asked for information on Co "F" raid last night. S-3 told him that Co "F" didn't even get into the town. Krauts were waiting for them outside of town. S-3 instructed 3d Bn S-3 tonight on the relief on the big draw in front of BISCHHOLTZ.

0905 - G-2 (Major RHEA) called S-3 and told him that the Rcn Troop didn't do so well last night as the enemy seemed to be very alert. The 36th Engrs shot a German soldier 20 yards in front of their front lines. Said he was from the 5th Bn, 6th SS Artillery, but there is no 5th Rn. They will check his sole book and find out.

DATE: 2 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0940A to 1331A

PLACE: INCWILLER, FRANCE (809304)

0940 - MP officer called S-3 and said that all the pass forms had been changed and whoever received the information in the War Room hadn't passed it on to him. Said he had informed the Mayor of INGWILLER that if anyone was out after dark he would shoot them. Said he picked up about 4 last night who could speak perfect English.

0950 - 00 of Co "B", 761st Tk Bn called and seid they would be firing Tommy Guns at (807270) beginning at 1045 this morning. (Informed all Bns, 383d FA Bn, MP officer AT and Cn Co's)

1000 - 411th S-3 said their 2d Bn closed into BOUXWILLER at 0807.

1010 - 411th S-2 called and asked if we ever got the password from PW's. S-2 told him only for the day are captured. 411th S-2 said they would like to have the enemy password for tonight if we could get it out of a prisoner.

1020 - At 1015 Capt JONES delivered Regt'l O.I. No. 17 to Sgt WEATHERUP in G-3 operations.

1045 - Major GILLMAN of Movement Control called and said our overlay with O.I. No. 17 was off. Said our baundary was too far to the N and W and the left limiting point was off about 500 yards. It HUGHES told him he would check and call him back. (It HUGHES checked it and called Major GILLMAN back and told him he was correct.

1155 - TD Bn 00 called and said the Asst Div Comdr informed him that the TD position in vic of SCHILLERSDOFF was too far forward and he suggested a 57-mm be placed there and pull the TD back.

1200 - S-3 wants 00 of Co "B", 781st Tk Bn to come down to 2d Bn CP.

1300 - Asst S-3 called G-3 (Capt DALCHER) and told him we would like to have another platoon of tanks, preferably from Co "B" of 781st Tk Bn, attached to us for 24 hours. Capt DALCHER will back call us. Capt DALCHER said Corps had informed him we were going to get some new 4.5 rocket launcher, 60 tubes on each launcher. More information on this later.

1325 - Asst S-3 called G-3 (Capt DALCHER) and he said he hadn't been able to contact CO of Co "B" or CO of Tk Bn. Asst S-3 told him he had the Bn CO here now and if it would be back.

1330 - G-3 said it would be OK for us to use that platoon of tanks, but they want to know which platoon we use. Said Asst Div Comdr was probably on his way down to our CP.

1331 - S-2 called TD Bn and told them their patrol was off for tonight. (Informed G-2).

DATE: 2 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 1340A to 1620A

PIACE: INGWILLER, FRANCE (809304)

1340 - Asst S-3 called 2d Bn S-3 and informed him he would have a platoon of tanks attached. 2d Rn S-3 said the Co Comdr of the tanks was there, and Asst S-3 told him to tell the Co Comdr of the tanks that this attachment had been OK'd by Division and his Bn CO. The 1st Plat of tanks are attached to 2d Bn. (Informed G-3).

1345 - Asst Div Comdr visited our CP.

1350 - 3d Bn S-3 called and said the people on their left flank don't seem to think they are to cover the big draw. S-3 told him they were to stay on the left side of the draw and he would call lst Bn S-3 and tell him about it.

1400 - Asst Div Comdr left our CP.

1402 - S-6 called 2d Bn S-6 and told him Asst Div Comdr was on his way to 2d Bn CP. Also said Asst Div Comdr didn't approve of the plan of using the platoon of Co "G", and he had better drop that.

1420 - 2d Bn 00 called S-6 and said Asst Div Comdr had just left his CP. He wants us to attack with Co "F" in the morning. We are going to do that. I would like to use some TD's. S-6 told him he would be able to get possibly 2 or 3 TD guns.

1430 - S-3 to 1st Bn S-3: 1st Bn will occupy the little knob above the draw on their right boundary.

1450 - Cn Co Co says at gun positions he has 687 rds of HE; 67 rds of WP; and 58 rds of AT.

1510 - 1st Bn S-3 reports that the German plane shot down fell behind the enemy lines and that the pilot parachuted down behind enemy lines.

1515 - Our searchlights are Btry "C", 2d Plat, 353d AA Searchlight Bn.

1610 - G-3 called S-3 and wants us to give the 411th Inf all the help we can tomorrow on their attack.

1615 - 3d Bn, S-3 called S-3 and wanted to know if we still had TD's and if they were under Regt'l control. S-3 told him "YES". Wants an overlay of the TD positions.

1620 - G-2 called S-2 and told him that the divisions on both sides of us are having trouble with German Raiding Parties - about the same as we have been sending out. We should be on the alert for things like that.

1621 - S-3 called 1st Bn S-3 and wanted him to find out if there were any enemy entrenchments or enemy activity at coordinates (859339). That is the plain in front of Co "C".

Also told him of above message from G-2. (1st Bn S-3 says nothing has been seen there.)

DATE: 2 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 16254 to 23594

PLACE: INGWILLER, FRANCE (809304)

1625 - Artillery reports they are now firing on 3 tanks at (879316). Don't know what type tanks they are.

1632 - 3d Bn S-3 reports that one Plat of Co "I" plus their LMG's plus a section of HMG's plus their .50's will be used in the shift. That will give the Bn a Res Co.

1650 - On our next periodic report, Div wants our RRL and as it now exists with limiting points.

1655 - S-2 informed 2d & 3d Bns that the I & R Plat is going out tonight thru Co "K" to that mill S of town. Almost in front of Co "L" first positions. Wents to make a Rcn and see what they can do to set-up a future raid. They will be at Co "K" at 1830 and go out at 1930. Will be back at midmight. We haven't informed Co "K" as yet.

1740 - Sgt DRAUDEN informed Ens and Artillery that Cannon Co, 411th Inf will register into BITSCHHOLTZ tomorrow at 1100. Also that 45th Div on left are using flares, parachute and other tonight.

2125 - 3d Bn S-3 report that the relief of part of Co "B" on line completed at 2115. (G-3 and lst Bn informed).

2340 - Condition is Red.

2359 - Condition is All Clear.

DATE: 3 February 1945

ORGANIZATION: 410TH INFARTRY

TIME: 0020A to 0815A

PLACE: INGWILLER, FRANCE (209304)

0020 - Co "C" report hearing vehicular movement in ROTHBATH. Artillery fire being called for. (Called G-3 War Room)

0030 - 1st Bn (Sgt WIELAND) to S-3: Co "B" relieved elements of Co "C" at 2400. S-3 said that they should send up a complete fire plan as soon as they can. He also teld them to know the exact location of their left flank.

0031 - Blue line is out.

0100 - Informed G-3 of 0030 entry.

0200 - Gave G-3 a negative report.

0215 - 1st Bn reports that their Co "C" OP's have just captured 2 Krauts.

0500 - The prisoners Co "C" captured were from ROTHBACH. They were part of the 11th SS Regt and the last of them were to pull out at 1230 this morning. S-3 Jr informed 2d Bn and G-3.

0501 - Gave G-3 a negative report.

O530 - The prisoners of Co "C" said they had about 100 casualties while in ROTHBACH.

They also heard that all the SS outfits were being pulled out of the line. They then made a statement that they heard one of their NCO's say they were going back to pick up replacements, reorganize, then come back and attack.

0600 - 0700 - Gave G-3 a negative report.

0715 - 2d Bn S-3 informed us that the raid went off on time and they were getting very good support from the supporting units. (S-2 gave this to G-2 & G-3)

0720 - 2d Bn S-2 informed us that one (1) Plat was in the town and are receiving HMG fire from the church. On Co is going to fire on it again.

0735 - 2d Bn S-2 reports they have 6 prisoners.

0745 - 2d Bn S-2 called and said raiding party are pulling out of the NW part of town and are getting a lot of SA and HMG fire. Tanks are up there firing now. We received some 88 fire.

0802 - 2d Bn S-2 said Co "F" is on its way back. They suffered several casualties. They said they saw vehicular movement on OFFWILLER - BISCHHOLTZ Rd.

0815 - Lt RITTMAN (IPW) informed S-2 that the 6 prisoners are from the 36th Volks Grenadier Division.

DATE: 3 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0825A to 1100A

PLACE: INGWILLER, FRANCE (209304)

0825 - C/S called S-5 and asked if we had a P/A system for the General to use in a talk this morning. S-5 told him we didn't have one, but we might be able to get hold of one.

0525 - 409th S-3 called S-3 and said the right plateon of our right flank was coming out of their holes and putting their packs on and taking off. S-3 told him we would check up on it.

0830 - Asst Div Comdr called S-6 and S-6 told him our Co "F" raid was over and we had 6 prisoners. Had 2 casualties that we know of.

0831 - 2d Bn reports that they have 6 prisoners, 1 NCO and 5 Pvts. They are from 6th Co., 87th Regt, 36th Volks Grenadier Div. At midnight last night they relieved the SS outfit in BISCHHOLTZ. We suffered 4 casualties, 3 walking and 1 litter.

0840 - 3d Bn S-3 called S-2 and asked him how the Co "F" raid came off. S-3 asked 3d Bn S-3 what the movement was on his right flank by his right Plat. He said they were relieving a squad at a time over there so they could dry out.

0905 - Asst Div Comdr wants the final report on the Co "F" raid as he has to go to Corps this morning. S-2 told him we didn't have a complete report as yet.

0907 - 2d Bn reports that Co "F" lost 1 killed and 4 wounded in the raid last night. Most of them were hit by our own fire. One man was wounded by a grenade that was thrown at a window but hit the wall and bounced back. One man from Regt AT Co was wounded by our own or enemy mortar fire. They didn't throw too much at us. At first we thought they were 88's, but I think they were heavy mortar. Threw quite a lot of stuff at our OP. We killed about 15 enemy troops. We heard them trying to take some vehicles out, so we directed tank fire and 155-mm fire on them, but didn't see the results. 2d Bn was informed that Co "F" will not stand the parade today but will be prepared to assemble in the street in case the Div Comdr wants to talk to them. Must be prepared to dig on the ERL this evening.

0920 - Further reports on Co "F" raid. Got into the town without any trouble. Casualties: 1 killed, 2 walking wounded, and 2 litter cases. We got 6 prisoners from the 2d Bn, 87th Regt, 36th Volks Grenadier Div. This outfit is over at NIEFFERN so they must have moved one company to BISCHHOLTZ. They relieved the 6th SS last at midnight. The two deserters who walked into Co "C" positions last night were SS men. Said their Bn had been cut from 200 to 100 men.

1015 - Div Comdr arrived at our CP.

1025 - Div Comdr & S-5, 410th left op for Co "F" op.

1100 - G-3 called and informed us that from 1100 to 1200, Ron Troop are firing bazooka's at (826259). From 1330 to 1630, 3d Bn 411th are firing SA's at (788276). Bns, AT, Cn, Arty, Lt MIHALAKIS informed).

DATE: 3 February 1945

TIME: 1145A to 1645A

ORGANIZATION: WHOTH INDANTRY
PLACE: INGWILLER, FRANCE (809304)

1145 - Asst 6-2 (Capt DREXEL) called S-2 and asked if the PW's we captured indicated that their company occupied RISCHHOLTZ. S-2 told him yes, that it was the 6th Co., and they had a total strength of 36 men before we attack them.

1245 - Munitions Officer called and informed us that they have 900 rds of 81-mm HE 11 int

1315 - 00 3d Bn called S-6 and told him he just got 2 more PW's from 3d Co., 165th Regt. 36th Div. They were on guard in MUHLHAUSEN and decided to walk into our lines and give up. They say the 1st, 2d, 3d, and 4th Co's are in MUHLHAUSEN, but don't know when the 5th Co had moved or where they are. The strength in MUHLHAUSEN is approximately 80 men. Most of the men there are previously wounded and considered 4-F. 3d Bn CO said he would like a P/A system if possible and also he was going to throw some leaflets into the town.

1320 - S-6 called G-2 and informed him of above entry and requested permission to use P/A system. G-2 said the Div Comdr doesn't like to use P/A's but G-2 would check and see if he would OK the use of it in the particular case. P/A system would have to be from Army.

1328 - S-6 informed CO 3d Bn of above entry.

1420 - Called 1st, 2d, & 3d Bns and informed them that 411th Cn Co would register in on the town of BISCHHOLTZ between 1500 and 1600 this afternoon.

1430 - AT Co Co called and wanted to know when we could release his Mine Plateon back to him. S-3 told him we would check with the 1st Bn and let him know. Also wented to know who fired the artillery that injured his men this morning.

1450 - Asst Div Comdr visited our CP. Talked about our Co "F" raid on BISCHHOLTZ. Said to tell S-6 he was very pleased with the raid.

1640 - Div Air Ln Officer called and said there was a B-24 in trouble between boundary of 45th Div and 103d Div. 5 men have bailed out and Div Air Ln O wants us to call them if we contact any of these men.

1645 - IPW Officer reports the two PW's who walked into our 3d Bn area are from the 3d Bo, 1st Bn, 167th Regt. The complete Bn is in MUHLHAUSEN. Bn strength between 90 and 100; Co strength 18 men. Den't know how many companies are left in the Bn. Relieved the SS troops on the 30th Jan, originally came from UHRWILLER. Gave positions of 2-75-mm AT guns; 1 MG; and their company CP. Said their company occupied the 3 houses leading into town; each house having about 7 men. First house on right have a squad and one officer and one NCO. 2d house is Co CP. House on the left off by itself has a squad and at night is used for a kitchen. 20 men in there between 1900 and 2000. They send troops up to the mill between NIEFFERN and MUHLHAUSEN to scout. That was their mission, but they kept right on walking into our lines. They said if we would shoot a

1645 - (Continued) - few leaflets over saying we would not harm them all the enemy troops would come over. Says most of them are old men and very tired of the war.

1650 - 3d Bg CO called S-3 Jr and told him that he was shifting his troops tonight. When shift is made, Co "L" will be on the right, Co "K" on the left; and Co "I" intact in Reserve. All of Co "L" on line but only two (2) plats of Co "K" on line. Making a slight change in MLR to try to save a little distance. Change will be in about the center of MLR. Am consolidating my positions on far left flank. Will have one plateon of Co "K" on my left flank covering the big draw. 2d Plat of "L" is the change in the MLR. We are going to try to nip off that Kraut patrol that comes up to the mill between NIEFFERN and MUHLHAUSEN tonight.

1720 S-6 called S-2 and told him to cancel the I & R patrol for tonight as 383d FA Bn had been firing at personnel targets in that area all afternoon and they would run into trouble. S-6 said he would not be here for dinner, but will be here at 1800 and leave a few minutes later.

1730 - S-3 Jr called A.T. Co OO and informed him that Mine Plat has been relieved from attachment to 1st Bn and reverts to A.T. Co.

2115 - 409th report Burp gun fire to left rear of their left Bn. Co "B", 410th report SA and Burp Gun fire to their left flank out forward.

2145 - Co "L" OP report one enemy deserter on way to 3d Bn CP.

2200 - 409th Inf report hearing more SA fire in MUHLHAUSEN.

2222 - 411th Inf raiding company have taken first 4 houses in ROTHBACH. 10 PW's captured. Krauts using red and white flares.

2250 - CO 3d Bn called S-2 and told him PW taken by Co "L" report the following:
He is from 13th Co., 12th Regt, 6th Mountain SS Div. Said there is 200-300 men in
UHRWILLER. Composed of Luftwaffer men, attached to 6th Mountain Div. As to SS En
that attack SCHILLERSDORF, there are 60 left in Bn of 350 strength. His outfit digging
in back of UHRWILLER. Says the 11th Regt on left and the 12th Regt on right of UHRWILLER.

2350 - Lt RITTMAN (IPW) reports PW from Co "L" is from 13th Co., 12th Regt, 6th Mountain Div. Whole Bn has about 50 men left. Company strength is 12 to 15 men. Dug in on high ground N of UHRWILLER. Bn moved to ZINSWILLER.

0020 - Lt RITTMAN (IPW) reports that a prisoner they have says his 00 is Sgt METZ. We had that Sgt pass through our IPW channels about a week ago. He says he is with the

0025 - S-2 received a report that 411th Co's A & B passed Phase Line 5, and Co C has passed Phase Line 2. Arty being fired on possible reinforcements coming from OFFWILLER.

They have killed 15 Krauts and took 5 prisoners.

0100 - Gave G-3 a negative report.

0120 - Capt BUTLER reports 411th Co "A" has reached their objective and have sealed off the road from the E so no one can get through.

0200 - 1st Bn reports they are receiving some 88 fire from (866343) in B & C Co sectors. They have 383d FA firing on it. 3d Bn reports all quiet. This information given to G-3.

0300 - Negative report given to G-3.

0400 - 1st Bn reports they believe they hear 3 or 4 tanks coming into HOTHEACH. 3d Bn reports all quiet. Given to G-3.

0402 - 411th S-3 said they cleaned out all the Krauts in ROTHBACH.

0500 & 0600 - Negative reports given to G-3.

0650 - 411th report that they took 24 prisoners last night from the 51st Luftwaffe Bn.

0700 - Negative report given to Lt YOUNG at G-3. He informed us that it was generally quiet along the whole front.

0820 - lst Bn reports that at 0300 this merning practically all 411th troops were out of ROTHBACH. They received some SP fire and we fired on them with a artillery concentration. Our OP reports they have seen very little sign of life in ROTHBACH this merning, but they think there are still enemy troops there.

0825 - 3d Bn 00 told S-2 that his patrol down to the mill between NIEFFERN and ROTHBACH didn't do any good. They were fired on.

0845 - S-3 instructed S-2 to alert all Bn OP's to be on the lookout to see if enemy troops will try to reinforce ROTHBACH and BISCHHOLTZ.

0846 - 3d Bn 00 told S-2 that there were Krauts still in BISCHHOLTZ or the civilians were very active with Burp guns. 3d Bn 00 said he was of the opinion that the Germans would try to hold all the towns on the front.

PLACE: INGWILLER, FRANCE (809304)

0850 - Division Air Ln O called and said we now have a bombing mission on OFFWILLER.
It was a hurry up job as they had a flight of bombers up who could not reach their
objective as they were running short of gas. Div Air Ln O wanted us to get our OP's
to observe it. (Called our 1st Bn S-2 and he is going to get "C" Co OP to observe it.)

0852 - G-2 called and said we had a bombing mission on OFFWILLER.

0925 - Msg from CG, 103d Inf Div (THOMAS, Maj) signed 040850 Feb 45: "1. Prepare plan employing Co "A", 410th Inf (Reinf) to raid BISCHHOLTZ (Q8532). Plan will include recommendations for reinforcements and for H hour. D day will be announced by this HQ. Submit plan to this HQ by 051200 Feb 45."

0930 - 409th Inf took no prisoners in their KINDWILLER last night.

0945 - 1st Bn OP's could see only some smoke and fires in OFFWILLER due to visibility.

0950 - S-5 called 1st, 2d, & 3d Bns, Cn, AT and instructed them to store their headnets and to keep their areas clean of garbage.

1030 - C/S arrived at our CP.

1045 - Received overlay from 36th Engr (C) Regt showing their patrols.

1050 - C/S left our CP.

1150 - 1st Bn reports that a good part of the town of OFFWILLER is afire. BISCHHOLTZ was not bombed.

1315 - Our MP officer reports that the firing we hear to our S is a TD outfit and he is going to check on it.

1330 - G-3 called and wants S-6 to report to the Division War Room as soon as possible. There will be a meeting of all Regt'l CO's there. (S-6 left for Division).

1345 - S-5 told 2d Bn S-3 that the Div Comdr wanted a narrative written up for publicity and for record on the Co "F" raid of BISCHHOLTZ.

1350 - S-5 told 3d Bn 00 that we would like for him to fire on MUHLHAUSEN and try to spot enemy guns in there. 3d Bn 00 said it would spoil his plans, but that he will do it.

1400 - S-5 called 2d Bn 00 and told him that 3d Bn had a couple of patrols planned and didn't want to make much noise around MUHLHAUSEN. 2d Bn 00 said it would be 0K if they didn't make too much noise there just so they could get some information on gun positions. S-2 called 3d Bn 00 and told him to go ahead with his patrols.

DATE: 4 February 1945

ORGANIZATION: 410TH INFANTHY

TIME: 1445A to 2350A

PLACE: INGWILLER, FRANCE (809304)

1445 - 1st Bn S-3 called S-2 and told him that Kraut artillery has been landing in ROTHBACH. About 20 rounds have landed so far today. (G-2 informed).

1645 - Enemy troops moving from OFFWILLER to ROTHBACH. Mortar were put on them and several were killed. Trying to get artillery on them now.

1730 - At 1643, Co "C" saw a column of 40 men moving into ROTHRACH from OFFWILLER. They had on blue uniforms. They were carrying one bazocka and what looked like 2 MG's. Mortars were placed on them and some casualties were inflicted. Some mortars hit right in among them. Artillery line was out at the time so no artillery was placed on them.

1743 - C/S called S-3 and wanted to know why our Heavy Weapons Co was absent from the inspection yesterday merning. S-3 told him the Heavy Weapons Co was there - the only company absent was Co "F" who had just returned from a raid.

1745 - 3d Bn S-2 called S-2 and wanted to know if 103d Rcn Troop was going to do any patrolling in their area, or would they do it themselves. S-2 told him they would do it themselves as he had talked to G-2, and they informed him that the 103d Rcn Troop definitely would not be there.

1843 - Div Ln brought in OI #60.

2030 - 1st Rn S-3 called S-3 and informed him that reinforcements had arrived at ROTHDACH.
Would like to have artificial moonlight. Let him know as soon as we can get it turned
on.

2230 - S-3 called 1st & 3d Bns S-3's and asked them to check on the gap between Co's "B" and "K". If no physical contact, S-3 ordered the 3d Bn to send a contact patrol over.

2300 - 3d Bn S-3 called S-3 and informed him Co "K" still has the nose and contact patrols between Co's "B" and "K" will go during the night.

2350 - G-2 report that the 614th TD patrol vic BISCHHOLTZ have captured 6 PW's and killed about 8.

DATE: 5 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0015A to 0220A

PLACE: INGWILLER, FRANCE (809304)

0105 - G-2 informed us that they got 6 PW's from the TD raid. One of the prisoners said they planned to attack Hill 235 (853318) and clean it out. They had bezoekas.

0108 - Asst S-3 called 3d Bn 00 and informed him that the TD patrol raided the mill between BISCHHOLTZ and MUHLHAUSEN and obtained information given in 0105 entry.

0110 - Aust S-3 to 1st Bn: Told him to pass on their Co's "A" and "B" the 0108 entry.

0120 - It RITTMAN (IPW) said the prisoner he questioned was from the lst Plat, 4th Co, 51st CAF Inf Bn. He was 40 years old but still the youngest in the cutfit. His Plat consisted of 36 men who were formerly with an Air Corps Ground crew cutfit. They were attached to the SS about 3 weeks ago and were apparently left behind when the SS pulled out. He was on guard when the attack came. The prisoner knew nothing of the proposed attack on Hill 235. His platoon had 4 MG's which were taken off planes. They are similar to the .31 cal ING. He had been at the mill 4 days.

0130 - 3d Bn S-3 wanted to know if all the TD men were cleared out as they may want to throw some artillery where they were. Asst S-3 said they were all out.

0135 - 3d Bn S-3 said they might want to use artificial meenlight at about 0215.

0137 - Asst S-3 informed 36th Engr that we intended to use artificial moonlight at about 0215.

0140 - Asst S-3 informed Lt YOUNG at G-3 that we intended to use artificial meenlight at 0215.

0145 - G-2 informed Asst S-3 that the prisoner who spoke of raid on Hill 235 learned same from a friend in the 6th Co, 87th Bn in BISCHHOLTZ. Passed this on to 3d Bn CO.

0209 - 3d Bn 00 said he wanted artificial moonlight on at 0215. (Asst S-3 informed 409th Inf and 1st Bn).

0210 - Asst S-3 called AA Btry and informed them to turn on the lights at 0215.

0220 - Div IPW Officer (Lt HYDE) reports that the prisoners are from 4th Co, 51 AAF
Bn, 1st Plateon. TD patrol captured 6, killed 2 and wounded one. All of them were
in the mill. The rest of the plateon is in BISCHHOLTZ attached to 6th Co, 87th VolksGrenadier Regt. There is a Bn CP in BISCHHOLTZ at (8574-3258), E sade of read. As
you go into town just before you come to crossreads you hit a grass plot - the first
house to the right of that has one sentry, and 2d house on left has one sentry. Co
CP is either in the 5th or 6th house on right. Also have one sentry at the cemetery.
Elements of the 6th Co were to raid this hill (235).

0300 - 3d Bn CO said lights were OK now.

0314 - Asst S-3 told artificial moonlight people that the lights were OK new.

0315 - Gave G-3 a negative report.

0400 - Checked with 1st Bn and they turned in a negative report. Gave G-3 a negative

0420 - 3d Bn 00 to Asst S-3: Said they picked up two (2) Krauts trying to infiltrate through their lines. There are 12 more Krauts trying to get thru but they are under observation.

0427 - Asst S-3 called 1st Bn S-3 and informed him of the information the Krant prisoner gave us about a proposed attack on Hill 235. Then informed him of 0420 entry.

0440 - Asst S-3 informed Lt YOUNG at C-3 of 0420 entry.

0442 - Asst S-3 informed AA Btry to turn out the third light.

0520 - Asst S-3 called 3d Bn CO and informed him that two (2) PW's say the Krauts are going to attack tonight. They are coming from OFFWILLER thru HOTHBACH. It is to be made by those SS troops that were relieved a couple nights ago.

0523 - Gave above information to 1st Bn S-2.

0527 - Gave information in 0520 entry to Lt YOUNG at G-3.

0615 - 3d Bn 00 said Co "K" had lost view of the 12 other Krauts. It RITTMAN had finished questioning the two prisoners and was on his way back to our CP.

0655 - Asst S-3 to Sgt WIELAND (1st Bn): The two (2) prisoners taken by Co "K" were actually deserters. The attack on Hill 235 did not materialize. Those 12 other Kreuts got away but Co "K" is still looking for them. The attack thru ROTHBACH by SS troops has failed to materialize. 2 PW's were from 4th Co., 51st ACB.

0700 - Turned in a negative report to G-3.

0705 - It RITTMAN learned further from the two prisoners that there are now 70 Krauts in BISCHHOLTZ.

0930 - S-3 gave Lt NORDHAUSEN permission to draw 150 rounds.

1030 - 103d Rcn Troop will fire small arms at (826259) beginning at 1300. (Notified MP officer, 1st, 2d, 3d Bns, Cn Co, AT Co, 383d F.A. Bn)

DaTE: 5 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 1100A to 1415A

PLACE: INGWILLER, FRANCE (809304)

1100 - S-6 ordered 2d Bn to furnish one Plat of Co "F" to 1st Bn.

1130 - Message to CG, 103d Inf Div - Attn: G-3 - "Recommend following as exact tie-in points with 409th on right (per Par 6 Div O.I. #60):

MLR - (876288) Trail Junction. RRL - (861273) RJ north OBERMODERN (Signed: McCARTHY, Capt - 1130)

1145 - 2d Bn 00 called S-3 and asked if he could come down. 2d Bn 00 said 5 of his men had just returned from Rcn around MUHLHAUSEN in concern with what S-6 told him this merning. These 5 men told 2d Bn 00 that the left flank of the 3d Bn is not being occupied. Hill 235 can be walked up by the enemy and there is nothing there to stop them. (Lt HUGHES went down to 2d Bn to interview these 5 men).

1200 - Cannon Co report they have one gun position: 693 rds HE; 139 rds White Phosphorous; No rds Armor Piercing; At Serv Co = 515 rds HE; 246 rds White Phosphorous; 200 rds Armor Piercing.

1245 - S-3 called G-3 and found out that the Div Comdr wants our Res Bn in MENCHHOFFEN.

1247 - S-3 called 2d Bn S-3 and informed him his Bn would most likely have to move to MENCHHOFFEN. Might have to move this afternoon.

1330 - S-3 instructed 1st Bn S-3 to send 2d Bn copies of their C/atk plans.

1340 - G-2 called S-3 and wanted to know if we were going to let the Kraut we captured go back into the town and try to get his buddies to surrender. S-2 told G-2 the prisoner didn't want to do that. He wanted to take a few men and surround the town and then he would yell at them in German to surrender as they were surrounded. This PW is definitely Anti-Nazi and says his unit will not fight if they know they are surrounded. S-2 told G-2 we had easier methods of getting Krauts than that one.

1355 - S-6 instructed 1st Bn S-3 and 3d Bn S-6 to keep their troops on the alert as the visibility is bad. 3d Bn S-6 said he would like to have people who come down into his area coordinate with his HQ. S-6 ordered 3d Bn S-6 to have 50% of his troops on line and 100% at night. (3d Bn has been keeping 1/3 strength on line during day and 100% during darkness). 3d Bn CO said his men had been on line 33 days and they had to get some rest. Have to pull them in as many at a time as possible to dry them out or he wouldn't have any men left at all.

1400 - S-6 instructed Munitions Officer to give 1st Bn. 150 rounds of 81-mm HE light.

1410 - 1st Bn Ln O just delivered C/atk plans of 1st Bn to 2d Bn.

1415 - S-6 called 1st Bn S-3 that we had a Ln O from a TD outfit attached to the 45th Div in our OP new. This Ln O reports that they have 2 new TD's with 90-mm guns on them

DATE: 5 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 1415A to 1550A

PLACE: INGWILLER, FRANCE (809304)

1415 (Cont'd.) - and they can't locate any targets in the 45th Div area. They want to come ever into our 1st Bn area and do some firing on OFFWILLER. 1st Bn S-3 said he would be glad to go up and show them some excellent positions. Said they could get

1425 - 1st Bn S-3 called S-6 and said the CO of Co "B", 781st Tk Bn feels sure we can get another plateen of tanks from his company if we get an OK from Div. S-3 said they wanted to use this plateen on the Co "A" raid to fire on any SP's or strong points they might hit and also cover the withdrawal. S-6 told him we already had a plateen with our 2d Bn that this can handle, but S-3 1st Bn said 781st Tk Bn wants to give another plateen that have had a little more experience.

1430 - S-6 instructed On Co Comer to go to 1st Bn CP and talk over plans for the Co "A" raid.

1431 - S-6 talked to CO, Co "B", 781st Tk Bn and found out that the Tk Co CO wants us to contact Division and get another plateon to use on the raid as his 2d plateon has had all the work and the rest have had none and the 2d plat is well tied in with our 2d En.

1440 - S-3 called S-6 from Division and S-6 instructed him to ask G-3 for an additional plateon of tanks to use on the Co "A" raid.

1450 - 3d Bn Opns Sgt reports: "Just got a report from our OP that visibility is about 1,000 yards. 409th mortars firing on NIEFFERN."

1457 - G-2 told S-2 he new had shells with surrender passes ready to fire on OFFWILLER, MINFFERN, ROTHBACH, BISCHHOLTZ, AND MUHLHAUSEN. S-2 told him the two (2) deserters who turned themselves into Co "K" at 0900 this morning were from the 1st Co of the 165th Regt. There are now 4 companies in MUHLHAUSEN; about 200 men. The 4th Co moved in. The Bn CP is there too. Don't believe they could get a thing out if we hit them during daylight and cut them off from the rear; don't believe they would try too hard. The two (2) PW's say the people in there are pretty well scared and head for the cellars when anything hits in the town.

1510 - C/S arrived at our CP.

1540 - C/S left our CP.

1545 - 2d Bn S-5 report that MENCHHOFFEN is full of troops and they could squeeze only two companies in there. S-6 told them to check on UTTWILLER.

1550 - S-3 called (from G-3 War Room) S-6 and said our Res En would have to move, but it would be OK to move tomorrow. Division knows that we cannot get the complete En in MENCHHOFFEN and that we will have to put the Heavy Weapons Company and one Rifle Co in UTTWILLER.

DATE: 5 February 1945

ORGANIZATION: 410TH INFANTEY

TIME: 1552A to 2220A

PLACE: INGWILLER, FRANCE (809304)

1552 - S-6 called 2d Bn S-5 and told him the Bn would have to move, but that they could move temorrow. Two companies in MENCHHOFFEN and two companies in UTTWILLER.

1555 - 3d Bn © called S-6 and said he was going to leave that plateen in position until he got an OK from S-6 as the plateen was due to be relieved tonight and he doesn't want to change them as long as there was any question of the position.

1605 - S-6 told Cn Co Comdr he should keep some HE AT rounds on hand in case he should have to use them against tank that might break through.

1615 - 2d Bn S-5 called S-6 and told him UTTWILLER was completely filled and they couldn't get any troop billets there at all. S-6 told him to hold up until morning and we would get in touch with C/S and see what could be done.

1820 - 00 3d Bn called S-3 Jr and informed him relief will most likely start at 1830.

1825 - 3d Bn new OP opened at OBERMODERN (8515-2770).

1925 - Elements of Co "B" relieved left Plat of Co "K".

1930 - 3d Bn CO assumed command of sector.

2030 - G-3 informed of 1930 entry. G-3 said Div Comdr approved our Co "A" raid plan.

2220 - Division Liaison Officer brought in Div O. I. #61.

DATE: 6 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0100A to 0830A

PLACE: INGWILLER, FRANCE (809304)

0100 - Gave G-3 a negative report.

0127 - 409th called and said they were going to turn on their artificial mosnlight. We said OK because it wouldn't affect our patrols who were operating in our left sector.

0200 - Gave G-3 a negative report.

0245 - 1st Bn called and said both of their patrols were in and it was alright to turn on the artificial mosnlight. The time to be turned on was 0300. We informed our 3d Bn, 36th Engrs, G-3 of same.

0252 - Informed AA Btry to turn on lights at 0300.

0300 - Gave G-3 a negative report.

0400 - The I & R Plateon checked in. Lt 0'REGAN said they got as far as vic (865308) where the Krauts tried to cut them off. They then started to return. On their way out, they contacted a Co "C" OP about 25 yards SE out of SCHILLERSDORF. Lt 0'REGAN said he couldn't understand why our Co "C" would have an outpost there.

0405 - 1st & 3d Bn turned in negative reports. Gave G-3 a negative report.

0500 - 0600 - 0700 - Negative reports given to G-3.

0717 - AA Btry called and said they are going to turn off artificial moonlight.

0745 - 1st Bn reports that one of their outposts heard a tank moving around in ROTHBACH about 0600 this morning. Arty was placed on it but they don't know if they got it or not. Co C heard some rifle fire coming from the 45th Div zone.

0752 - Sgt WIELAND (1st Bn) says that the patrols Co "A" sent out last night were able to verify the positions we learned of from the PW's captured the other night. The patrol also found out further disposition of the enemy and their positions.

0825 - G-2 (Capt DIXON) called S-2 and asked for patrol reports. S-2 reported that
Patrol No. 1 (1st Bn patrol to the farm N of ROTHBACH) gave a negative report. Patrols
2 & 3 (Co "A" patrols to the outskirts of BISCHHOLTZ) went out to see if they could
verify some MG positions given to us by PW's. They came in late. They obtained quite
a bit of information and will send us an overlay later. They didn't run into any
patrols. I & R Plateon got mixed up with some Krauts and the Krauts tried to cut them
off. Don't have a full report from them as yet. They went up to the mill S of MUHLHAUSEN.

0830 - S-6 called 1st Bn S-3 and told him they couldn't have anymere 81-mm light.
Couldn't get any yesterday and there is some doubt when we will get anymere. Cannon

DATE: 6 February 1945

TIME: 0830A to 1000A

PLACE: INGWILLER, FRANCE (809304)

0830 (Cont'd.) - has lossened up. S-6 instructed lst Bn S-3 to try to use Cannon instead of morter on the Co "A" raid. lst Bn S-3 said he had at least one morter mission he could give to Cn Co. S-6 said he would be down to lst Bn this afterneen to look ever the final plans for the Co "A" raid.

ogho - G-3 called S-6 and said 409th had complained that our artificial meen had ruined one of their patrels. G-3 wants us to notify him 45 minutes before we turn on our moonlight. S-6 told G-3 if we moved our Res Bn to MENCHHOFFEN we would have to put them in hay-lefts as there was no room there. G-3 said Div Comdr wanted them moved there. G-3 said he would try and get some of the Armored Arty moved out of the town. S-6 told G-3 that he would check the final plans for Co "A" raid this afternoon.

0845 - S-3 instructed 2d Bn S-2 to move his Bn to MENCHHOFFEN this morning.

0846 - Received Minefield Records No. 108 and 109 from 328th Engr.

0855 - S-3 told 2d En 00 that no one would be moving out of the town of MENCHHOFFEN.

0900 - Received G-3 Periodic Report and Engr Minefield Overlay #12.

0901 - MP Officer asked S-3 if he could use the Mine Plateon for perimeter defense of INGWILLER, S-3 gave him permission.

0902 - S-3 instructed AT Co Comer to let our MP Officer use the Mine Plateon for use of perimeter defense of INGWILLER.

0910 - 3d Bn S-3 wants to know how many men he can send to the flamethrower school. S-3 said he would call him back and let him know.

0915 - 411th S-2 called S-2 and told him that their OP had reported 81-mm mertars landed at (845321). About 9 shells - started at 0900 and one came in every 3 minutes.

0930 - Asst Div Comdr visited our CP.

0945 - G-3 (Et EDDENS) reports that 103d Rcn Treep will fire small arms at (826259) at 1330. (Called MP Officer, 1st, 2d, & 3d Bns, AT & Cn).

0955 - 2d Bn CO called S-6 and said he had 10% to 15% of his men in the rifle companies who had developed frost bite since they came out of the lines. They need 72 hours of treatment on them or they will have to be evacuated. 2d Bn CO wants to leave these men in INGWILLER with the Heavy Weapons Co. to feed them and motorize them. S-6 asked Asst Div Comdr if this would be OK, but he refused to make a decision. S-6 told 2d Bn CO to go ahead with his movement to MENCHHOFFEN and we will contact Div and try to get a decision from them.

1000 - S-6 called 1st Bn S-3 and told him to try to work these two TD's with the 90-mm

1000 (Cent'd.) - guns in on the Co "A" raid.

1015 - Asst Div Comdr left our OP.

1016 - S-5 called C/S and asked him if we could leave our men with frestbite in this town and explained the situation. Regt'l Surgeon explained to C/S what was wrong with the men. C/S said he thought it would be OK, but he would talk to the Div Comdr.

1100 - S-6 instructed S-5 to ask 411th Inf if they could move their Res up to MENCHOFFER temerrow so our Res Bn could go back and take ever this billets.

ll15 - 1st Bn says Co "C" reports they have some Krauts in fex holes in front of them who are using our air identification panels. In the morning, they turn the white side up and in the afternoon they use the red side. S-3 instructed them to use their left forward 57-mm gun with HE and blow them out of their holes.

1130 - 1st Bn S-3 called S-3 and said the Asst Div Comâr had said they could use two towed TD's on their Co "A" raid. They will be used to protect the tanks from SP fire. S-3 told him we would contact the TD's and find out if we could get a couple of guns. (Lt HUGHES called Lt EDDENS at G-3. He had contacted the TD CO and found out that all their guns are in position, but they will see if they can get a couple of guns for us.)

1155 - Received overlay of AT and TD gun positions from 409th Inf - New AF Code and Change in SOI.

1200 - 2d Bn frostbite cases: Co "E" - 9; Co "F" - 2; Co "G" - 17; Co "H" - 9; Hq - 2 or 3 cases not completely cured. Total - 37 cases.

1245 - 2d Bn closed old CP at 1215 in INGWILLER; opened new CP in MENCHHOFFEN at 1216.

1320 - Asst Div Comdr to S-6: "The appearance of the men, carrying of weapons, no bunching in chew lines, no bunching of vehicles had improved considerably. However, today I saw 7 Service Company vehicles bumper to bumper. You should keep guarding against that."

1325 - S-6 informed Lt RIGDON of the above entry. Lt RIGDON said he would bring it to the attention of all his drivers.

1330 - S-6 informed 2d Bn S-5 of 1320 entry, since the trucks in mention were these that were to pick up his Battalion's kitchens. 2d Bn S-5 said he would take care of it.

1500 - 00 411th Inf visited CP. Left for 1st Bn CP to see S-6.

1935 - S-3 called S-2, 2d Bn and informed him to have one Co motorized at 0600 temorrow and have Co Comdr report to 1st Bn CP at 0600. He was informed that Co "G" will furnish Plat for Div CP security. Co "E" will be used as motorized Co in accordance with Regt'l 0. I. #19.

DATE: 6 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 2150A to 2400A

PLACE: INGWILLER, FRANCE (809304)

2150 - Cn Ce Cemdr reports that shells are falling on our Ce "C" positions and one man has been hurt. S-3 teld him we would have our Arty Ln O check with Div Arty on it. Cn Ce Comdr says he thinks it may be the 500th FA who is firing close to him.

2200 - S-3 called 1st Bn S-2 and they knew nothing of our Arty falling on Co "O" positions. They are going to check.

2203 - 383d Arty Ln O reports that all Div Arty is firing interdiction fire on MUHLHAUSEN and vicinity. That is the closest firing to Co "C".

2213 - On Co Comer reports that Arty is not falling in Co "C" area; it is Co "B" area. Says someone may be trying to fire into BISCHHOLTZ and it is falling 200 or 300 yards short.

2220 - Sgt GROOMS (3d Bn Opns Sgt) reports that one round of time fire just burst ever the town of SCHILLERSDORF. Burst about 100 feet in the air and he thinks it is our artillery fire.

2225 - 1st Bn S-2 called S-3 and said Co "C" was receiving no artillery fire. S-3 told him we had just received a report that it was Co "B" and not Co "C" receiving the Arty.

2242 - 1st Bn S-2 reports that the man who was hit by Arty fragment was from Co "F" Plateon.

2355 - Co "B" Comdr called S-3 and reports they made contact with a Kraut patrol and think perhaps the patrol has penetrated our lines. Fired illuminating shells right after contact with the patrol and they were no where to be found. Said he wanted to coordinate with us on artificial moonlight as Co "F" was laying around there. S-3 told him to get patrols working behind our lines as well as laterally and we would have the artificial moonlight on in about 45 minutes.

2356 - S-3 called G-3 (Lt EDDENS) and told him we would like to turn on our artificial moonlight at 0045 and leave it on until 0700. Lt EDDENS said he would notify everyone.

2400 - Called our AA SL Plateon and instructed them to turn on our artificial moonlight and leave it on until 0700.

0005 - Told 3d Bn (Sgt GROOMS) that our artificial moonlight would go on at 0045 and be on until 0700; also of possibility of enemy patrol penetrating our Co "B" lines. Sgt GROOMS said Co "I" had a wire party out, but he would call them and tell them to call it off. Told 1st Bn (Opl SMITH) that our artificial moonlight would go on at 0045 and off at 0700. He said he would notify the companies of his Bn.

0010 - G-3 (Lt EDDENS) called S-3 and said he had notified everyone of our artificial moonlight. lolst Div was worried about it as they had patrols across the river; but their lines are 6 kilometers from ours and Lt EDDENS said it wouldn't bother them a bit.

0100 - Submitted a negative report to G-3 (Sgt LOWRY).

0135 - Co "B" Comdr reports that the enemy patrol that was reported as having possibly penetrated our lines did not get through. They were reported as seen running back toward their own lines.

0200 - 0700 - Submitted negative reports to G-3 on the hour.

0712 - 1st Bn CP (Capt VINSON) called that they had just received report that preparations went right into town, that Co "A" is now in town and moving very fast toward the center. Co "A" is receiving very little small arms fire. It is using a lot of hand grenades to clear out buildings. No report yet on whether it has taken any prisoners.

0725 - Red OP (1st Bn) reports that they just had word from "F" Plat CP down at "B" CP that one of our men came in down there with a prisoner. Our man was wounded. There is still lots of small arms firing in the town.

0732 - 1st Bn S-2 says they will shoot all PW's right up to our cage.

0740 - S-2 told G-2 that we sent out Patrols #1 and #2 to develop information for the raid this morning. Don't have a full report on them. On our raid up to this point we have one PW.

0755 - 1st Bn S-2 called S-2 and said Capt PARKER had just called in and Co "A" is out of the town. Said they had approximately 12 PW's. Know of one of our men who is wounded.

0810 - G-2 reports that 103d Rcn Troop ran into a minefield last night. The artificial moonlight came on and they discovered they were right in the middle of the minefield. They were lying right on top of the ground. They killed 6 Krauts.

0830 - 1st Bn S-3 reports Co "A" has 10 and possibly 11 prisoners. Had one man wounded in the hand and one creased under the arm. Awaiting more complete report from CO Co "A".

ogo5 - 1st Bn S-3 to S-6: It is 11 prisoners. Our total casualties, one evacuated - gun shot wound of hand, 2 not evacuated slight lacerations. The Krauts reacted with some morter fire and fire apparently from two (2) pieces of artillery. The morale of Co "A" very high, as they passed me at the OP they were laughing and joking and generally seemed in high spirits.

0910 - Div Comdr visited OP.

0915 - Div Comdr left CP for 1st Bn CP.

1125 - On Co CO called S-6 and said he would have to make his relief tonight so he won't be able to close into any area until after dark. Also that his area in BOUXWILLER is very poor and would like permission to go to another town. S-6 said he should move to BOUXWILLER and then change locations tomorrow.

1128 - S-6 from C/S: You did a nice job at BISCHHOLTZ. You still have trash in your area. S-6 told him he had S-5 working on it. S-6 asked him if it was OK to have Cn Co in another town, C/S said he didn't see why not.

1315 - S-3 called AT Co CO and asked him how many guns will he have to leave. AT Co CO said he would have to leave one gun which is in position near ROTHRACH. S-3 told him to contact 2d Bn and make sure they leave one guard with the gun.

1415 - 1st Bn S-3 called S-5 and told him that Co "B" last night heard digging on road between ROTHBACH and BISCHHOLTZ. They were using picks and assumed they were planting mines.

1610 - Asst Div Comdr visited CP.

1615 - S-3 lst Bn report one man from Co "B" hit by sniper fire. We plan to put some artillery fire on BISCHHOLTZ.

1635 - Asst Div Comdr left CP.

1800 - Prior to dark, left squad of Co "C" relieved.

1830 - Co "A", 410th Inf relieved by Co "B", 411th Inf.

1840 - Received plan of attack on NIEFFERN from 3d Battalion, also plan for the defense of OBERMODERN.

1905 - 2d Battalion S-2 reports that 25 rounds of artillery fell vicinity LA WALK.

1930 - C-3 called and said we could use training films on Monday P.M., all day Tuesday, and Wednesday and Thursday P.M.

1945 - 1st Battalion reports that "A" and "D" Companies fired mortars on horse-drawn vehicle going into NIEFFERN. Sound ceased.

1955 - Sound of galloping horse in vicinity of above mortar fire.

2000 - Artillery fire landing vicinity ROTHBACH.

2005 - One rocket shell (dud) landed in our lines between SCHILLERSDORF and NIEFFERN. The direction of the gun was not determined.

2030 - The Division Commander wants to go to one of the I&R OP's sometime tomorrow and have a look at NIEFFERN. Lt. O'Regan will take him out there in the morning.

2145 - 1st Battalion reports several flares in front of their positions. 3 white flares in a row fired. 2 flares observed in front of the 2d Battalion positions.

2300 - "G" Company patrol reached its objective - nothing found.

Found some enemy OP's but they weren't manned, and didn't locate any mines. As they reached a point 200 yards from our OP an enemy machine gun opened up, but it wasn't firing at them. Machine gun was firing over the crest of the hill.

0200 - Submitted the above report to G-2 and G-3.

0300 - Submitted a negative report to G-2 and G-3.

0400 - 1st Battalion reports that their OP observed some flares to their extreme right front. 2d Battalion submitted a negative report. Reported this to G-2 and G-3.

0440 - 1st Battalion reports that at 0405 their OP heard Mg and AW fire to their extreme right and estimate it to be in 2d Battalion Zone. In regard to 1945 entry yesterday on horse-drawn vehicle in NIEFFERN they believe the "galloping horse" is a recording as same sound was heard at 0200, 0230 and 0410. "A" Company patrol left at 0300, returned at 0340. Left from edge of woods in front of NIEFFERN and went straight ahead toward the road, then down the road to point 135 yards from the town. Here they found three rows of AT mines, and of a light color. Couldn't determine the composition as they did not touch them. Also saw a man come across the road from the house on the right to house on left hand side of the road.

0500 - Submitted the above report to G-2 and G-3.

0600 - 1st and 2d Battalions submitted negative reports. Gave G-2 & G-3 a negative report.

0630 - G-3 reports that the 36th Division continued to relieve the lolst Airborne Division during the night. The 42nd Division reports that their front line elements observed huge balls of fire being shot into the air from enemy positions. They didn't explode and they haven't as yet determined what they were. Rest of VI Corps Front quiet during the night.

0700 - Submitted a negative report to G-2 and G-3.

0820 - Received tentative plans for attack on NIEFFERN from 1st Battalion.

0846 - Both I&R OP's are now in. Negative reports. Visibility fair.

1200 - Received negative reports from OP's. Our artillery is dropping leaflets on the towns of NIEFFERN and KINDWILLER.

1300 - Negative reports from OP's. Negative reports from OP's at 1400.

1515 - OP#2 reports that two Krauts ran into woods at 874304 and Cannon Company fired.

1535 - 3d Battalion S-3 says they want the movies tomorrow and Tuesday. S-3 told him that S-6 had OK'd the counterattack and defense plans. 3d Battalion is taking 2 companies out tomorrow to improve the BLR as part of the position has caved in.

1615 - 1st Battalion reports that 2 SP rounds fell 864294 at 1610.

1645 - Chief of Staff called S-3: "Unit Commander's meeting at 1400 tomorrow. Conference room will be at the North end of the CP."

1743 - 1st Battalion reports 5 rounds (believed 88) fell 903267 at 1740.

1815 - At 1800 6 to 8 rounds light artillery fell western edge OBERMODERN. Believed coming from southern edge of woods in 8832 grid square.

2005 - 3d Battalion S-2 reports that 8 rounds (88mm or larger) fell at 856270. 3 rounds fell at 855269 and one at 856270.

0400 - 1st Battalion reports their OP has observed 5 white flares to their right front in the past hour. 2d Pattalion submitted a negative report. Reported this to G-2 and G-3.

0600 - 1st and 2d Battalions submitted a negative report. Gave G-2 and G-3 a negative report.

0630 - 1st Battalion reports that "C" Company sent two patrols out last night. 1st patrol left at 2330 and returned at 0130. Came to the 3 belts of mines that "A" Company patrol found last night, but they think they are Antipersonnel mines, Shumines. 1030 - The division Commander arrived at our CP and left at 1033.

1540 - S-3 called 1st Battalion S-3 and told him that S-6 was on his way to 1st Battalion CP. S-6 has just returned from the Unit Commanders meeting at Division.

1550 - S-6 left to meet 3d Battalion CO and S-3 at 1st Battalion CP.

1550 - SP gun spotted at 909315. Firing on it with artillery. Results unknown.

1600 - Negative reports from OP's.

1700 - Negative reports from OP's.

1700 - S-3 called CO of "B" Company, 328th Engineers, and asked him to report to our CP at

1720 - S-6 returned from 1st Battalion CP.

1730 - Negative reports from OP's. They are checking out for the night.

1820 - At 1810 9 rounds of 88mm fell at 905266. Believed coming from gun spotted earlier in the afternoon at 909315.

2145 - 1st Battalion CO reports that "C" Company patrol is in NIEFFERN engaged in cleaning out the enemy. No estimate as yet of enemy strength.

2200 - 1st Battalion CO reports that "C" Company patrol in NIEFFERN is meeting resistance.

2210 - 1st Battalion OP reports that enemy mortar fire coming into NIEFFERN. Our Cannon Company is firing on them. Several bursts of Machine Gun fire have been heard.

2230 - 1st Battalion S-3 reports that "C" Company patrol is still in NITFIER. Approximately 4 casualties. Having trouble getting the casualties out due to Machine Gun in V-shaped trench. Pinned down in enemy minefield and one casualty suffered there. OP is receiving enemy mortar and SP gun fire.

2235 - OP reports that the enemy mortar fire is still coming in strong.

2400 - 1st Battalion S-3 reports that all but three wounded men are out of NIMFFERN. Enemy mortar fire and artillery has died down. Still trying to get the three wounded men out of the town. Suffered approximately 10 casualties.

0050 - 1st Battalion reports that they still are unable to get the two wounded men out of the enemy minefield. Everytime they try to remove them an enemy machine gun which covers the minefield opens up on them.

0100 - Submitted a negative report to G-2 and G-3.

Ollo - 1st Battalion CO reports that so far they have lost 3 men killed and 8 wounded men have passed through the Battalion Aid Station. The two wounded men in the enemy minefield haven't been evacuated as yet. Only one man killed by small arms fire. Other casualties were from mines. Had very little difficulty with enemy troops in NIEFFERN. Lots of enemy mortar fire received in the town but it didn't bother anyone. Our patrol went up the road and hit the town of NIEFFERN from the Southeast. Ran into an enemy minefield there. Don't know of any PW's taken.

0200 - Informed G-3 that part of the "C" Company patrol had returned from NIMFIGHM, the raid was unsuccessful, and they suffered some casualties.

0300 - Submitted a negative report to G-2 and G-3.

0330 - 1st Rattalion CO called S-6 and informed him that the patrol into MIEFFERN turned out very bad. Believes that 4 men were killed, 2 missing in action (believed killed) and 12 were wounded. No PW's taken. Apparently all of the casualties suffered were from mines except one. Most of the mine casualties suffered were suffered while trying to remove wounded.

0330 - 1st Battalion OP reports that at 0230 they saw what they believe to be a lantern moving in the streets of NIEFFERN. At 0235 one rifle shot was heard in NIEFFERN. At 0303 three rifle shots were heard in NIEFFERN. The two wounded men in the minefield are believed to be dead. Aid men got back up as close as possible to them and called to them. They didn't answer. They feel sure that one man was dead when they pulled out the 1st time.

0400 - Submitted the above report to G-2 and G-3.

0415 - 1st Battalion OP reports that they now believe the light they saw in NIMFFERN and reported as a lantern is merely the wind blowing a small fire.

0500 - Submitted the above report to G-2 and G-3.

0600 - 1st and 2d Battalions submitted negative combat reports. Submitted a negative report to .G-2 and G-3.

0700 - 1st Battalion OP reports they hear the sound of heavy motors in ENGWILLER (reported this to G-2 and G-3).

DATE: 27 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0701A to 1120A

PLACE: BOUXWILLER, FRANCE (\$13252)

0830 - 1st Battalion S-3 reports that it is believed that 7 men were killed on the "C" Company patrol into NIEFFERN last night. The original group consisted of 18 men. The scouts got into the town, but the rest of the group was caught in the minefield. Only 5 men of the original 18 men got into town. The others were caught in the minefield which is located approximately 25 yards from the town.

0905 - 1st Battalion reports that 2 men from "B" Company moved within 50 yards of NIEFFERN.
No enemy activity. Smoke coming from two chimneys in the town. Cannon Company and artillery may fire.

- 0915 Division Commander arrived at the CP and left at 0920.
- 0915 I&R OP's checked in. No activity along the front.
- 0945 I&R OP's report that 2 rounds of mortar fire landed at 872292 and one round at 876294.
- 1010 I&R OP reports that two or three enemy troops are moving around at 898291. Artillery fired but results are unknown.
- 1015 411th Infantry CO visited the CP and left at 1030.
- 1045 OF #2 reports that an American soldier in field at 875299 is moving around. Put on helmet, moved around on elbows, and then fell back. The helmet fell off.
- 1050 Notified 1st Battalion S-3 of above report.
- 1100 1st Battalion OP reports seeing two men walking West on road at 908315.
- 1115 Regimental Munitions Officer called S-3 and told him that the 1st Battalion was at the Regimental dump to pick up the rocket rounds for the demonstration. They only wanted 120 rounds, but S-3 instructed them to take all of them.
- 1117 S-3 called 1st Battalion S-3 and informed him that he was sending the full amount of rocket ammunition for the demonstration instead of 120 rounds.
- 1120 1st Battalion CO called and stated that OP and Artillery OP had informed him that they had seen one of the two men who was left in the minefield outside NIEFFERN last night by "C" Company patrol move. Wants us to get O.K. from higher headquarters for a litter team to go out under a Red Cross flag and bring him in.

DATE: 27 February 1945

TIME: 1121A to 1333A

PLACE: BOUXWILLER, FRANCE (813252)

1125 - S6 called Chief of Staff and asked for O.K. on sending out a litter team under a Red Cross flag to pick up the wounded man in the minefield outside NIMPFRIM. Chief of Staff said he would have to get O.K. from Division Commander who was expected back shortly.

1140 - Chief of Staff called S-6 and told him it was O.K. to send out the litter team.

1144 - S-6 called 1st Battalion CO and told him to send out the litter team under the Red Cross flag.

1200 - G-2 called S-2 and instructed him to get any information regarding mines electrically operated and report it to him. G-2 has to report to Corps on it.

1200 - OP No. 2 gave negative report. Can still see wounded man moving around.

1200 - S-3 called 2d Battalion S-3: "1st Battalion is going to send out a litter team under a Red Cross flag to pick up a wounded man in a minefield outside NIEFFERN. We want all action to stop. Notify people on your right. They will be going out shortly. Will notify you when the litter team returns." (S-3 also called above message to 383d FA Battalion, 411th Infantry, and Cannon Company.

1209 - S-3 called 1st Eattalion S-3 and asked for the exact time the litter squad would leave. 1st Eattalion S-3 will notify us when everything is ready.

1243 - S-3 called G-2 and informed him that the litter team would leave in a few minutes. Told him they would be wearing Red Cross flags and all units had been notified to cease firing.

1245 - 4 rounds artillery landed 872292 (see 0945 report). Apparently coming from vicinity of ENGWILLER.

1255 - 12 rounds estimated 105mm artillery received between ZUTZENDORF and the woods to the right at 1245.

1301 - Litter team just passed OP No. 2.

1325 - One of the regiments of the 42d Division report that their patrols have found abandoned positions and equipment. The positions were occupied by the 11th SS Mountain Regiment.

1330 - 00 of Cannon Company reports they picked up 410 rounds of HE today.

1333 - The litter team is now within 100 yards of the wounded man and they haven't been fired on as yet.

1355 - Litter team is on the way back with the wounded man.

1435 - OP No. 2 reports five enemy troops 300 yards up road Northeast of NIEFFERN. Watched the litter team take out the wounded man. Two of them came down the road after the rescue the Cannon Company fired on them.

1440 - The litter team was able to save only one man. The other man was dead when they got there.

1443 - S-3 informed the 411th Infantry, 2d Battalion and Cannon Company that the litter team was back and it was O.K. to resume firing.

1520 - Interrogation of wounded man revealed that last night there were 100 to 150 enemy troops (some of them in town in cellars and some back of town) in NIMFERN. Said they had a 20-man patrol out just East of the town last night. One of the officers spoke English and questioned the wounded man. Asked him what weapon he carried and he replied FAR. One of the Sergeants wanted to kill him then. He was treated by enemy medics and they were sending a litter team for him, but one of our Machine Guns fired on them and they couldn't get to him. He reports there is a good sized garrison in the town. Prepared positions on hill back of the town.

1530 - S-3 called Cannon Company Executive Officer and instructed him to find out what time firing was resumed after the rescue of the wounded man, and on whose order it was resumed.

1535 - 8 rounds 105mm artillery fell vicinity of OBERMODERN. Came from vicinity ENGWILLER.

1640 - Cannon Company CO reports that they were in error in resuming firing too soon after the rescue.

1645 - S-3 called 1st Battalion 00 and told him Cannon Company was in error in firing before the order was given this afternoon.

1800 - S-6 left for 2d Battalion CP.

1810 - Cannon Company CO reports that 5 rounds of 88mm artillery fell in BUESWILLER at approximately 1810. (Reported to G-2 and G-3).

1810 - 1 platoon of Company "E" relieved 1 platoon of Company "G" at 1800 in reserve position.

Company "G" will have 7 squads on line and Company "F" will have one squad. Company "E" will have 1 platoon in reserve position. Companys "F" and "E" (-) will be in SCHALKENDORF.

DATE: 27 February 1945

TIME:

PLACE: BOUXWILLER, FRANCE (813252)

1955 - Company "G" relieved Company "F" on line.

2000 - 1st Battalion reports two white flares were observed from their OP coming from behind the ridge back of NIEFFERN. Two flares were observed at 1940 and one more at 1955.

2040 - Two more white flares were observed by 1st Battalion OP coming from back of the ridge at NIEFFERN. One at 2030 and one at 2035.

2100 - 1st Battalion S-2 reports that at 2037 one white flare was observed between UHRWILLER and MUHLHAUSEN. At 2040 4 machine gun bursts heard vicinity MUHLHAUSEN. At 2040 and 2050 one white flare from ridge back of NIEFFERN.

2140 - S-3 called 1st Battalion S3 and was informed that a tank commander from the 14th Armored Division would be up tomorrow to select a firing position for the rocket-firing medium tank we have. We will get the tank Thursday and probably fire Thursday morning. (G-3 informed).

2210 - 2d Battalion S-2 reports that one round of heavy caliber artillery fell at 905266.

It was time fire. Outfit on our right reports heaving boxes being opened and digging at the crossroad KINDWILLER and BITSCHHOFFEN.

2350 - 2d Battalion S-2 reports they have two PW's taken at right platoon OP (898280).

DATE: 28 February 1945

ORGANIZATION: 410TH INPARTRY

TIME: 0001A to 0600A

PLACE: BOUXWILLER, FRANCE (813252)

0045 - S-6 returned from 2d Battalion.

0100 - Submitted a negative report to G-2 and G-3.

0120 - IPW Officer called and reported that the two PW's picked up by the 2d Battalion are both Polish. One was a lance corporal and the other was a pfc. They belong to the 36th Engineer Battalion, 2d squad, 1st platoon, 1st Company. This Engineer Battalion is part of the 36th Volksgrenadier Division. Their Company is located in CUMBRECHTSHOFF N: the 2d Company is located in ZINSWILLER; and they haven't seen the 3d Company and don't know where it is. Each company has a strength of about 30 men. The mission of their squad for last night was to build a bunker at 907289. They report that there are three SP guns at the point of woods 915334. They saw three Nebelwerfers (each with 4 tubes) at ed e of woods 915330. About a week ago they saw 10 to 12 SP guns in GUNDERSHOFFEN. They have been laying in great quantity in all the towns along the front. They laid three mine fields at UHRWILLER, 60 mines in each field. They usually expose one mine row and cover the next one so that in trying to step over the first row of mines a soldier will explode the mines in the second row that are covered. They laid five minefields at BITSCHHOFFEN on the South edge of town, about 100 meters beyond the last house in town. There are three minefields on the West side of the road with 60 mines in each field, and two minefields on the East side of the road with about 40 mines in each field. (Assistant S-3 gave this report to G3).

0200 - 1st and 2d Battalions report all quiet in their zones. Submitted a negative report to G-2 and G-3.

0300 - Submitted a negative report to G-2 and G-3.

0400 - 1st Battalion reports that at 0310 their OP heard a fire fight between MUHIHAUSEN and ROTHBACH which was followed by a white flare. 2d Battalion reports all quiet in their zone. Gave the above report to G-2 and G-3.

0500 - Submitted a negative report to G-2 and G-3.

0600 - 1st Battalion OP reports that our own artillery is doing a lot of firing and the target seems to be ENGWILLER. 2d Battalion reports all quiet in their zone. 3d Battalion reports their patrol has just returned and they will give a full report as soon as it is obtained. Patrol left at 0315 and returned at 0600. They got 300 yards past the "A" Co. OP, but couldn't go any further because of the light. (Gave this report to G-2 and G-3).

DATE: 28 February 1945

ORGANIZATION: 410TH INFANTRY

TIME: 0601A to 1303A

PLACE: BOUXWILLER, FRANCE (813252)

0630 - 1st Battalion OP reports there is quite a firefight going on over around MUNIHAUSE. Lots of enemy automatic weapons and some of our own. 4 mortar rounds came in at 0625 just to the right of the "A" Company Sector. (Called in to G-2).

0700 - Submitted a negative report to G-2 and G-3.

0715 - 2d Battalion S-3 reports that at 1900 they sent out a listening patrol to the West edge of KINDWILLER to make reconnaissance. They reached their objective O.K., but they heard a whistling sound which has been reported to us before. The enemy whistles from post to post when a patrol has picked up. Patrol leader says they were probably picked up coming across a piece of open, wet ground as their shoes made quite a lot of noise. The patrol leader took two scouts and went forward. They were challenged and heard the bolt click on an automatic weapon (think it was a machine gun). They then pulled back and called for artillery fire on the position of the automatic weapon. The artillery came in and the patrol leader reports he thinks it was right on the position. (Called in to G-2).

0845 - OP's No. 1 and No. 2 reported in. Visibility is very poor.

0900 - 42d Division picked up two deserters from 5/221 16th ID. Company strength about 50 men. PW stated his Division relieved elements of 6th SS Mountain Division, 11th Regiment. Present disposition of the 36th Replacement Battalion: 9th Company in ROTHBACH, strength approximately 90-100 men - 5th Company, 165th Regiment is new designation. 10th Company in OFFWILLER, strength unknown - 6th Company, 165th Regiment is new designation. Doesn't know where the 11th Company is nor anything about them. Doesn't know where the 12th Company is nor anything about them.

0900 - Memorandum from S-6 to 1st, 2d, and 3d Battalions, Cannon Company, AT Company, MP Platoon, and Headquarters Company: "At all guard posts where persons are asked for the password the guards will keep all civilians, including FFI, away from the post so that civilians cannot hear the password."

1100 - OP reports approximately 12 enemy troops coming from UHRWILLER toward NIEFFERN.

They reached a point about 883307 and then returned. Probably intended to move up under cover of the fog but found it had lifted.

1217 - Negative report from OP's.

1303 - Negative report from OP's.

DATE: 28 February 1945

ORGANIZATION: 410TH INFANTEY

TIME: 1304A to 2400A

PLACE: BOUXWILLER, FRANCE (813252)

1410 - 1 flare seen at 857307.

1430 - 3 flares seen at LA WALCK.

1432 - S-3 told 2d Battalion S-3 that at 1545 today the 411th Infantry was going to smoke one of the towns in front of their positions and then use artillery and small arms on it. They are not going to attack, just trying to bring the enemy out.

1439 - S-3 repeated the 1432 message to 1st Battalion S-3.

1447 - S-3 called 2d Battalion and told him that G-4 was going to inspect the property books of "E" and "H" Companies tomorrow at 1300.

1450 - Received one artillery round at 903257.

1500 - 2 flares seen at 857307.

1505 - An artillery Battalion S-3 of the 14th Armored Division called S-3 and reported that they had spotted a half-track in KINDWILLER and wanted clearance to fire on it. S-3 called white 3 and told him of this.

1530 - at 1515 18 enemy troops moved into town at 909323.

1540 - At 1517 two enemy troops moving along trail at 892323 to 900327.

1910 - 411th Infantry reports their demonstration this afternoon drew no enemy fire.

2230 - 2d Battalion S-2 reports that their patrol is back and found occupied position by two or three Germans at 88702965. Unoccupied position with wire running to it (wire was cut by patrol) at 892296. Germans seen at 894293 (KINDWILLER).
