2130 - Two guards at Regimental Headquarters Motor Pool (field right behind the CP) observed someone with a very small flashlight in the Motor Pool. They went down to investigate and the light vanished as they approached. They yelled "Halt" twice and then fired 3 shots.

2140 - Our MP Officer reports that at 2115 a 409th Infantry soldier was guarding the gasoline dump in BOUXWILLER. He fired 7 shots at someone in the dump after yelling "Halt" twice. Shortly after that the guard who relieved him fired two or three shots in the same dump. (Guard - Pfc. Fred E. Nigut, 20607489, Company "D", 409th Infantry.)

2220 - 1st Battalion called and wants the artificial moonlight turned on. We checked with 411th Infantry and they want us to keep the moonlight out of their zone. We informed the 1st Battalion of this.

2223 - Our MP Officer called and said that at 2200 the guards at Regimental Headquarters Motor Pool again saw someone there with a flashlight. This time the guard tried to crawl up on the intruder and grab him. Just as he got near the man, a thermite grenade was thrown near him and blinded him for about 10 minutes, allowing the intruder to escape.

2300 - Lt. Hollingsworth, our AA searchlight officer, called and said that the 411th Infantry had consented to our using artificial moonlight. We then called all Pattalions and the 14th Armored Division and notified them that the artificial moonlight would go on at 2305.

2310 - S-2 called 409th Infantry S-2 and informed him of the incident in our motor pool. He said he already knew about it and had notified his Battalion.

0955 - S-3 informed 1st Eattalion S-3 that the 14th Armored Division would lay a smoke screen in their zone sometime this morning to aid in evacuation of a disabled vehicle.

1000 - Negative reports received from OP's.

1015 - S-3 called 409th Infantry S-3 and asked them if they were running a problem last night. They said that they were not, but that they were firing some illuminating shells during the night. S-3 asked 409th S-3 to inform us when they have a problem or a demonstration.

1040 - G-3 (Captain Cocke) called S-3 and asked if we had anyone quartered in 80 SS LSHAUSE. G-3 wants to move some troops in there if it is O.K. with us.

1100 - Negative reports received from OP's.

1115 - At 1700 this evening one platoon of "F" Company relieves one platoon of "E" Company. At 1900 "E" Company relieves "G" Company on the MLR. "G" Company leaves one squad in position.

1125 - S-3 informed G-3 of 1115 entry.

1155 - CIC informed us that the new curfew hours are 1900 - 0630. Notified all our units.

1245 - 1st Battalion reports that their 2-man patrol did not go out last night because of a 10-man patrol from 411th Infantry going into the same area. 411th Infantry patrol found enemy OP at 86453022 and 2 occupied positions at 86543056 and 86663032. The enemy OP was manned by only one soldier and when he saw 411th patrol he ran to one of the occupied positions (86543056). Immediately 4 white flares and 1 red flare came from vicinity MUHIRAUSEN. This was followed by 1 red flare from vicinity NIMFFERN. Very shortly 6 rounds of mortar fire fell in vicinity of positions the patrol occupied.

1300 Negative reports received from OP's.

1350 - OF's observed two enemy soldiers enter house in West end of MINFFERN.

1400 - S-6 left to visit the Battalions.

1430 - The Division Commander visited the CP and left at 1431.

1432 - S-3 informed 3d Battalion S-3 that the Division Commander was on his way down there.

1450 - Negative reports received from OP's. Cannon Company fired on house in MIEFFERN where two enemy soldiers entered.

1600 - Negative reports received from OP's.

1600 - S-3 called Regimental Munitions Officer and told him he would like to use the German weapons he has for use in the 1st Battalion - instructing.

1601 - S-6 called and said he was leaving the 1st Battalion and was going to the 2d Battalion.

1700 - CP's are checking out for the night.

1730 - one platoon of "F" Company relieved one platoon of "E" Company in support platoon positions.

1732 - S-6 returned from 2d Battalion.

1955 - "E" Company relieved "G" Company on the line.

2015 - The 14th Armored Division is conducting a night problem in their rear area and will use flares. (Notified all our units).

2145 - 2d Battalion reports enemy mortar position at 898290. Fired on by our artillery and knocked out.

2239 - 2d Battalion patrol reports a minefield at 8845 2935 extending at least 40 yards in each direction. Estimate that the nose of the hill is completely mined. Report they observed gun flashes in rear of KINDWILLER and think they are 75mm guns.

2325 - 1st Battalion reports "A" Company patrol returned. They reached their objective no enemy action - found no mines. They heard the sound of a horse and wagon on road SE of UHRWILLER and motor vehicle running W from town. Believe the Germans are using a recording machine again.

2330 - Lt. Edwards, 409th Infantry, said 2 men from our "L" Company are being held by their MP officer, being picked up in a stolen jeep.

2335 - Captain Whipps, Company "L" Commander, said he would come down first thing in the morning and check on his two men held by 409th Infantry. Our MP officer is picking up the men from the 409th and will hold them in our guardhouse for the night.

0830 - S-3 called Regimental Munitions Officer and wants him to make a double check on the "didd" that fell in "I" Company area. ASP No. 42 has quite a lot of 30, 45, and 50 caliber ammunition and also boxes of one-half pound blocks of TNT. These may be had by just hauling them away.

0900 - Negative reports received from OP's.

0907 - 3d Battalion S-3 informed us that their inspection would be at 1000 this morning.

1000 - Negative reports received from OP's.

1015 - S-3 called G-3 and told them that our tank was no in position to fire the rocket demonstrations and would probably fire in about one hour. They will be in position on road leading from where our 1st and 3d Battalions are up to the town where the 1st Battalion of 411th Infantry is.

1538 - CO of 1st Battalion called S-3 and told him that there are some men in between the front lines and MUHLHAUSEN. Wanted us to check and see who it is. S-3 called 411th Inf. and they know nothing about it.

1600 - Received negative reports from OP's.

1612 - All Clear.

1615 - AT CO called and wants to do some indirect firing on KINDWILLER tomorrow. S-3 said it was O.K., but that AT CO should coordinate with 2d Battalion.

1618 - G-3 called S-3 and told him that the 14th Armored Division would fire artillery for one hour beginning at 1700. Will be both heavy and light. (Called our organizations).

1700 - OP's submitted a negative report and checked out for the day.

1818 - Platoon Leader from 3d Platoon, Company "A", 48th Tank Battalien dropped in and said he will move his tanks up to ZUTZENDORF tomorrow morning. They have one tank with a 76mm gun and 4 tanks with 75mm guns. Call sign is FONDALE ARLE 3.

1850 - G-2 called S-2 and reported 3 enemy tanks in KINDWILLER. They were fired on by the 14th Armored Division. Might be self-propelled guns. 13 self-propelled guns seen on 28 February in REICHSHOFFEN.

2038 - 2d Battalion reports rockets are firing at them from a 60 degree azimuth from their right AT gun position.

2105 - Division Operations Instruction No. 66 received from Division.

2345 - 2d Battalion requests artificial moonlight. Contacted the 1st Battalion, 14th AD, and 411th and they say it is O.K. Informed G-3. Informed Lt. Hollingsworth to turn on the lights.

2355 - "A" Company patrol spotted 2 MG positions 884302 - one gun 20 yards up road from coordinate along road to UHRWILLER. Other gun 50 yards closer to town and on left side of road at 885306. Heard a record machine in UHRWILLER. "B" Company patrol reached objective. Observed enemy occupying positions along and near road. Heard recording machine. 2d Bn patrol established listening posts. Lots of enemy flares. Coming from 90152870 believed to be enemy OP's. 20mm AA guns from behind KINDWILLER firing direct fire on PHAFFENHOFFEN.

0945 - S-3 called 3d Battalion S-3 and asked him if they could ration 25 men from the 48th Tank Battalion - 12 men with "K" Company and 13 men with "L" Company. 3d Battalion S-3 said it would be O.K. (S-3 called S-4 and informed him of this).

1015 - SWIFT 3 called S-3 and asked if it would be O.K. to use the range at 747225. S-3 told him he would have to contact Major Sipes, our Reinforcement Company CO.

1032 - S-3 called 3d Battalion S-1 and told him a bomb disposal officer was on his way up.

1045 - CO, Co. "A", 614th TD Bn., called and said that near his 2 gun position in ZUTZENDORF there is a lonely house West of the woods and during the night lights came on and no effort was made to blackout the windows. Going to check the house today. Every morning two men come across the field, enter the house, and then leave in the evening.

1915 - S-3 called G-3 (Captain Dalcher) and told him that tomorrow at 1000, weather permitting, our AT Company is going to use one gun (vicinity SCHALKENDONE) with direct fire on some buildings in KINDWILLER. Perhaps some at UHRWILLER. The principle training events for tomorrow - Company "D" 0830 to 1100 "Familiarization with German weapons". Area field West of OBERMODERN.

2010 - 3d Battalion S-1 reports that the 3d Battalion relieved the 1st Battalion on the line at 1945 (reported to 0-3). One platoon of "K" Company and one platoon of "L" on line.

2050 - 3d Battalion requests artificial moonlight.

2200 - 409th Infentry called and said they will fire HE 81mm mortars from 0900 to 1200 tomorrow. Impact area will run from 78652590 to 79402955. 2d Battalion 409th will post range and road guards. Road from WEINBOURG to OBERSOULTZBACH closed from 0900 to 1200.

2230 - 2d Battalion S-2 said their patrol is back. Followed route submitted on overlay. Found nothing. One white flare fired from center of KINDWILLER. Got to within 50 yards of building on right end of town. (Reported to G-2).

2300 - 1st Battalion closed into OBERMODERN AT 2025.

2345 - Artificial moonlight turned on.

Informed G-3 of this.

0100 - Submitted a negative report to G-2 and G-3.

0200 - Checked with 2d and 3d Battalions and they report no enemy activity on their front. Submitted a negative report to G-2 and G-3.

0220 - 2d Battalion reports their patrol just returned. No report as yet. They want some artificial moonlight. Called G-3 on the moonlight and they instructed us to coordinate with 411th Infantry and 14th AD. Checked with 3d Battalion and they still have a patrol out, so

0300 - Submitted a negative report to G-2 and G-3.

0330 - 2d Battalion reports their "G" Company patrol went out at 2400 and returned at 0220. They went to coordinate 907289. They found some enemy position unoccupied and full of water. They heard nothing and saw only flares that were fired at regular intervals.

0340 - 3d Battalion reports their "K" Company patrol went out at 2000 and returned at 2320. Their mission was to make a reconnaissance of the main road into NIEFFERN. 0855- G-2 says we do not pick up cameras. Says SHEAF will put out a memo on it. The use of cameras and binoculars by civilians will be prohibated.

0930- S-5 called AT First Sgt. and ordered him to have a Platoon ready and waiting at Cp and Capt. WHIPPS will pick them up.

0935- S-2 instructed MP officers not to pick up cameras or binoculars. MP's will screen all civilians in whose homes they find firearms.

1030- 3d. En S-2 reports there is a good boat launching site on their right flank. There is a spot in "I" Co. sector where boats may be launched, but they aren't too good.
