HEADQUARTERS 410TH INFAUTRY

11 Nov 44

Location of Headquarters: (33.4-66.0)

- 1210 00 of Company "C", 601st TD Battalion visited our CP and informed us that his company had been attached to 6299-3. We have two methods of communicating with them. They have an M-20 Scout Car in our CP that we can contact by calling URICKET CHARLEY RADIO. We can contact their CP by calling CRICKET CHARLEY.
- 1230 Our S-3 was informed that the 411th Infantry is trying to force our train bivouac out of their area. We called Division and they told us to keep the area until they could decide who it did belong to. We sent our S-5 up to our train bivouac to hold the area until Division decides.
- 1530 The Division Commander visited our CP to check the situation. He informed us that we were to send a patrol down to the TAINTROUX RIVER to check it for width and as to whether the bridge across had been blown or not.
- 1550 CO, 328th Engineer Battalion visited our OP to check on our roads and mine sweeping. Phone is in to his Battalion CP. They will sweep mines for us in the CHALET area tomorrow. Darkness prevents any mine sweeping tonight.
- mines in the CHALET area tomorrow. OC 3d Bn., informed us that he was running patrols tonight to contact Co. "E" of the 409th. Co. "E" of the 409th is on his right about 600 yards away. His S-2 is now checking on the track up to his right flank. He is sending his patrols from CHALET into enemy held woods South of CHALET. The patrols will go out not earlier than 1900 and are ordered to return at 0200. He wants arty fire in this enemy held woods and as much as 100 yards into the woods before 0200. At 0400 he would like arty fire on the north edge of the woods and 25 yards into the woods and along the track leading back to CHALET. He would like that fire again at 0500 and 0600, the reason being that PW's have said that the enemy uses the edge of these woods to launch an attack and they use the track as a route of advance. S-3 will call him back about the arty fire.
- 1620 5-3 3d Bn called and said that Captain Whipps with the rest of his "L" Co. will go down to the 600 yard gap between our right flank and the 409th. They will protect the CP that the 3d Bn. now has. He can also prevent any enemy coming up the draw and act as a reserve for the rest of his Co. which is now in CHALET.

11 Nov 44 Cont'd

Location of Headquarters: (33.4-66.0)

- 1655 Received the situation overlay from 2d Battalion.
- 1700 S-3 to CO 383d on arty fire for our 3d Bn. Arrangements were made to fire this mission at 0400, 0500, and 0600 tomorrow morning. Colonel May has been informed that he will receive the arty fire.
- 1720 S-3 to 2d Bn. Get information about TAINTROUX RIVER as to width and whether bridge has been blown. Information will be phoned in as soon as possible.
- 1730 We are sending a relief platoon to LA BOLLE to relieve elements of the 30th Infantry. This platoon is composed of a reinforced platoon from "G" Company supported by "H" Company weapons. We reported this to Division G-3 Section. G-3 informed us that the Chief of Staff's decision on whether we, the 41lth, or arty would get our train bivouac area was that in case of conflict we would have to move out.
- 1825 CO Cannon Company to S-3 CO On Co informed S-3 that he would fire interdictory fire from 112000 to 112200 and again from 120500 to 120700 at the following points; 400-657 387-664 and 383-642. Permission was granted for this interdictory fire.
- 1900 Situation overlay received from 3d Bn.

Our attachments are as follows: Company "B" of the 3d Chemical Bn., Company "B" of the 328th Engr Bn., Company "C" of the 756 Tank Bn., and Company "C" of the 601st TD Bn.

- 1950 S-6 to S-5 at our train bivouac: It's too late now to send up the water and rations for the 2d Bn. This truck will leave the first thing tomowrow morning with the water and rations and is to have priority on the roads. CO 2d Bn. says he cannot distribute water and rations at night because the truck cannot get into his area at dark. He must have them by 1500 every day.
- 2015 S-2 to Captain Parker: At 1800 this evening an enemy tank of unknown size was seen on the road to St. Die and was knocked out by 383d Arty. There may have been more tanks knocked out at 410-652 at 1910. Ens were notified of the fact that tanks were in this area so they could put out bazookas and AT protection. Earlier this evening we spotted a small patrol about 413-760. There were 5 to 8 men and were spotted by "C" Co. Roads are mined from CHALET To ST. DIE according to PW's.

11 Nov 44 Cont'd

Location of Headquarters: (33.4 - 66.0)

- 2015 Charley says "AMERICAN SOLDIERS LAND IN PANAMA." Phone Code for Cont'd Units: VI Corps REDWOOD. 409th FANCY. 411th FATIMA. 383d FAGGAT. 3d Division COBRA. 36th Division ROBERT. 45th Division POWER.
 - 2037 S-3 of 383d informs us that they will put fire on three points for our 3d Bn at 0400, 0500, and 0600. Two rounds per gun. We called 3d Bn. and informed them of this fire and cautioned them that Germans might come back with lots of fire, S-6 suggests that men be kept well under cover. Nothing about "K" Company.
 - 2036 lst Bn. to S-2: We are sending a German Document to you that was found in "B" Company area. We would like to know any results from it. We will send out patrol and set up CP's if it clears up a little tomorrow.
- 2135 Erwin to S-3: Coordinates (378-637). We got information from PW used to dig in and to form for any movement. Battalion about 150 men.
- 2145 S-2 to G-2: Information about PW captured. We got 6 PW's in CHALET. From 1st Co. of 202d Mountain Bn. They had positions in edge of woods SE of CHALET, 60 men in position, cover 60 yards. Entire Bn. of about 150 men. They said at "F" Sector was the 201st Battalion, 90 to 100 men. These two battalions are supplemented by elements of other Bns. PW captured at LES MOITRONES. 2 men identified as belonging to the 2d Co., 726th. They said a mountain bn. was to their left. One was from 7th Co., 726th. They were stragglers. No information about captured men at LA BOLLE. Fronts are quiet. Entire 225th Regiment was being reorganized and equipped about 15 November. No information as to how they got across the river. People around here gave them the information avout the river.
- 2245 Relief of elements of 30th Infantry by reinforced platoen of "G"

 Co. still in progress. Enemy mortar and arty fire falling 2255

 (From S-3, 1st Bn.) 1st and 3d Bns report no action on their fronts.
- vires are OK in CP. There should be no change in position.
 - 2310 S-3 to S-4: Major informs us that rations are now on their way up.
 We called the let Bn. and informed them that the rations were on
 their wy, and they should be in Bn. area by 0100.

11 Nov 44 Cont'd

Location of Headquarters: (35.4 - 66.0)

- 2320 G-3 to S-3: We asked if a periodic report would be made tonight and should they be turned in to the 30th Infantry or 3d Division. We were informed that they should be turned into 3d Division as they are still in control. G-3 wants the location of the CP's of our attached on our overlays. Cur relief to LA BOLLE should be in progress.
- 2350 1st Bn. S-3 informs us that no 4.2 mortars have fired as yet.

12 Nov 44

Location of Headquarters: (33.4 - 66.0)

- 0010 Major Thomas, Asst. G-3 was given location of our Bn CP's.
- Oloo 2d Bn. reports that "E" Co has had one man killed and four wounded by enemy mortar fire on house they are using as CP. They are reporting to move CP tonight.
- 0130 From OG, 6299: "6299 assumes command of its area 0900 12 November.
- 0145 S-4, 3d Bn. arrived with rations for 2d Bn. 2d Bn. notified and rations will be picked up in the morning at Regt. CP.
- O220 let Bn. reports tha "B" Company moving to new position became split and one-half of the company arrived at 2d Bn. CP. S-3, 2d Bn. is trying to guide them to their own Company.
- 0225 2d Bn. reports that reinforced platoon following guide into La BOLLE was delayed due to the fact that the guide lost his way. Platoon leader is trying to locate his position and proceed on to LA BOLLE.
- 0600 2d Bn. reports that a guide was sent out to attempt to locate the reinforced platoon from "G" Company but no contact has been made as yet.
- 0615 30th Infantry reports that our relief of their troops was completed at 2400. No confirmation as yet. 30th Infantry is rechecking. Our 2d Bn. just reported that relief is not complete as our reinforced platoon from "G" Company had not as yet reached LA BOLLE.
- 0710 G-3 wants to know when our relief of the 30th Infantry is complete.
- 0750 lst Bn. reports that "B" Company is still uncertain as to whereabouts of their complete company. Will report back as soon as confirmed. They report before end of conversation tht "B" Company closed into position at 0500.

12 Nov 44 con't

Location of Headquarters: (33.4-66.0)

- 0800 GO 383d FA reports that mission was fired for our 3d Bn as called for by his battalion and was assisted by 928th FA Bn. Missions were fired at 0400, 0500, and 0600.
- 0950 TD CO visited our CP and informed our S-3 that he was going to change the position of his guns so as to cover road running in front of 1st Bn.
- 1010 S-3 to G-3: We have no word of our platoon from "G" Company that was to proceed to LA BOLLE and relieve elements of the 30th Infantry. We have just received word that this platoon is on the edge of the woods outside LA BOLLE and has failed to relieve the elements of the 30th Infantry. TD's are now on the road leading South from the spiderweb about a quarter of a mile down the road. These TD's are self-propelled.
- 1030 S-6 called 2d Battalion and instructed him to get his Ex O down to LA BOLLE and see that our relief of the 30th Infantry is completed tonight. 2nd Bn CO wants the GRO at his OP this morning.
- 1115 Our attached Chemical Company reported their OP at (362-671). They have eight operating mortars and a total effective strength of 7 officers and 113 enlisted men.
- 2nd Bn was called in regard to position for 4.2 mortars. Engineers are sending down the necessary personnel to cut the trees. 2nd Bn has selected an area of about 200 yards long which will have to be cleared for 4.2 mortars.
- 30th Inf to S-3: A platoon of tanks which had been attached to the 30th Inf wanted to know if they were relieved. They were informed, through the 30th Infantry, that they had reverted to us at 0900 this morning and were to stay in position. They are in the vicinity of the CP of our 2nd Bn.
- 1155 S-6 to 2nd Bn S-3: Our GRO is at the 1st Bn CP now. 2nd Bn is to send a jeep down to the 1st Bn CP to pick up our GRO. Engineers will send 2nd Bn a squad of men at 1300 today. 2nd Bn liaison will guide the Engineers down from Regt CP at that time.
- 1200 "C" Company reports that they have spotted 15 enemy tanks on the road running North on the ST DIE-LA VOIVRE road at 0800. Artillery observer reported that either arty or mortar fire was placed on them, but this report is unconfirmed.

12 Nov 44 con't:

Location of Headquarters: (33.4-66.0)

- S-6 to 3rd Bn CO: "Your ammunition truck is now at the spiderweb.

 Send a guide for it. The 81 MM Mortar and 60 MM Mortar ammunition on this truck is all that our Regiment can get until the 24th of November. You will use accordingly. A few trip flares are available at Regimental DP on request or on request to Captain PEREZ."
- 1330 S-2 to S-3: "15 or 20 tanks have been spotted in the ST DIE area. Corps is very upset about this report. Did anyone except this Field Artillery Observer spot these enemy tanks?" Our S-2 informed G-2 that the name of the Field Artillery observer is unknown to us, but it is reported that he is from the 41st FA Bn and as soon as he reaches his OP we will contact him. G-2 wants to know about this for the information of Corps. G-2 informs us that Division is putting personnel into OP's at dark tonight to cover our entire sector. They will give us coordinates of CP's later. Division will have communications with these CP's. We asked G-2 about 30 round of propaganda artillery that the 41st FA Bn will have to fire today or not at all. The propaganda is addressed to the 16th Div and G-2 informs us that there are no 16th Division troops in this area to his knowledge. G-2 is going to check before we fire this mission and we are to hold up until we hear from him.
- 1400 S-2 to G-2: "We picked up two prisoners this morning. One was from 2nd Co, 201 GEB. One was from 2nd Co, ZBV. They have been separated from their units since 10 November at 0600 and have been milling around in No Man's Land. This morning they decided to desert and came over to our lines. They had been in Meitresses. We picked them up at 0930 this morning at (385-650). Upon questioning they told us there were 10 more Germans that were in houses along the road (386-648) who also wanted to surrender. Both PW's gave the following information about the TAINTRUX RIVER between MOITRESSES and LA BOLLE. The river is about 15½ feet wide and about 4 feet deep at present. Banks are about a 45 degree slope and banks are of clay. Area surrounding the river here is extremely swampy. The current is extremely swift. There is an old ford that is passable at (38.4-64,5).
- 1400 CO of the Chem Mortar Co that is attached to us was in and informed us that his lst Plat is supporting our 2nd and 3rd Bns and his 2nd Plat is supporting our lst Bn. His 2nd Plat has a switchboard in. He is sending up Sgt TRIANO as his liaison officer.
- 1500 CO off our attached Tank Co came into our CP and gave us the disposition of his tanks. Three are in HERBAVILLE and one more will go up tonight. Two are in SAUCERAY and two more will go up tonight. Seven are 600 yards in the rear of our CP and two more will come up tonight.

12 Nov 44 con't:

Location of Headquarters: (33.4-66.0)

- 1530 S-4 to S-5: S-4 is in the G-4 tent at Division and wants information on the move of his train bivouac. S-5 has no information on a move as there is room for both 6299-G and 6299-H in their present location. S-5 suggested that S-4 contact S-6 who is now in the Division War Room at a Unit Commanders meeting. S-4 informed S-5 that the phone in his area has gone out. We have Hq Comdt checking on it.
- 1610 2nd Bn S-2 reports that German documents and pictures have been found in a building in the "C" Co area at (38.95-67.5). The 30th Inf was designated by the CIO to search this house. CI C took three Frenchwomen from this house two days ago.
- 1610 CO 1st Bn reports that his ration truck has never come in. We are now checking on this and are to call him back as soon as we have a report.
- 1620 Div PW Interrogator called our S-2 for information on the two PW's we took this morning. We gave him the same information that we have to G-2 earlier in the afternoon.
- 1630 G-3 wants our liaison officer to bring coordinates of Regt & Bn CP's to Div this evening.
- 1650 S-3 to 1st Bn: "Have you men at coordinate 38.35-68.4? It is a read junction." 1st Bn informed us that they might have one squad out there, but didn't know. We informed them that if they have a squad of men there that the TD CO will put in one or two M-10's. They said they would put a squad of men out there. TD CO is to check with S-4 of 1st Bn before he puts his M-10's into position.
- 1710 CO 1st Bn called our S-5 for information about his rations, water, mail, and cigarettes and tobacco for his men. He was informed that these ration trucks were to pull into Regt CP by 3:00 in the afternoon and we haven't seen anything of them. He was also informed that the ration breakdown was started at 1130 this morning. S-5 informed CO 1st Bn that as soon as we had any information of these ration trucks we would let him know.
- 1650 G-3 to S-3: G-3 has information that there are 7 and possibly more enemy tanks in the vicinity of our second and third battalions. We have no information on this. According to G-3 our artillery support is firing on these tanks and has knocked out seven of them. This report is unconfirmed. Tanks were reported in the vicinity of coordinate 40.0-65.8. G-2 wants a report on this immediately as it has to go into Corps.

12 Nov 44 con't:

Location of Headquarters: (33.4-66.0)

- Oapt Parker, 383d FA Bn liaison officer, gives us this information on the tanks that were reported. "Two tanks observed and fired upon at coordinate 41.34-66.18. Forward observer reports that they were neutralized at 1530. Two tanks observed and fired upon at coordinates 40.5-65.6. Observer reports tanks neutralized at 1545. One tank observed and fired upon at coordinates 39.28-66.02. At 1610 forward observer reports visibility so bad he is unable to see results of fire. One gun observed and fired on at coordinates 40.48-65.81. Observer reports gun neutralized at 1610. Enemy mortars in position observed and fired upon at coordinates 40.46-66.58. Observer reports that mortars moved from this position at 1700. The 383d FA Bn fired all of these missions."
- 1750 8-6 directs that 2nd and 3rd Bn S-6's report exact time of arrival at ration truck and to have three guides at Regt Hq CP tomorrow at 0830.
- 1755 S-6 of 2nd Bn reported to our S-6 that our reinforced platoon for relief of elements of the 30th Inf at LA BOLLE went into position at 1740. Elements of the 30th Inf are now on the way back to our position.
- 1810 S-3 of 2nd Bn reported that "E" and "F" Co's had received fire from tanks and mortars at 1700 today. Fire located at coordinate 40.2-65.4. Mortar fire located at coordinate 39.9-66.1. Artillery fire was called for. Tank and mortar fire was silenced. "F" Co has outposts at LA BIHay, total of 19 men. "G" Co is in the process of relieving "L" Co, 30th Inf. Will let you know when the relief has been completed.
- 1830 "D" Co reports that at 1805 they observed French civilians removing possessions from several houses in town of MAIZELAY. They were waving a white flag and placing their household possessions in hand carts and moving away.
- 1828 French civilians found in American jeep on way to ST DIE. They said they were going to ST DIE to observe arty fire, supposedly sent by the 15th Inf.
- 1830 S-3 to G-3: "At 1753 our reinforced platoon of "G" Co relieved the last elements of the 30th Inf."
- 1900 Overlay of plan of fires received from 3rd Bn.
- 1900 Div Arty wants information on tanks fired upon by our arty support and also whether any damage was done to tanks fired upon. Will get this for them as soon as we can contact our forward arty observer and the visibility lifts.
- 1910 00 2nd Bn reports that relief of the 30th Inf is now completed.

12 Nov 44 con't:

Location of Headquarters: (33.4-66.0)

- 1911 S-6 to G-4, quote "Get my rations issued at 0800 in the morning. Must get rations to Bns at 1400 or 1500 or they can't get them to the troops." G-4 said our rations could be drawn at 0800 in the morning and would notify our S-4 of that fact."
- Patrols extend to 372-642. Have communications to all companies except "K" which will be in shortly. We have OP secured again tonight. We have a patrol from Co "K" to Co "L". Patrols from Co "L" going into main draw. Going into mortar positions and also toward 2nd Bn. Our guards out 100 yards. No arty fire tonight. Co "L" reports cur arty coming in close. Capt HERSHBERG will refire tomorrow. Many civilians in CHALET. Two houses to be raided tomorrow believed to be occupied by Krauts. We have mortar and arty fire thrown at us for four hours this afternoon. One man killed and one man wounded in Co "I". They threw about 30 rounds of arty at us this afternoon. The OP was no good tolay, no visibility.
- 1950 S-3 2nd Bn reports that Bn ration truck arrived at 1700. Capt Bailey figured they would have arrived at 1530 if the truck had not got stuck. In order to get rations to co's at proper time they should arrive at CP at 1400. Relief has been affected at 1930. At 1700 arty fire brought on mortars fire. Mortars at 39.9-66.1.
- 2015 S-4 to S-6: "Have made arrangements with 411th and will remain in present position. Am issuing 1 2/3 rations tomorrow which will give all units a reserve. Remainder of sand bags for vehicles to be drawn tomorrow. All troops were issued cigarettes, candy, gum, etc today.
- 2040 S-6 asked Chief of Staff about releasing French civilian and French officer captured today driving American jeep 600 yards north of road bend, 200 yards NE LA MENANTILLE.
- 2100 S-6 1st Bn to S-6: "Will we be able to draw 10 in 1 rations? We have lost contact with Co "O", wires are out. No casualties in Bn today.

 One man of "B" Co twisted his knee and was evacuated."
- 2112 Div Chem Officer to S-3: "Have liaison officer report to Div Hq at 0830. He will see Col Bishop after meeting."
- 2300 S-3 let Bn to S-3: "Co A reports 3 white flares being fired in LA VACHERIE (37.0-69.1) in zone of the 15th Inf. Co "O" reports one flare in outskirts of ST DIE followed in five minutes by two other flares. Machine gun fire from across MEURTH RIVER in vicinity of Co "O" at coordinate (39.8-67.0) in addition reported arty fire at approx (39.4-66.5). Arty fire landing in territory to north of our zone.

12 Nov 44 con't:

Location of Headquarters: (33.4-66.0)

- 2305 S-3 to S-3 383d FA Bn: "We have been firing white phosphate at coordinate 40.11-66.09 to knock out tank. We fired 26 rounds of it."
- 2310 S-3 to S-3 let Bn: S-3 let Bn informed us that two men were walking in road in front of "C" Co outpost position. Fired on them but no results. Co "C" reported 3 flares to his right at 38.8-69.9. Outfit to our North had ordered flares to be fired at LA VEIN.
- 2315 S-3 to S-3 lst Bn: Unit to our N had ordered flares to be fired at LA VOIVRE.
- 2318 S-3 to G-3: Enemy MG is firing across Meurth River at 1070 from Co A.
- 2335 S-2 2nd Bn to S-2: Two tanks at 40.11-66.09. Artillery fire on same. We fired Btry of HE and WP at 2300.
- 2359 S-3 to S-3 let Bn: Change in degrees reported by Co A. It should be 40° instead of 107°. Position where reading was taken 379-681. At 389-699 three flares landed and MG opened fire.

13 Nov 44:

Location of Headquarters: (33.4-66.0)

- 0020 S-3 to S-3 383d FA: Co A is located at 379-681. Enemy MG azimuth of 40° from that point. Take line from 379-681 and extend line from NE up toward LA LOUVIERE. Somewhere at a greater range at 389-699 point. Estimated spot to fire on 3905-7025.
- 0025 S-3 to CO Co-A: Co A OP just got 7 rds of 88. 6 more rds of 88's from MARZELAY. 88's landing at HERBAVILLE.
- 0040 S-5 to S-3 383d FA: 383d reports Div arty can's reach so will get medium gun. Will probably fire in 15 minutes. Co A rpts intradictory fired same time (2015) last night.
- 0045 S-3 to 00 Co A: Division will bring medium artillery on position.
- 0053 S-3 to S-3 383d: Artillery will fire 12 rounds at 0105.
- 0059 S-3 to 00 Co A: Informed of above.
- of Co A and the N plat of "C" Co at about OO15. We had two CP's take an azimuth on the muzzle blast and after getting this our S-3 took a look at our base relief map and checked the most likely place for the gun to be firing from. This gun, according to our calculation, was located at coordinates 39.05-70.25 and we requested arty fire on this position. Corps arty medium bn laid a concentration in of 12 rounds at O105. Our observer checked the rounds and found that the sixth round was very close. The rest of the rounds were to the right of the target. Our own arty couldn't traverse that far so I called the 15th Inf and they agreed to let us use their arty support bn for this fire. The concentration was fired at O240. Our observer reported the fire was 200 yards left repeat range. That word was relayed to the arty and they fired five more rounds adjusted fire and put them right on the target.
- Oll5 S-3 to CO Co A: CO Co A said his OP said that arty fire to right of MG position. One rd came close, believed to be #6.
- O300 Our troops are receiving fire from at HERBAVILLE from what is believed self-propelled 88's. They can pick up no muzzle blast but believe the fire is coming from the village of MARZELAY. Division was notified on this and we put CP's there ready to pick up that firing anytime they start again.
- 0330 "K" Co receiving fire in their area at this time.
- 0615 G-3 just called and wanted to know what has happened during the night.
 We gave them this information. G-2 already has this information.

13 Nov 44 con't:

Location of Headquarters: (33.4-66.0)

- 0720 0720 2nd Bn reported a very quiet night on their sector.
- 0800 3rd Bn reports very little activity during the night on their sector.
 A little arty fire in this sector, but not very much. Reported that
 their guides were on the way up to guide the 411th down to their CP.
- 0805 Message sent to all Bns and all Spec Units as follows: "The CG will never be referred to by name in any telephone conversation or where his name may be overheard. He will be referred to as FAME 6. No officer will give his name when halted by a sentry. He will say "Friend with the Countersign." in reply to the challenge of the sentry."
- 0920 S-6 of 411th Inf arrived at our OP with his S-5 to check on the situation and future plans and was then guided down to our 3rd Bn.
- 1020 Asst Div Comdr arrived at our CP to check on the situation and discuss future operations with our S-6. Left at 1115.
- 1130 S-6 1st Bn to S-6: 00 reports we are getting only a limited number of 10 in 1 rations. He directed that all available rations be issued 1st Bn.
- 1230 S-3 sent message to CO Co B of 328th Engr to be at our CP as early this afternoon as possible.
- 1330 Co A reported 13 rounds of mortar fire at 37.0-68.4.
- 1349 G-3 called and wants our liaison officer at Division immediately.
- 1355 S-6 left to visit 1st and 2nd Battalions.
- 1400 Asst Div Comdr visited our CP.
- 1405 G-3 called and wanted to know if we had any reports of any activity around LA BOLLE today. We have had none and informed them of same.
- 1435 S-3 reported to G-3 that situation remained unchanged in our sector.

- 1300 S-3 to Fame 3: The people have moved through us ad have advanced to the river. We shall check for exact advance. Some have reached stream, some entered woods in our E Co area, some on right of Fatima Blue. Quite a bit of enemy arty fire. Smoke this morning was overshot for a while. That was corrected and Fatima 6 called to have it lifted. A request was made for information on Fatima White. Wires were out but we would pass anything we got on to them. S-3 then called White 3 asking for information on FatimaWhite. They are trying to get in touch latest they have is that Fatima George will be 300 yards out in woods. Heavy machine gun fire along the road running along their front. Heavy

0040 S-3 to 2d Bn S-2: 3-3 asked "Your listening post found out that there are two 88's at approximately 404665." S-2 2d 3n replied "Yes, they picked up those guns on a trial. We saw the muzzle flashes and thought they were 88's, but after checking the rate of fire decided they were long 77 SP guns. We called arty fire on the first gun and believe we knocked it out. S-3 "What time was that?" S-2 2d Bn replied he would check his journal and make sure. He stated that about 20 min after that the same OP reported another had moved in down about 200 yds almost due S of that spot into the point by the river and the road where the road crosses the river at 4025-6635. S-3 "That is another 77 there?" S-2 21 Bn "Yes, firing into the left flank of the 411th Inf." 3-3 "Did the 1st one fire?" S-2 2d Bn "Yes, that's the way we spotted it. I checked by the rate of fire that it was a 77 SP. We know we got one hit at about 2210. About 40 min later we fired at the second one." 3-3 "One of your OP's picked up that moving in and after it moved in it began to fire on the N flank zone of the 411 Inf. You get a bead with cadence and dumped arty on it and believe the gun was knocked?" S-2 2d Bn "Yes, we checked with our OP and our forward arty observer. Our forward arty observer is the one who is the most certain we got a hit. This gun attempted to pull out but after the last volley was fired there was no sound of motors running. The other came in twenty minutes later. They then took up firing. Our OP picked that up and they were firing into 411 Inf zone. We are getting a little fire up here right now, about 105 mm stuff. I will try to spot the approx concentration here on the map and give it to you. It seems to be a battery of 3 guns as 12 rounds were fired. It seems to be interdiction fire at 357-6735. It is a minor RJ. They are throwing them in around that. Do you want to follow through on the working party?" S-3 "On this last SP that moved right in about twenty minutes after you finished the artillery concentration. Did they fire on the 411th Infantry Zone?" S-2 2d Bn "We believe that was where it was firing. His muzzle blast was pointing in that direction. We fired on him and he stopped firing and we could hear the sound of heavy motors pulling out. Then here a while ago Lt Hughes called and questioned me about the fire hitting the 411 zone from that direction. It seems logical that they did pull back up that trail. Our visibility is very poor. 3-3 "Was that the OP from which you observed that stuff?" S-2 2d Bn replied "That is one of them. I have three different ones working on this." 3-3 "Have you any others out E or are they all up high?" S-2 2d Bn. "One down in the valley and another up on top of the mountain. I also have one out by the river. S-3 "You have three of them then?" S-2 2d Bn "I have 5 itogether. One on the floor, one up high, one down by the river, our forward arty observer and Phil has a post out there, a listening post." We told them to get us all information in as quickly as possible and we would get this in to Div.

0100 The above message was phoned in to the Div G-2 Section.

I am going to give this to the arty. (G-2 said he would call Div Arty and give it to them).

- 0610 S-3 made overlays of the situation and sent them down by In 0 to all the Bns, the AT Co. On Co is sending an officer to pick them up.
- 0630 Message from our S-4 Plenty of C and K Rations for White and Blue in position and in Bn reserve. Am prepared for change in plan. We can feed either B or C on order.
- 0722 S-6 to 2d Bn S-6 S-6 asked 2d Bn S-6 if he knew when things were due to start. He said he did. 2d Bn was to coordinate with 411 S-6 as to the use of smoke this morning. Visibility poor.

- O743 Div S-5 to S-6 Div S-5 wanted to know if we knew where our boundary between us and 411. We did. Informed them that we had units totaling to about 2 companies not counting heavy weapons in the area between that boundary and our S boundary; one platoon at Les Moitraisses; have some at La Bolle bringing total to about 3 rifle companies: north of there we have the equivalent of one full Bn on line; in reserve we have a company and a half of one Bn plus 3 companies of about 2/3 strength; one rifle company at hill 647 W of La Chenale; S into draw, one rifle company less a platoon; SW at hill 621, one rifle company less 12 platoon; back NE at 363-660 there is a hill with a company less one platoon.

The latest on Fatima, Co F has passed thru Co E. Co E has gone to rear and reverted to reserve. F has pushed on thru in the entire white sector, the enemy activity has been null. In the blue sector, Co K is in approximately same position as last night. In ward to the NE. We have 3 French civilians at 2d Bn OP taken by our F Co. We have just captured 3 more and they confirm the first report.

This is the same spot where we caught the enemy column the other night. We told him we would check with S-6 and get permission for his patrol.
- The Division Commander called 8-6 and instructed him to start vigorous patrolling at once. We are to determine if the pimple at LA BIHAY is occupied and if not to move in. Div. Comdr. says he has received reports that the enemy is pulling out everyplace. We were instructed to find out what is on our side of the MEURTHE RIVER and patrols out from LA BIHAY, LA BOLLE and LA MENANTILE. We are to contact the people on our SOUTH.  He said he was not ble to draw this equipment. The Engineers have all kinds of equipment and we have only A&P engineer equipment. The electrical apparatus for electric caps is organic but it is not available for me to draw. 3d Battalion is jumping the gun. They are requesting these things on two hour notice. All we have to do to get rifles for the AT Company is get approval from Division.

We want to use them to sweep the main supply routes. 3d Bn wanted to know if the Engineers would sweep the road from CHALET EAST, and how much steel wire we could get to pull out booby traps, also how much rope.

- 0800 2d Bn S-3 called S-2 and said that 20 minutes ago our "E" Co. patrol had not contacted the 41lth. They patrolled all around the hill at 2400 last night and saw no one, not even enemy. - 0805 We called G-2 (Sgt Martinez) War Room and gave them the above message (0800)

Div. Comdr wants to send patrols in and take the railroad yards. Also told him of our "E" Co. patrol on the pimple. Told him Engineers were here and were going down to check for a river crossing. They have some good abrial photos. S-6 is checking into the rubber boat situation.
- 0815 Asst S-2 called 2d Bn S-6 and told him S-6 instructs that Sgt Clark and enough witnesses to establish his Silver Star start at once for Regtl CP.
- 0827 Cannon Company CO was in and told us he was all ready to move as soon as he gets orders.
- O833 2d Bn S-3 called our Asst S-2 and said our "E" Company patrol on the pimple had made contact with "F" Company of the 41lth Infantry. We have four squade out there and they will have to remain in position as we have one squad with a LMG set up in a house at a road junction (40.2-60.6) just EAST of LES TIGUS. Due to visibility they will probably remain in position until late this afternoon. "E" Company reports a little artillery fire in their area.
- 0845 Asst S-2 called G-2 Jr and gave him the above information. G-2 Jr told us to keep our eyes on TETE ST. ROOHE for self-propelled guns. He is sure there are some over that way.

S-6 said he would try to het him two rubber boats and two 100 foot pieces of rope. 1st Bn S-5 said that Spitfires were bombing and strafing Krautland over is the 15th Infantry sector. the high ground around SAN MICHEL on the road across the river.
- 0908 5-4 came into our CP.
- 0910 3-6 called CO. "B", 328th Engineers and asked them if they could furnish us rubber boats and rope. They replied that they had 6 or 7 hundred feet of inch rope, but no rubber boats.
- 0915 Division Commander wants S-6 to come to the Advanced Division CP. S-6 is preparing to leave.
- 0920 Fatal Red reports that 0910 12 P-47's strafing and bombing N & E of river at ST MICHEL. Result 2 fires and smoke. Enemy AA very weak.
- 0930 let Bn S-2 to S-2: Bridge at Duviller half out (Kraut side out). They found two light maching guns. Across the river, trucks parked with few Inf. protecting them. Artillery fired at them and both the half track and other truck believed knocked out. Time of firing 0137. Two civilians passed on to 0 Co that the place is full of booby traps and mines. They were not to go in until Division gave their permission.
- 0940 S-6 informs us that they intend to pull out at dusk because they can't go across valley in daylight. They have sketches of mines and are located.

Pulled back to take high ground. 2d Bn reached point at 728740 SW of Reichsfeld SE and pushing out immediately at daylight and continue on mission. 1st Bn takes Itterswiller - 2d Bn takes Reichefeld SE and N of Bernardville. Numerous road blocks and SP's - resistance quite stiff. G Co on individual mission - ended up at Hill 608 at 743751 at 1630. They captured five prisoners in a house. Nine fields near that house. No vehicles can use roads. Tanks of no use. Have no tanks left and only three TD's. Need heavy maintenance for tanks. Medics hard pressed. Only two drivers and two ambulances. Fatima in Barr headed S across our front. We are to look out for them, they are taking main route out of Barr thru Eichhoffen.

- 1704 S-5 informed Fame 3 that Blue Bn was headed into Hohwarth but are still in woods. Fame 6 came to phone and was informed of same and of snipers in woods and of counterattack.

- 0905 S-5 called S-6 3d Bn is at Hohwarth. The enemy is thick around him. Can't use the road at all that he was planning on using. He is getting all set and wants to know what to do. S-6 said if he couldn't move out of Hohwarth he would like to have a Co sent up to him for reserve. S-6 is at 735728.
- 0910 S-6 was connected with 3d Bn Co. 3d Bn Co said he had a rough time of it all day yesterday and most of last night.

- 1012 S-3 called G-3 and gave him the information about German troops on road E out of Andlau. He is going to see if he can get some fire on it. We told him our 2d Bn was around Reichsfeld and that G Co was sitting on the hill overlooking Bernardville.
- 1022 S-6 to S-5 Get the AT CO, including their mine platoon and our I&R up here immediately. They will report to me at RJ 732728.

29 Nov 44 cont'd:

- 1032 S-3 to G-3 "The town of Reichsfeld was taken by 2d Sn at 0930."
- 1040 S-3 called G-3 and was informed that the 411th occupied Andlau at 0330 this morning. Doesn't know whether they were going to push on E from there or not. They didn't have any orders from Div to push on E but they might have done so.
- 1045 S-6 called S-5 "We are receiving a counterattack from direction of Nothalten. I had to pull 2d Bn back to check it. Get M-1's for the AT Co. if it is possible. Also try to get tanks ad TD's for the 3d Bn.
- 1050 S-6 to S-3 "Had to pull the 2d Bn. back to help check this counterattack. B and O are cleaning up. A Co was counterattack from the SE. 1st Bn is taking a beating. We informed S-6 that elements of the 14th Armored Div left Barr this morning and were moving down to Eichhoffen. S-6 told us to tell Div that if the 14th could get down and clean out those towns they would find plenty of enemy stuff.
- 1100 S-3 to G-3 "1st Bn on hill at 765737. They have been receiving the most terrific kind of fire up there. It is so bad that the A Co Comdr is now tied down to a stretcher in the aid station. They are getting a counterattack from the SE from Nothalten. We have pulled our 2d Bn back to aid in stopping this counterattack. They are swinging down to 75-72 grid square Hill 372. Our AT Co and our I & R platoon is at 732728." G-3 informed us that St Maurice had been taken at noon without trouble. Still working on the town of Dieffenbach.
- 1344 S-3 to Blue 1: Fatimahas 1 Bn at Barr, another at Andlau. Fancy cleared St Maurice with White Bn and striking down to Thanville. Our B Co is in woods out of Itterswiller, C Co in woods S of Bernardsville, G Co in Reichsfeld, A Co at 751731, remainder of 2d Bn at 745727 pulled down to asist in thwarting counterattack from Nothalten.
- 1416 S-3 to Blue 6: Informed him that tanks just passed through Ville.
 L Co is at first RJ and where they are set I Co will go on to
 second RJ. They had just knocked out an enemy stillery battery.
- 1424 S-6 informed of Blue 6 situation and Fancy situation. He didn't agree to allow 3d Bn knock out anyone who might be in St Pierre Beis, said that was Fancy's job. Thought if might be suggested to Fancy to relieve remaining eleme nts of 3d Bn left at Hohwarth. The situation of 1st Bn as follows: C Co on high ground on N but can't help B Co, A on SE but can't help B, B Co practically surrounded.
- 1430 S-3 passed on 1424 entry to Fancy.
- 1450 3 Tanks going MW of Epfig, checking to see if they might be ours before firing on them. Fatima to be notified of this.
- 1515 Blue 6 informed of lat Bn situation and instructed to forget about St Pierre Beis.
- 1525 Received message from 3gt Drauden as follow: The six (6) 2 ton trucks alerted last night are no longer alerted. Movement.
- 1540 S-3 to S-6: Blue Bn of Fatima aBarr, Red and White at Andlau, have been given mission to take Eichhoffen and St Pierre. Our L and I Co's in their respective positions, both assigned two tanks, On Co in position shooting ith artillery. Fancy White Bn marching on Thanville. Blue in Dieffenbach. 36th reported to have a combat force (at 1100) at 71064, other elements clearing woods at that S-6 says white Bn is tking high ground M of Nethalten and Baker Co still in trouble.

- 1602 Fancy 3 to S-5: We are sending a company cross country from St. Maurice to St Pierre Beis. We gwe him our 3d Bn setup.
- 1610 S-5 to 3d Bn 6: Passed on 1602 entry. He informed us that they ran into a road block at RJ and that next RJ was being dvanced on. They have hd a little artillery fire.
- 1710 The Fame office informed us that it is entirely possible that German armor may be used against us and everybody should be warned to have AT weapons on the alert at all times.
- 1730 S-6 called S-5 and wants 2 ambulances, 2 doctors, blankets and dressings sent up to 1st Bn aid staion at once. If necessary go 11 the way back to Fame to get them. One platoon of B Co has only 8 men left.
- 1735 Corps wants to run air missions over Epfig and Dieffentha tomorrow.
- 1755 S-3 to Forward S-3: 409th occurried St Pierre Beis without a fight, also took St Maurice, were going to atack Thanville in the morning. 411th 1st and 2d Bn hwe moved out of Andlau N toward Eichhoffen but haven't gotten far. Our situation no change in Blue, C Co went through B, 2d Bn minus G Co started its movement, pased the S flank of the 1st Bn at RJ 746 726 NE of Nethalten. Leading elements arrived at a point about on the 75 grid line at a point just E of that road jet. They are holding here they are. Ran into a lot of artillery there. B Co lost all but 8 men in one platoon. Just get a mag from 2d Sn and they are digging in on the 75 grid suare. Ocrps is planning an air mission on Epfig and Dambach during the morning. They want to make sure that our troops me far enough away.
- 1800 Blankets and supplies, 2 Medical officers, and one ambulance were dispatched to 1st Bn aid staion.
- 1832 Informed S-6 of 1800 entry. He said they needed more ambulances.
 2d Bn Ln O said there were three ambulances on way there.
- 1846 S-3 to 3dBn 6: 2d Bn's southernmost bdry is at 750721 so it's CK to put fire up to the RJ. We would check with 2d Bn however.

29 Nov 44 cont'd:

Location of Headquarters Ville, France

- 1850 S-5 to 2d Bn 6: 2d Bn was informed that enemy countertack drove back I and L Co holding FJ's at following coordinates had I at 744719 and L at 758717. Either 2 tanks or SP's were there. They have pulled back to other side of woods at 728715 and are there now. They estimated their position at about 747722 and said it would be all right anywhere S of the 72 grid line running across for arty fire to be laid.
- 1945 E Co had just been counterattack.
- 2002 Informed S-6 that it would be safe to fire from RJ 357 to Blienschwiller. S-3 suggested that it was almost imperative that 3d Bn reoccupy those two RJ or almost anything could come up the road. S-6 was thinking of moving 3d Bn up near him to be used in morning and help against counterattack. S-3 informed him that 409th had taken Thanville and St Pierre Bois. S-6 gave permission for arty to be fired.
- 2030 Informed 3d Bn 6 that it was OK to fire below 72 grid and E of 73 grid. Informed him of the counterattack that E Co threw off. Informed him of 2002 entry and he informed us of a counterattack he just had and was expecting another, said they came from direction of St Pierre Bois.
- 2040 Informed 3-6 of 2030 entry. He said fire had not started as yet.
- 2100 S-3 called 2d Sn 6 and found out that Corps arty fire was falling in their area. We would call S-6 on it.
- 2105 S-5 to S-3 forward: Informed him of 2100 entry. Forward said he would have 2d Bn 6 check to make sure about it would check with Company Cmdrs. Forward says Krauts have fired on several occasions the same time we did to/us the impression that we were firing on our own troops.
- 2120 Ln O reported road blocks at RJ where 3d Bn was supposed to be. We informed him that 3d Bn was pushed back from there.
- 2128 We informed 3d Bn 6 that there were no Fancy troops in those woods and he said they were going to fire into them.

- 2150 3d Bn 6 informed us upon inquiring that the tanks were in that span mentioned in 2143 entry. He said 8" or better needed to do any harm to tanks.
- 2214 3d Bn 6 informed us he was going to fire into Hill N of first RJ.
- 2316 Fame 6 called and informed us that we must take care of our S flank and to get the 3d Bn companies back into position. He said he would try to get us help from the N. He said we would probably get some of them. We said 3d Bn sure could use some of them.

- 0015 Fame 3 informed of 0050 entry. Also given general situation.
- 0130 Fatal 3 to Red 3: Bazooka team being sent to take care of these two tanks in 0 Co CP. Captured all our personnel in CP.
- 0335 Fame to 3-3: OI coming out to be delivered to Advance CP. They want vehicle to lead them to the Advance CP.
- 0450 OI from Div brought in. Copy made of OI and Liaison officer took i took to Fatal Advance.
- 0505 Fatal lue notified that in CI they are to maintain present position until relieved by 409th ad will be released by Div Order.

39 Nov 44 cont'd:

- 0525 Fame 3 to S-3: Given general situation. Asked about 0 Co of being captured.
- 0600 Ln O reached Fatal Advance with CI at o600.
- 0943 3d Bn 1 to 8-3: Captured some Krauts in Barrurs who say that there are still 70 Krauts and 6 Lts. in the high ground up there. All they have is personal weapons and about 6 hand grenades. Sending prisoners to our Interrogation Officer.
- 0958 Fanny called and wanted to know how many litter bearers we needed. S-5 said we lost about 14 so it was agreed that we would need that many or more. Fanny was to check with Army on it.
- 1008 S-6 informed S-3 of this plan: 2d Bn would take Nothalten, then when Fatima comes to left flank, the 1st Bn will take Itterswiller. Important thing is to make sure that we have an officer with Fancy's left flank when they come up on our right so that he en report to our 6 where left flank is. This officer is to be there physically and follow their left flank at all times and report by 284 radio. S-6 wants knowledge not guess. 2d Bn will take
- 1017 Fancy informed of this. (1008 entry). He said it was CKwith him.
- 1040 Lt Hughes was taken to Facy as contact officer by 3-3. S-3 then going to 3d bn to orient them.
- 1053 S-6 to S-5: Informed us that they were jumping off at 1100. Also said that a truckload of prisoners (10) was being sent back here when they contacted 3 of our men ho were sheltering themselves from clear woods round there so their supply road will be see. S-6 wants us to check Fame on that.
- 1057 Informed Fame 3 of 1053 entry. He said we could use K Oo but not to move rest of 3d 3n until they had OK'd it.
- 1100 From Fame 3: Ammunition in prior to 1200. Advise as to check on marking front lines with smoke and panels (yalow). 3-2 gave this information to S-3 at 1110.
- 1102 Informed 3d En 6 of what we planned t do with K Co and that we were going to use On Co transportation to pick them up at Hohwarth to take them to Fatal Forward. S-3 informed S-5 that Lt Hughes was all set with the 409th and we should let Forward know.

30 Nov 44 cont'd:

- 1112 S-5 informed Forward S-5 of 1102 entry.
- 1132 3d Bn informed us that 409th jumped off at 1100.
- 1143 Fame 2 informed us that Epfig and Dambach are fire missions today if planes are not grounded. This passed on to S-2 forward.
- 1152 Tanks wanted to verify position of tank needing maintenance. They had 701724 which was correct.
- 1157 3-5 found out from 3d Bn that K Co men were on trucks and coming back.
- 1159 Fatal Forward informed us that they had not received their rations and we should send them immediately.
- 1217 Div 2 to S-2: 14th Armored cutfit got counterattack in vic of Mittlebergheim from Eichhoffen approx a Bn unloaded there. 411th 3d Bn closing LD, getting a little small arms fire.
- 1222 S-2 passed on 1217 entry to S-2 forward.
- 1220 G-2 called and wants us to expedite our PW's back to Div just as quickly as possible. Wanted to know about the Kraut raid on "O" Co CP.
- 1240 G-3 called and wanted news on our situation. We had nothing new to give to him.
- 1242 S-5 to Forward S-3: We know 2d Bn must be on the move, lst is the same place they were, 2d Bn has moved forward. They were to occupy first town, lst Bn was not to move before that time.
- 1250 Informed G-3 that 2d Bn had moved out but we were out of contact with them and as yet let Bn had not moved.
- 1330 S-3 to S-5: S-3 Forward wants us to get thru to 409 and find out where they are. Informed them that we can have 3d Bn now. We were to shuttle companies up to where they were and in the next shuttle heavy weapons were to be taken. They informed us that RJ at 74-72 shelled badly and heavy weapons would have to be hand carry.
- 1332 S-3 to S-2: 409th left flank now at 750711. 2d Bn has taken hill 393. Getting lot of small arms fire.

30 Nov 44 cont'd:

- 1340 Ln C reports that 36th leading elements at 3 end of gap going left along woods; the RJ we are concerned about is still in enemy hands. Gave him our situation.
- 1310 S-2 called our advance CP and was informed that 2d Bn had reached hill 393. Received lots of small arms fire taking the hill. We lost two H Co vehicles at a road junction in the 75-73 grid square as German 88's got direct hits on them. 1st Bn is going to hold off for a while until the 2d Bn takes their objective. Advance CP wants us to get the positions of the flanks of the 409th and the 411th and get them to him as soon as possible.
- 1320 S-3 called G-3 and gave him the above message. G-3 said that the Div Comdr had taken the strings off our 3d Bn and we could move them as we chose. We told him our 1st Bn was not going to move until the 2d Bn had taken Nothalten.
 - 1345 S-5 informed On Co OO we were going to use his trucks to shuttle all of 3d Bn and that he give them help to see that all troops are moved.
 - 1347 S-5 to Blue 6: You will move all of your unit bak were I Co went. Weapons to go dong with the next shuttle if possible.
 - 1357 S-3 Forward instructed us to contact Engineers Co Comdr and have him send rations for one day to the 43 men up there. They have rations thru dinner today only. They are working back near Albe and the rations should be taken to the truck there.
 - 1412 Gave Fame 3 situation as follows: As of 1300 2d Bn attacking in S zone reac ed hill 393. Krauts have RJ 392 zeroed in. 409th at 748716 at 1300, we sent back our position to them. Our plan of maneuver given to Fame 3. Shuttling K Co. 1st Bn not going to move till 2d 3n has Nothalten.
 - 1420 Informed Fancy (409) that at 1305 we hd hill 393 and are receiving a lot of small arms fire. 409 would hold back till we heard more about 2d Bn.
 - 1452 Fame 6 to S-5: Wanted to know why we are holding up let Bn. Teld him we had moved K Co. He said to move the rest of them cross country and have to move fast. We should get B Co a good CO and keep them moving. Keep 3d Bn together and don't scatter them. Stressed 'get going'.

- 1457 S-5 to S-3 Forward: Fame 6 wants rest of 3d Bn moved coss country on foot. He didn't think the 2d Bn should havegone into Nothinten should have been 1t Bn. We should moce forward and catch up ith the other Regiments who are already at phase line A. S-6 told S-5 to have 3d Bn take Blienschwiller.
- 1510 S-2 to Forward: At 1450 Divarty reports air recon shows much civilian and military activity in Nothalten.
- 1511 Fame 3 to S-2: A report from 411 puts them passed phas line A.
 46th Armored Bn coming down to Blienschwiller, we ca follow them
 through.
- 1513 S-2 informed forward of 1511 entry.
- 1516 In C reports that at 1410 411 at Phaseline A and getting small arms and artillery fire.
- 1528 From Blue 6: We got orders to take Blienschwiller. What about tanks ad TD's? We knew nothing about them.
- 1557 409th wants to know if we have any troops at Blienschwiller, they want to fire there. We'll cal back.
- 1559 On Co CO informed by S-5 that the shuttling was called off ad he could have his trucks bak.
- 1600 We found out that we have no troops at Blienschwiller. Informed us that 2d Bn was 400 yerds from Nothalten but are drawing fire. 1st Bn seen Krauts running out of there. Forward wanted rest of 3d shuttled up.
- 1602 S-3 informed 409 2 we have no troops at Blienschwiller.
- 1612 S-5 informed G-3 of 2d Bn being 400 yards from Nothaltn.
- 1615 3d Bn 6 informed of 1600 report on 2d Bn.
- 1635 3d Bn 6 informed us that RJ at Wiederhardt had fire fight going on there between TD's and Krauts. Informed him that the trucks he was to use were back at Cn Oo.
- 1642 S-3 informed S-6 of 1635 entry. S-6 says he must have rest of 3d Bn up at his CP tonight. K Co suggests riding trucks to Albe then walk.

30 Nov 44 cont'd:

- 1645 Lt Hughes informed us that he was back at Hohwarth but was with 409 till 1515. Informed us that the opposition 409th had met so far was just small arms fire. He was told to stay at 3d Bn CP.
- 1705 S-3 to S-3 Forward: Upon inquiring, S-3 forward informed that the remainder of 3d Bn less I Co was to get to forward CP anyway 3d Bn 6 thought best. Also informed us that Lt Hughes' job was done and could return to the CP.
- 1710 Div Comdr called S-5 and told us to get our 3d Bn out of the 409th area and to get it out tonight. He said we were to use our tanks and infantry together.
- 1710 S-3 talked to the 3d Bn CO and they are planning the movement of his Bn as quickly as possible. 3d Bn CO said it would take his 6 hours if he had to shuttle his troops and close into his new area. I Co is being left to move on Blienschwiller. On Co vehicles are going to be used to shuttle 3d Bn troops.
- 1720 S-3 called K Co CO and wants him to pick out an area for the 3d Bn and a CP, also have guides at Albe to guide the troops up to the new area. K Co CO said he would take care of it.
- 1740 S-3 called Adv CP and talked to our S-3 up there. Told him that On Co was going to support I Co on their adv on Blienschwiller. Told him that 3d Bn CO wanted K Co CO to pick out a motor park for his organics up there. Adv S-3 said there were no motor parks available for anyone up there.
- 1750 S-3 called 3d Bn CC and told him that the Regt'l Comdr would like to have him and anyone he chose to bring along up to the Adv CP as soon as possible. Told him they were sending an I & R jeep to Albe to meet him, and he could have his S-5 lead the Bn up. We asked him if the road that leads from the Adv CP E and then S to 744719 RJ is clear and if it is clear over W to where the road block was just fixed. 3d Sn CO didn't know but said he would find out. Said he had just received a report that the road was clear for 4 miles from Hohwarth but the report is unconfirmed.
- 1755 S-3 called Adv S-3 and gave him the above message about the read.
 ADV S-3 did say the IAR jeep had just left for Albe to meet 3d 3n 00.

- 1812 S-3 called Adv S-3 and told him of above message. He is going to check and call us back. He said there was no motor park for the . 3d Bn in that area and the Regtl Comdr said they should leave their organics at Albe.
- 1845 S-3 called 409th S-5 and told him our people around Nothelten have heard some track vehicles but don't know what they are at all. Also told him that our 2d Bn which was moving on Nothelten was about 300 yds from the town and dug in for the night, that our I Co was moving on Blienschwiller and our lat Bn was around Itterswiller.
- 1848 S-3 called 3d Bn S-3 and told him that he couldn't get his orgaic motors into his new area and that S-6 suggested they leave them at Albe. They are going to start moving very shortly.
- 1850 S-3 called On Co CO and told him that as long as he was tied in with the arty it would be OK to stay where he was. He reported that he had just had word that the relay radio team was getting set up to
- 1910 Report received that the 1st Bn captured Itterswiller at 1830.
- 1912 3-5 called Div and gave them the above message.
- 1930 S-3 called 3d Bn S-5 and told him that the 41lth Inf at 1600 was on the outskirts of Epfig. They had their 3d Bn there. About 900 yds to W and slightly to the N was their lat Bn. Their 2d Bn is in reserve. Told him our lat Bn had taken Itterswiller at 1830, that our 2d Bn.ran into a lot of fire and were now dug in about 300 yds W of Nothalten, 3d Bn was heading up in the vicinity of our Adv CP. about 4000 yds E same spot it was in Dieffenbach occupying road blocks and outposts St Pierre Bois.

- 1935 S-3 called 3d Bn S-5 and they reported they would be ready to move in about 10 minutes. We told them we would have someone in Albe to guide them up to their area.
- 1940 S-3 called Adv S-3 and told him that 3d Bn would be on the way in 5 minutes. Adv S-3 said he would get guides down to Albe to meet them. They have seen nothing of the 14th armored outfit up there. 3d Bn s-6 hasn't arrived up there as yet.
- 1955 3d Bn moved from the Vic of Hohwarth.
- 2000 8-2 called forward S-2 and gave him the situation as we have it now. Forward S-2 told us there was a bridge mined and ready to be blown at 795683. It is out in front of Dambach la Ville.
- 2030 Report that elements of the 14th Armored Div re at 775742 N of Itterawiller. The 411 Inf 3d Bn is in Epfig.
- 2032 S-3 called Forward S-3 and told him of the above message. 3-2 requests that we try to contact these elements of the 14th armored and they will also try to contact us. They me going to work with us in the morning.
- 2040 On Co says they can't get any communication from I Co with their radio relay team.
- 2045 G-3 called S-3 and told him that elements of the 14th Armored Div were at a RJ NW of Itterswiller at 771744. They are sending out a patrol to contact us.
- 2045 S-3 called Adv S-2 and gave them the above message. Told him to try to get a patrol out from lat Bn to contact these people. Forward S-2 reports that I Co is running into a lot of trouble on their objective in the form of small arms fire, 20 mm fire, and schu-mines.
- 2110 S-3 called G-3 and told him that our I Go ran into a lot of schu-mines and small arms fire in the woods from their objective. Can't give them the location because we don't know ourselves, but we think it is about 1000 yds W of Blienschwiller. They are ordered to hold up tonight and in the morning swing in from enother angle.

30 Nov 44 cont'd:

- 2125 S-2 called S-2 forward and our Forward S-2 informed us that Patterson, the radio chief for the 2d Bn had been missing since last night and it is feared that he has got captured. He had the map coordinate code and several other codes on his person and we are to call G-2 and inform them of this fact.
- 2130 S-2 called G-2 and gave him the above message about the missing radio chief. Also said that we were very worried about the Hill Mass Foret Dambach to our S and we informed G-2 of this fact. He says that 409 would have that well under control, but we think they have moved in too fast and haven't combed it and that it is still full of Krauts.
- 2155 Cannon Co Co called S-3 and told him he hd been firing missions for I Co for the last 1/2 hour and that I Co had report lots of Krauts, wagons, and some 20mm guns running around the town. I Co Co came on the phone at that moment and wanted to know the situation. He was under the impression that his battalion was behing him with TD's and Tanks, but they aren't. He wants the situation straightened out. Says there is a road block 200 yds from the town and that MG's and snipers are holding it. On Co Co reports enemy MG's behing I Co about a mile down the road from Hohwarth. I Co says there re anywhere from 20 to 150 Krauts in the twon and a 20 mm gun. We told I Co Cmdr we would call S-6 and get the situation straightened out.
- 2220 S-3 called S-6 to the Adv CP and gave him the msg from I Co. S-6 said that Div had given orders that we would take this town by tomorrow but if was OK for I Co to wait until morning to take it. S-6 said 3d B n CO was going to communicate with I Co CO and tell him what to do. Gave him the message that S-2 just gave us a PW reports that the 728th Inf Regt and the 658 FA Regt had CP's in Blienschwiller yesterday afternoon, and it is reasonable to assume that they are still in the town. This PW had been on a recon just before he was captured and the Jerries know we have Fill 393.
- 2240 S-3 called 1st Bn and told him where the 14th armored elements were and if we had contacted them as yet. Opl Smith didn't know, but he is going to check with his Adv OP and will call us back and let us know.
- 2250 3d Bn Operations Sergeant Grooms called and we gave him the situation.

30 Nov 44 cont'd:

- 2300 1st Bn (Cpl Smith) called and says we have established contact with elements of the 14th armored (isn't going to move till daylight). Contact was made at 2250 just a little NE of where we thought they were.
- 2302 S-3 called S-6 and gave him the above message. S-6 says Colonel May talked to I Co CO and had made arrangements for I Co to stay where they were tonight and go into the town tomorrow. 3d Bn just closed into their new area in the vic of our dv CP.
- 2306 On Co called and had I Co CO on the wier. I Co said they now had a patrol out to see what damage Cn had done to the road block in front of them. Said they weren't going into the town until the morning. They seem to think they are surrounded by Jerries up there, and have no observation into the town at all. Their patrol returned because they couldn't get through, but discovered another road block closer to the town which was covered by snipers and they drew fire from these snipers. I Co is going to pull back 500 or 600 yds from the town and dig in for the night. On Co is going to cover the movement of some AT guns with interdiction fire on the road block. On To has already thrown 200 shells into this road block, but they don't have observation on it. On wants to throw some white phosphorous shells into the town and burn it up, but doesn't have observation on it. However they can cover I Do with a curtain of fire in case Jerry counterattacks during the night. We gave I @ 00 the information about the two enemy OP's in the town. On Co threw fire at the road block to cover movement back at 2320.
