General Orders No 11, Hq 103d Inf Div (cont'd)

2. During days or half days of individual or technical training in close-in areas, troops will normally arrive in Company street promptly at recall. Small unit field exercises should not be hurried but if additional time is desired for AM exercises, reveille, mess and AM drill call for the day in question should be advanced rather than run over recall. Recall may be disregarded for afternoon or all day field exercises and participating troops excused from retreat but not from weapons clean-up.

3. The Division Artillery Commander and Commanding Officers of Infantry Regiments will be responsible for sounding calls within their respective areas.

4. The Commanding Officer, 328th Engr Bn will run a roster of all buglers in the 328th Engr Bn, 328th Med Bn, 103d Rcn Tr, 103d QM Co, and 803d Ord Co, and provide for the appropriate sounding of service calls in the areas occupied by those units and organizations.


5. The Commanding Officer, Separate Battalion, will provide for the sounding of service calls in the areas of the Division Headquarters Company and the 103d Signal Company.

6. Commanding Officers responsible for sounding service calls will insure daily synchronization of time between the hours of 1600 and 1700 with Division Message Center. The Division Signal Officer will provide the Division Message Center with means for synchronizing its time-piece between the hours of 1530 and 1600.
