I -- AWARD OF ENORGE STAR MEDAL. Under the provisions of army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded following named individuals:

Technician Fifth Grade Jos D. Ramirez, 34789216, (then Private First Class), Medical Department, Medical Detachment, 41th Infantry Regiment. For heroism in action. On 16 November 1944, in the vicinity of \* \* \*, Prance, Technician Hamirez, aid man attached to Company "E", worked tirelessly day and night in order to render aid and evacuate the wounded. The area in which he worked was under constant enemy metillery, mortar and small arms fire, but he continued on completely oblivious of the withering fire. The utter disregard for his life, he braved the fire-swept terrain again and again to attend his wounded conrades. Even though it was necessary in one instance to cross an icy stream he pushed on relentlessly. Technician Ramirez's heroic efforts were instrumental in saving the lives of many of his conrades and rendering first aid a minumerable others. Residence:
Bay Harbor, Florida.

Private First Class Matthew P. Anderson, 31316521, Infontry, Company " "G", 409th Infantry Regiment. For heroism in action. During the daylight hours of 21 December 1944, in the vicinity of \* \* \* \*, Germany, Private Anderson, with one other courade, went forward on his own initiative, to capture an enemy strongpoint which was holding up his company's advance. This mission had to be accomplished in direct observation of the enemy who were fully aware of the impending assault. His path was swept by a mirderous barrage of enemy small arms and mortar fire but he courageously and boldly continued on his mission undetered. Because of the immense size of the fortification he carried a 20 pound pole charge of TNT to assist him in blasting the position. Although protective cover was available he disregarded it entirely and pushed relentlessly toward the accomplishment of his mission. In the face of devastating fire he and his corrade skillfully placed the charge, resulting is the complete destruction of the enemy embrasure. As the smoke cleared from the blast, 15 of the enemy dashed from the enclosure and surrendered. As a result of Private Anderson's outstanding valor and utter disregard for his life, the attacking troops were able to advance successfully toward their objective. Residence: Test Haven, Connecticut.

Private Alvin Gelbe, 12192667, Medical Department, Medical Detachment, Allth Infantry Regiment. For heroism in action. During the period 19th to 20th December 1944, in the vicinity of \*\* \* \*, Germany, Private Golbe, medical aid man attached to the Second Battalion, braved withering enemy fire night and day to render aid and assist in the evacuation of the wounded. On many occasions it was necessary to carry the wounded down a steep mountain slope on his back as the use of litters was impossible. He worked tirelessly and efficiently rendering all possible aid until he dropped from sheer exhaustion. Refusing evacuation, he rested but a few moments and again went courageously forward to be of assistance wherever it was deemed necessary. In one instance he administered blood plasma to a seriously wounded comrade under intense enemy fire and in complete blackout. Private Golbe's devotion to duty and utter disregard for his life, resulted in his saving the lives of many of his comrades and served as a source of inspiration to all. Residence: Brooklyn, New York.

Private First Class John J. Killilea, 31254552, Infantry, Company "A", 411th Infantry Regiment. For heroism in action. During the daylight hours of 10 December 1944, in the vicinity of \* \* \* \*, France, Private Killilea, was pinned to the ground by intense enemy machine gun and sniper fire. Observing his platoon sergeant lying wounded in an exposed position, he, with utter disregard for his life dashed from his place of safety over 200 yards of fire-swept terrain to the side of the wounded man. Although withering fire raked the area where he stood, he carefully tied the wounded man's hands together, placed them around his neck and dragged him to safety. As a result of Private Killilea's outstanding courage his injured commade was removed from an extremely dangerous position and professional medical attention was rendered efficiently and expeditiously. Residence: Wallaston, lessachusetts.

Staff Sergeant Donald O. Enclander, 36411790, Infantry, Company "B", Allth Infantry Regiment. For heroism in action. On 13 December 1944, in the vicinity of \* \* \* \*, France, Sergeant Enclander, with his platoon in the attack was warned of an impending counter-attack by enemy tanks. He quickly and skillfully deployed his plateon as a covering force while he fearlessly went forward with his bazooka. Lurking in the shadows of a nearby house he observed a tank approaching on the road. When the tank was approximately 40 yards from him he opened fire forcing it from the road with a direct hit. Despite the fact that the tank continued firing on his position he exposed himself to signal his platoon to open fire, resulting in the tank's complete neutralization due to the superbly directed cross-fire. Observing a second tank approaching from behind, he again skillfully directed fire on it with his bazocka forcing it to stop. This brilliant delaying action enabled a tank destroyer group to come forward, ultimately repulsing the counter-attack and forcing the enemy tanks to withdraw. Residence: Hudsonville, Michigan.

Sergeant Gordon F. Robinson, 36548763, Infantry, Company "L", 409th Infantry Regiment. For heroism in action. During the moonlight night of 26 November 1944, in the village of \* \* \* \*, France, Sergeant Robinson, and his company were attacking the village when a command fell seriously wounded

by enemy small arms fire. Sergeant Robinson's display of outstanding courage in the face of severe enemy fire was an inspiration to all. Residence: Plymouth, Michigan.

Private First Class Robert M. Ord, 39467039, Infantry, Company "I", 409th Infantry Regiment. For heroism in action. During the monlight night of 26 November 1944, in the village of \* \* \*, France, Private Ord, and his company were attacking the village when a comrade fell seriously wounded by enemy small arms fire. Although the area in which his injured comrade was lying, was subjected to intense enemy fire, he, and another comrade, fear-lossly advanced forward to aid the wounded soldier. Disregarding the bullets that raked his path he courageously continued on and successfully reached his wounded comrade, and succeeded in moving him to the safety of a sheltered doorway. Private Ord's display of outstanding courage in the face of severe enemy fire was an inspiration to all. Residence: Baker, Oregon.

Private First Class Hercus 2. Connelly, 37420155, Infantry, Company "G" 409th Infantry Regiment. For heroism in action. During the daylight hours of 21 December 1944, in the vicinity of \* \* \*, Germany, Private Connelly, with one other comrade, went forward on his own initiative, to capture an enemy strongpoint which was holding up his company's advance. This mission had to be accomplished in direct observation of the enemy who were fully aware of the impending asscult. His path was swept by a murderous barrage of enemy small arms and mortar fire but he courageously and boldly continued on his mission undetered. Because of the immense size of the fortification he carried a 20 pound pole charge of TWT to assist him in blasting the position. Although protective cover was available he disregarded it entirely and pushed relentlessly toward the accomplishment of his mission. In the face of devastating fire he and his courade skillfully placed the charge, resulting in the complete destruction of the enemy embrasure. As the smoke cleared from the blast, 15 of the enemy dashed from the enclosure and surrendered. Corporal Francis X. Bosch, 32486545, Infantry, Company "B", 409th Infantry Regiment. For heroism in action. During the daylight hours of 15 December 1944, in the vicinity of \* \* \*, France, Corporal Bosch, observed soveral wounded men lying in an exposed position on a hill in direct line of enemy fire. Realizing the precarious position of his wounded conrades, he, with utter disregard for his life dashed fearlessly up the fire-swept hill to give aid and assistance. He braved the devastating fire many times rushing up and down the hill carrying the men to shelter. In one instance a shell landed nearby, striking the man when he was carrying. This did not deter him a moment as he pushed relentlessly on. As a result of Corporal

Bosch's magnificent valor the lives of many of his conrades were saved. Residence: Camden, New Jersey.

Private Roy J. Williams, 38495296, Medical Department, Medical Detachment, 409th Infantry Regiment. For heroism in action. On 26 November 1944, in the vicinity of \* \* \*, France, Private Williams an aid man, was advancing through open terrain with Company "L", when they were subjected to a murderous concentration of enemy artillery fire. Observing a comrade severely wounded and unable to reach cover, Private Williams, with utter disregard for his safety, fearlessly advanced through shell-raked terrain to the side of his injured comrade. Despite the harassing conditions about him he coolly and expeditiously rendered first aid. So severe was the enemy barrage that his comrade was wounded a second time as he prepared to evacuate him. Unswerved by this action he successfully brought the wounded man from his exposed position to safety. Residence: Walker, Louisiana.

Staff Sergeant Sigmund M. Cieszkowski, 36549230, Infantry, Company "B", Allth Infantry Regiment. For heroism in action. During the daylight hours of 19 December 1944, in the vicinity of \* \* \*, France, Sergeant Cieszkowski, was pinned to the ground by intense enemy machine gun fire. Observing his company commander lying wounded in an exposed position, he, with utter disregard for his life, dashed to the side of the injured man. While bullets raked the area where he stood, he efficiently and expeditiously administered first aid. When all possible aid had been rendered he boldly picked up the injured man and carried him across the fire-swept terrain to safety. As a result of Sergeant Cieszkowski's outstanding courage the wounded man was removed from a precarious position and professional medical attention was made possible. Residence: Detroit, Michigan.

Private First Class Conrad A. Herrmann, 32963711, Infantry, Company "E", Allth Infantry Regiment. For heroism in action. During the daylight hours of 20 December 1944, in the vicinity of \* \* \*, Germany, Private Herrmann, observed a driver forced to abandon his vehicle due to a terrific enemy artillery barrage falling in the immediate area. Realizing the valuable vehicle would suffer a direct hit unless immediate action was taken, he, with utter disregard for his life dashed boldly from his place of safety to rescue the exposed vehicle. Fully cognizant of the extreme danger confronting him, he jumped into the vehicle and a hail of devastating fire and drove it to safety. Residence: Glendale, New York.

Technician Fifth Grade Urban J. Henning, 37326692, Infantry, Headquarters Company, 411th Infantry Regiment. For heroism in action. During the daylight hours of 16 December 1944, in the vicinity of \* \* \*, France, Technician Henning was in charge of a wire crew laying wire for the regimental command post to the regimental observation post when he and his men were caught in an intense enemy barrage of mortar and small arms fire. Quickly dashing back to his vehicle, he, with utter disregard for his life, boldly drove through the hail of enemy fire, stringing the wire as he drove. Undemuted by the fact that mine sweepers had not cleared the read, he drove courageously on for three miles although hostile fire raked his path for half

the way. As a result of his valorous act, Technician Henning not only enabled his command post to know when the leading elements of attack crossed into Germany, but also enabled his regiment to keep uninterrupted contact with the forward companies. Residence: Belgrade, Minnesota.

Private First Class Edward F. Shepard, Jr., 33789415, Medical Department, Medical Detachment, Allth Infantry Regiment. For heroism in action. During the daylight hours of 15 December 1944, in the vicinity of \* \* \*, France, Private Shepard, medical aid man attached to Company "F", worked tirelessly throughout the day to render aid and evacuate the wounded. Repeatedly he exposed himself to the devastating and concentrated fire of the enemy. He aided his company until all wounded men had been evacuated and then, on his cwn initiative, assisted an adjacent unit in need of medical help. With utter disregard for his life he couragequally carried many of his wounded comrades to safety in the face of withering enemy fire. As a result of Private Shepard's indefatigable efforts and outstanding courage the lives of many of his courages were saved. Residence: Chester, Pennsylvania.

Technician Fifth Grade Herbert Y. Gill, 38468487, Infantry, Company "G", 411th Infantry Regiment. For heroism in action. During the twilight hours of 18 December 1944, in the vicinity of \* \* \*, Germany, Technician Gill, automatic rifleman, was painfully wounded while assisting in the repulsion of an enemy counter-attack. Having observed the source of enemy fire he directed, his assistant to take over his gun and crawled back in search of his plateon leader to give him the vital information. With utter disregard for his life and despite his excruciating pain he courageously crawled over the hilly terrain in the face of enemy fire. Having located his plateon leader he divulged the location of the enemy position and not until he was assured that the plans had been formulated for its neutralization would he submit to evacuation. Residence: Poteau, Oklahoma.

Private First Class Edward P. Levenian, 19205440, Infantry, Company "M", AlOth Infantry Regiment. For heroism in action. During the daylight hours of 3 December 1944, in the vicinity of \* \* \*, France, a heavy machine gun was placed in a position to protect the flank of the battalion from enemy grazing fire. Private Levenian stayed at his exposed position throughout the day to return intense enemy small arms fire without the protection of supporting riflemen. He pinned the enemy down by a hail of fire thus preventing the enemy from setting up their mortars. Private Levenian's effective fire held the enemy down until artillery fire neutralized the hostile emplacements. Leter in the day, he again laid a cover of fire enabling a friendly patrol to escape from an isolated house to safety. As a result of his valor, the battalion was secure and a friendly patrol safely returned to its lines. Rosidence: Los Angeles, California.

Private Henry A. Tucker, 34789256, Infantry, Company "G", 411th Infantry Regiment. For heroism in action. During the daylight hours of 18 December 1944, in the vicinity of \* \* \*, Germany, Private Tucker and his company were pinned to the ground by intense enemy small arms fire from a hostile pill-box. Observing heavy casualties being inflicted on his compades,

he advanced forward with his bazooka, and, with utter disregard for his life, crawled to an exposed position with 40 yards of the hostile emplacement. He fired his bazooka scoring a direct hit which greatly reduced the fire emanating from the enemy strongpoint. Unswerved by the hail of fire about him, he advanced to a machine gun nest on which he again skillfully secred a direct hit, to completely wipe it out. As a result of his valorous actions, two enemy positions were neutralized, thus preventing heavier casualties among his comrades. Residence: Homeland, Florida.

Technician Fourth Grade Robert J. Caskey, 6292905, (then Technician Pifth Grade), Medical Department, Medical Detachment, 409th Infantry Regiment. For heroism in action. During the night of 14 December 1944, in the vicinity of \* \* \*, France, Technician Caskey, a medical aid man, volunteered to reconnoiter a mountainous and hazardous area for a vitally needed evacuation route. In addition to intense enemy artillery fire, blackeut conditions made his mission extremely difficult. Although enemy artillery shells were dropping all around him, he did not once sook cover, but relentlessly continued his reconnaissance. He skillfully discovered the desired route and began the evacuation of the serious litter cases from the top of a mountain. His display of courage and deep devotion to duty while under the most dangerous of conditions enabled the speedy evacuation of his seriously wounded comrades to medical aid. Residence: San Antonio, Texas.

Technician Third Grade Lawrence E. Dorsey, 36715089, Medical Department, Medical Detachment, 928th Field Artillery Battalion. For heroism in action. During the daylight hours of 20 December 1944 in the village of \* \* \*, Germany, enemy artillery made a direct hit on a building near a howitzer position, injuring several of the gun crow. The building which contained small arms ammunition adjoining an artillery ammunition dump, burst into flames. Realizing the danger of exploding small arms ammunition and nearby howitzer projectiles, Technician Dorsey, fearlessly entered a building immediately adjacent to the burning structure, coolly administered first aid and removed a seriously injured soldier to safety. Residence: Freeport, Illinois.

Private First Class Stanley L. Myers, 31298592, Infantry, Company "A", Allth Infantry Regiment. For heroism in action. I -- AWARD OF EMONZE STAR MEDAL. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is swarded following named individuals:

CAPTAIN WILLIAM L. PULTZ, Ol165436, Field Artillery, Battery "B", 928th Field Artillery Battalion. For heroism in action. During the daylight hours of 14 December 1944, CAPTAIN PULTZ was the artillery observer with a task force whose mission was to capture and hold the village of \* \* \*, France. The enemy strongly defended the village, subjecting the task force to heavy direct fire from artillery, mortar, machine gun and small arms. Despite the intense enemy fire, and with utter disregard for his life, he proceeded to an observation post forward of the front lines. From this exposed vantage point he skillfully directed the artillery to lay down a rolling barrage, which enabled our troops to advance with a minimum of casualties. CAPTAIN PULTZ'S skill and heroic action contributed materially to the success of the attack. Residence: Boundbrook, Now Jersey.

FIRST LIEUTEWANT JILLIAM H. STONE, JR., 0520908, Infantry, Company "P", 41th Infantry Regiment. During the daylight hours of 15 December 1944; in the vicinity of \* \* \*, France, in an attack on an enemy-held village, LIEUTEMANT STONE'S company suffered many casualties from an intense enemy mortar and artillery barrage. Heeding the cries for help from one of his man, LIEUTEMANT STONE, with utter disregard for his life, crawled fifty yards over the crest of a hill in the face of intense enemy small arms fire in order to reach the wounded man. Oblivious to the hall of hostile artillery, mortar, and small arms fire, LIEUTEMANT STONE administered aid and then courageously carried the helpless man over the crest of the hill, shielding the casualty as best he could. As a result of his valorous act, a wounded man was expeditiously evacuated and given proper medical attention. Residence: Greensboro, North Carolina.

FIRST LIEUTENANT ROBERT D. MONIUX, 0435280, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroism in action. On 14 December 1944, in the vicinity of \* \* \*, France, LIEUTENANT MONIUX worked indefatigably and skillfully day and night in order to render medical attention to the

wounded. Completely oblicious of the withering fire that swept the area, he hastily set up an aid station in a small building directly behind the front lines. Regardless of physical exhaustion he worked with renewed vigor on the casualties. He courageously remained at his station with utter disregard for his life, refusing to take shelter, as the intensity of the bombardment greatly endangered his position. Not until all the wounded were efficiently treated would be cease his activity. As a result of LIEUTENANT MONIUX'S magnificent courage many lives were saved and the wounded were brilliantly attended. Residence: Algona, Iowa.

CHAPLAIN (FIRST LIEUTENANT) LEON J. DAVIS, 0546034, Chaplain Corps, Headquarters, 409th Infantry Regiment. For heroism in action. From 14 to 17 November 1944, in the vicinity of \* \* \*, France, CHAPLAIN DAVIS served with the Second Bettalion to give spiritual and moral guidance to his men. Running over the mountainous terrain from foxhole to foxhole as enemy mortar and artillery fire blasted about him, he comforted and assisted the men of all faiths and creeds. Later, in an attack on a village, CHAPLAIN DAVIS, with utter disregard for his life, courageously dashed from house to house through intense sniper fire to conduct services and prayers for the men. Frequently during the attack, CHAPLAIN DAVIS was by the side of the wounded giving comfort and aid while medical treatment was being administered. The untiring and valorous efforts of CHAPLAIN DAVIS were an inspiration to the men and were greatly responsible for the high degree of morale throughout the battalion. Residence: West Tulsa, Oklahoma.

SECOND LIEUTEMANT WILLIAM D. CAIN, 0543225, Infantry, Headquarters Company, First Battalion, Allth Infantry Regiment. For heroism in action. During the daylight hours of 6 December 1944, in the vicinity of \* \* \*, France, LIEUTEMANT CAIN, with the Battalion Adjutant, volunteered to assist in supplying the battalion with amminition, food, and water which had been urgently requested by radio. The supply route was jammed with vehicles mired in the mid, and the party proceeded on foot to reconnoiter a by-pass despite knowledge that the area was subjected to heavy enemy mortar and sniper fire, and that mines had not been removed. In order to determine whether the by-pass was suitable for the passage of vehicles, LIEUTENANT CAIN, with utter disregard for his life, volunteered to return, obtain a vehicle, and complete the reconnaissance. Thile proceeding forward, the vehicle struck a mine, LIEUTEMANT CAIN sustaining severe lacerations of the face and a leg wound which necessitated amputation. As a result of this heroic action it was possible to get needed supplies forward, and the battalion was able to continue the attack. Residence: Springfield, Illinois.

CAPTAIN STEVE P. HIMIC, 01296032, Infantry, Company "K", Allth Infantry Regiment. For heroism in action. During the night of 16 December 1944, in the vicinity of \* \* \*, Germany, CAPTAIN HIMIC, acting as battalion executive officer, on his own initiative, led one of his companies over extremely difficult terrain into an advance position. This hazardous movement was accomplished in extreme darkness and necessitated the company passing within 50 yards of an enemy strongpoint over a mine-infested area. During the course of the action enemy small arms opened fire adding immeasurably to the precariousness of his position. With utter disregard for his life, he courage-

ously led the men forward to the safety of their new position. Arriving at their objective he discovered one platoon of the company was missing. In stanteously he heroically retraced his steps and found the lost platoon in the vicinity of the enemy emplacement. He led them to the new company command post without the loss of a single man. As a result of CAPTAIN HIMIC'S outstanding valor under the most trying of conditions, the company advanced to its new position without a casualty and succeeded ultimately in replusing an enemy counter-attack. Residence: Bradenville, Pennsylvania.

CAPTAIN CHESTER C. ...CHER, 0339423, Infantry, Company "C", 411th Infantry Regiment. For heroism in action. During the daylight hours of 12 December 1944, in the vicinity of \* \* \*, France, CAPTAIN ACHER, while leading his company in an attack, keenly observed four enemy tanks approaching in the distance. He quickly deployed his company into strategic positions of protective cover, simultaneously grabbing a rifle from a nearby soldier. He courageously went forward to a vantage point, from which he fired directly into the oncoming tanks. Realizing this fire to be ineffective he rushed back to bring up a bazooka team. When he found none available he seized a bazooka, dashed forward despite intense enemy fire and fired his bazooka into a tank, scoring a direct hit. As a result of his accurate fire the enemy tank was neutralized and the occupants taken prisoner. By CAPTAIN ACHER'S display of magnificent valor the efficiency of the bazooka's fire power so impressed the men of his company that they rushed forward with renewed vigor completely destroying the remainder of the tanks. Residence: Fort Dodge, Towa.

SECOND LIEUTENANT LEE E. ENGEN, 0545582, Infantry, Headquarters Company, Third Battalion, Alth Infantry Regiment. For heroism in action. During the night of 14 December 1944, in the vicinity of \* \* \*, France, a heavily mined and blocked road had to be cleared so that tanks and tank destroyers could take part in a dawn attack. Cognizant of the importance of clearing the road and the risk of his personal safety, LIEUTENANT ENGEN organized a group of volunteers to clear the road. He not only supervised the work, but also wielded a saw and axe to expedite the removal of the roadblocks. He courageously worked for two hours removing the deadly mines, until a boobytrap wounded him and killed another man. He reorganized and checked his men for further casualties and then permitted himself to be taken 1000 yards for medical treatment. After aid had been administered, he learned that a group of engineers had arrived to assist in clearing the road. Despite his painful wound, he insisted on returning to the road block where he rendered valuable assistance in removing the mines. As a result of his magnificent valor, armored troops and infantry successfully advanced to their objective. Residence: Brookings, South Dakota,

Private First Class Charles E. Autry, 38161282, Infantry, Company "L", 411th Infantry Regiment. For gellantry in action. In the dawn of 17 November 1944, in the vicinity of \* \* \* , France, Private Autry, advancing with his company, found it necessary to cross a swift, turbulent stream, in order to reach the company objective. As a bridge was not available he skillfully made his way to the opposite bank by swimming across. When he reached safety he heard a cry of distress from a drowning comrade. With utter disregard for his life, he plunged into the icy waters, fighting a vicious current, to reach his comrade's side. He succeeded in pulling the drowning soldier to safety. Courageously he remained in the frigid water until he was assured that all members of the leading platoon had reached the security of the opposite bank. This valorous deed accomplished, he observed a soldier of another platoon struggling for his life after he had been swept from his feet by the swift current. Once again he gallantly plunged into the stream and rescued the drowning man. He remained in the water until he was dertain that all members of the last platcon had successfully crossed the stream. As a result of Private Autry's display of outstanding courage two comrades lives were saved and many others were materially assisted in their crossing. Residence: Houston, Texas.

II - AWARD, POSTHIMOUS, OF SILVER STAR. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Silver Star is awarded, posthumously, to the following named individuals:

Corporal Gordon K. Bentson, 37542021, Infantry, Company "E", 409th Infantry Regiment. For gallantry in action. During the daylight hours of 13 Lecember 1944, in the vicinity of \*\* \* , France; Corporal Bentson, squad loader in the leading assault platoon, was pinned to the ground by inters e enemy artillery, mortar and automatic weapon fire. The assigned route of the attacking squad necessitated Corporal Bantson's maneuvering them over 800 yards of fire-swept terrain in full view of the enemy. He gallantly preceded his squad, with utter disregard for his life, seeking out the enemy as he courageously advanced. When he had advanced approximately 100 yards he was painfully wounded by enemy small arms fire.

CO #7, Ha 103d Inf Div, dtd 2 Jap 45.

Despite these injuries he pushed relentlessly on, heedless of the devastating fire that swept his path. Advancing but a few yards farther, he was wounded again, this time by enemy mortar fire. He dragged himself to a nearby doorway and from this vantage point, brilliantly directed his squad in the attack which ultimately resulted in their forcing the enemy to withdraw. Corporal Bentson subsequently died of the wounds received in this action. Throughout this entire activity Corporal Bentson's display of magnificent courage was in accordance with the highest traditions of the military service. Residence: Dallas, Texas. Next of kin: Mrs. Gwendolyn O. Bentson (wife), 3628 Lartmouth, Dallas, Texas.

Private First Class Elmo E. Gross, 37402352, Infantry, Headquarters Company, Third mattalion, 411th Infantry Regiment. For gallantry in action. During the night of 14 December 1944, in the vicinity of \* \* \* , France, it was imperative that a heavily mined and blocked road be cleared in order that a task force of infantry and tanks could begin a dawn attack. Realizing that the small group of engineers could not clear the road in time for the early morning attack, Private Gross, on his own initiative, assisted the engineers in removing deadly mines from four road blocks. In addition to the danger of removing the booby trapped mines in the dark there was also the possibility of the noise of the digging attracting the alert enemy. Despite this danger he worked on, with utter disregard for his life, until a mostile mine exploded, mortally wounding him. As a result of Private Gross' heroic action, the task force was able to advance along the cleared read to successfully capture its objective. His gallantry was in accordance with the highest traditions of the military service. Residence: St. Louis, Missouri. Next of kin: Mrs. Bessie M. Gross (wife), 4705 Thrush Avenue, St. Louis, Missouri.



In the progress of the movement a squad member was struck by shrapnel. With utter disregard for his life, he dashed to the side of his wounded commade, and despite the withering fire, dragged him 75 yards to protection. The intensity of the fire became so severe at one point that the wounded man was struck again. Heedless of this extreme danger Sergeant Rose continued courageously, and as a result of his cutstanding valor he saved the life of a wounded commade! Residence: Springfield, Ohio.

Private Venseslado M. Salgado, 39017751, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroism in action, During the period of 19 December to 20 December 1944, in the vicinity of \* \* \*, Germany, Private Salgado, litter bearer attached to Second Battalion, worked tirelessly and courageously night and day evacuating wounded. Warned that going forward entailed extreme danger, he, with utter disregard for his life, dashed to the front line troops to be of assistance wherever it was deemed necessary. Evacuation of the wounded necessitated traversing a thousand yards of hazardous and mountainous terrain, in the face of withering enemy fire. Repeatedly he crossed the fire-swept area to bring his comrades to safety. Oblivious of physical exhaustion he did not cease his courageous efforts until all the wounded had been carried to safety. By his outstanding valor many lives were saved and medical attention was rendered expeditiously to the wounded. Residence: Rosemead, California.

Private First Class Harry E. Thomas, 37400595, Infantry, Company "E", 411th Infantry Regiment. For heroism in action. During the daylight hours of 10 December 1944, in the vicinity of \* \* \* \*, France, Private Thomas was pinned to the ground by intense enemy small arms fire. Observing a wounded comrade lying in an exposed position, he, with utter disregard for his life, dashed courageously to the injured man's side. Completely oblivious of the devastating fire that swept his path, he picked up the wounded man in full view of the enemy and carried him to safety. As a result of Private Thomas' heroic actions, his wounded comrade received prompt medical attention. Residence: St. Louis, Missouri.

Private First Class Bernard A. Enos, 36553926, Infantry, Headquarters Company, Second Battalion, 409th Infantry Regiment. For heroism in action. Buring the daylight hours of 21 December 1944, in the rocky and mountainous region near \* \* \*, Germany, Private Enos, a one quarter ton truck driver, on his own initiative, volunteered to bring urgently needed ammunition to the battling front line troops. With utter disregard for his safety, he courageously drove two miles through intense enemy artillery, mortar, and small arms fire to a precarious advance position. Successfully reaching his destination, he unloaded the vitel ammunition and then brought a wounded soldier back to safety as litter bearers were needed elsewhere. On four occasions he braved the heavy enemy fire to transport ammunition to the front and evacuate casualties to the rear for medical aid. Private Enos' heroic


actions were of material assistance to our infantry in their advance and his expeditious manner of evacuating the wounded was extremely helpful to the seriously wounded casualties. Residence: Saginaw, Michigan.

Private First Class Bonald G. Leichtweis, 36548766, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroism in action. During the daylight hours of 25 November 1944, in the vicinity of \* \* \*, France, Private Leichtweis, litter bearer assigned to Company "A", was pinned to the ground by intense enemy mortar and small arms fire. Informed that many wounded were in an exposed position in front of an enemy road-block, he, With utter disregard for his life, dashed forward to locate and evacuate the wounded. Despite the withering fire that swept the area, he continued his heroic efforts completely oblivious of the dangers that confronted him. He worked untiringly and courageously evacuating many wounded, until he, himself, was seriously wounded by enemy machine gun fire. As a result of Private Leichtweis' magnificent valor, prompt medical attention was rendered efficiently and expeditiously to his wounded comrades. Residence: Plymouth, Michigan.

Private First Class Lynn R. Stowe, 38535135, Infantry, Company "C", 409th Infantry Regiment. For heroism in action. During the night of 1 December 1944, in the vicinity of \$ \* \*, France, Private Stowe, was subjected to a marderous enemy artillery barrage. The terrain, being open and flat, offered little cover from the devastating fire, Coserving a comrade struck down by a shell fragment, Private Stowe, with utter disregard for his life, fearlessly advanced to the side of his wounded comrade. While enemy shells raked the area, he expeditiously administered first aid, and then skillfully assisted the wounded man to safety. His courageous actions accomplished under the most hazardous conditions saved the life of a fellow soldier. Residence: Fort Worth, Texas.

Private First Class Robert L. Leslie, 33435556, Infantry, Company "G", 409th Infantry Regiment. For heroism in action. During the daylight hours of 19 December 1944, in the vicinity of \* \* \*, Germany, a light machine gun failed to function while the company was undergoing a heavy artillery and mortar-supported counterattack. Cognizant of the peril to his company, Private Leslie, machine gunner, with utter disregard for his life, courage-ously held the position while the remainder of the squad withdrew the machine gun to be repaired. Private Leslie returned fire with his rifle and, although the counterattack increased in intensity as the enemy approached to within 75 yards, he firmly held his position. Private Leslie's delaying action enabled the squad to repair the machine gin in time to return it to the position and drive off the enemy. As a result of his valorous act, the company materially aided in stabilizing its position, successfully replused the hostile counterattack. Residence: Newcastle, Pennsylvania.

Private Philip H. Lesh, 32777429, Field Artillery, Headquarters Battery, 382d Field Artillery Battalion. For heroism in action. During the night of

30 November 1944, in the mountainous and wooded region near \* \* \*, France, Private Lesh, a wireman in a forward observer section, was assisting in mintaining a radio relay station during the assault on the village. Being in close proximity to the enamy lines, hostile patrols were known to be active in the area. Shortly after the infantry advance passed their position an enemy patrol of ten men came within thirty yards of their post and another hostile patrol opened fire. Due to his expert firing the patrol was forced to withdraw. Despite the danger constantly confronting him in this forward position, he, showing great devotion to duty, stayed at his post so that important artillery fire missions could be relayed to the fire direction center. Residence: Clifton, New Jersey.

Private Oscar H. Walker, 38479112, Medical Department, Medical Detachment, 409th Infantry Regiment. For heroism in action. On 20 December 1944, in the vicinity of \* \* \*, Germany, an enemy attack supported by intense artillery, mortar, and tank fire resulted in heavy casualties. Several times throughout the day, Private Walker, a medical aid man attached to Company "D", courageously exposed himself to hostile fire to administer aid to the wounded. On one occasion, with utter disregard for his life, he courageously dashed 200 yards through mortar, artillery, small arms, and direct tank fire to the aid of a wounded comrade who had been shot through the lung. Displaying great stamina and determination, he carried the casualty, unaided, up a precipitous slope to the safety of a troop-shelter. Private Walker skillfully and expeditiously treated the sorious wound, but was unable to evacuate the injured man to the aid station during the persistent enemy assault on our positions. For a period of 60 hours, during which time he did not sleep, Private Walker remained continually at his comrade's side carefully attending and watching the serious lung wound. As a result of his magnificent valor and spirit of duty, his helpless patient was later evacuated to an aid station where professional and effective medical treatment was administered. His courage and sacrifice remains a lasting inspiration to all his comrades. Residence: itoka, Oklahoma.

I -- AMARD OF BRONZE STAR MEDAL. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded following named individuals:

Staff Sergeant Virgil A. Gallion, 17175027, Infantry, Service Company, 409th Infantry Regiment. For heroism in action. During the porning of 16 December 1944, Sergeant Gallion, a battalion supply sergeant, on his own initiative, began the dangerous mission of delivering rations and ammunition over fire-swept terrain to the front line troops fighting near \* \* \* , Germany. Because our troops had advanced swiftly, a considerable distance lay between the supply point and the troops, with no direct route available. Sergeant Gallion reconnoitered the area and found a feasible, though fireswept, route. Realizing the importance of his mission, he disregarded warning of those around him, and proceeded forward, although at one time he passed under direct enemy observation and was subjected to intense shelling. He successfully directed his vehicle as close to the troops as possible and then swiftly organized hand parrying parties. While in this forward position, he learned that a nearby village was to be bombed shortly, but remained so that he could evacuate any casualties. Having successfully evacuated the sole casualty of the bombing, he returned to the supply point. Sergeant Callion skillfully continued his important work throughout the following two days by supplying forward troops with rations and ammunition, which were of material aid in their advance. Residence: Atchison, Kansas.

Private First Class Harold E. Robinson, 35595925, (then Private), Infantry, Company "F", 409th Infantry Regiment. For heroism in action. During the daylight hours of 29 November 1944, in the vicinity of \* \* \*, France, Private Robinson, a messenger, observed a comrade wounded by enemy small arms fire. All aid men being preoccupied, he, on his own initiative fearlessly advanced forward under the enemy fire and successfully reached the injured man. Bullets raked his path as he expeditiously carried his comrade to safety. Because of Private Robinson's courageous actions while under fire, his injured comrade was able to receive prompt medical attention. Residence: Stow, Ohio.

Private First Class Charles E. Widas, 38496876, Infantry, Company "A", 409th Infantry Regiment. For heroism in action. On 23 November 1944, in the vicinity of \* \* \* Prance, Company "A", 409th Infantry Regiment, was subjected to intense enemy machine gun fire; Realizing the vital necessity of ascertaining the location of the hostile strongpoint, Private Wicks, with utter disregard for his life, courageously accompanied his platoon leader and two commades who were going forward in full view of the enemy. Heedless of the withering fire that blasted the area, knowing one of his commades had been killed and another wounded, he heroically pushed forward to locate the enemy emplacement. As a result of Private Widas' magnificent valor the position of the hostile gun was located and ultimately destroyed by morter fire. Residence: Roseland, Louisiana.

II - AWARD OF BRONGE STAR MEDAL, MISSING IN ACTION. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded following named individual:

Sergeant Willis M. Gartrell, 34497242, Infantry, Company "G", 409th Infantry Regiment. For heroism in action. During the daylight hours of 20 December 1944, in the vicinity of \* \* \* , Germany, the position of Company "G" was threatened by an enemy counter-attack. Sergeant Gartrell, with utter disregard for his life, crawled from his trench numerous times in order to fire more effectively. On numerous occasions he stood upright exposing himself, firing with devastating accuracy on the attacking enemy. Although he was in the mortar section, he courageously joined the riflemen in their counter-drive to repulse the severe hostile attack. Sergeant Cartrell advanced toward the enemy forces, firing as he moved, and was last seen driving forward over the hostile area. Sergeant Cartrell's magnificent valor was in accordance with the highest traditions of the military service. Residence: Memphis, Tennessee. Next of kin: Mrs. Hamme O. Private Robert J. Doris, 32960552, Infartry, Company "D", Aloth Infantry Regiment. For horoism in action. During the drylight hours of 30 November 1944, in the vicinity of \* \* \* , France, Private Doris, machine gunner, while under severe enemy shelling, courageously remained at his post despite the withering fire that blasted the area. When one gunner was killed by enemy fire, he, with utter disregard for his life, single-handedly moved the gun and directed accurate and effective fire on the hostile troops. The accuracy of his fire was so severe that the opposing forces were compelled to withdraw in a disorganized retreat. In the process of this heroic action he was struck by hostile fire, falling mortally wounded. Throughout this entire action Private Dorisi display of magnificent valor was in accordance with the highest traditions of the

Realizing the vital necessity of ascertaining the location of the hostile strongpoint, Private Mlackman, with utter disregard for his life, courageously accompanied his platoon leader and two comrades, who were going forward in full yiew of the enemy. Heedless of the withering fire that blasted the area, Private Blackman heroically pushed forward until cut down by enemy fire, falling mortally wounded. His outstanding courage materially assisted in locating the position of the hostile gun which was ultimately destroyed by mortar fire. Throughout this entire action, Private Blackman's display of magnificent valor was in accordance with the highest traditions of the military service. Residence: La Salle, Michigan. He directed accurate and effactive fire on an enomy strongpoint while in full view of the hostile forces. In order to locate a more advantageous position, he, with utter disregard for his life, skillfully crawled forward, completely oblivious of the devastating fire that blasted the area about him. In the process of his move forward he was struck by enemy fire, falling mortally wounded. Throughout this entire action, Sorgeant Gentry's display of outstanding valor was in accordance with the highest traditions of the military service. Residence: Shady Valley, Tennessee. He effectively placed fire on hostile forces moving forward in a counter-attack, with such accuracy that the enemy were forced to withdraw in a hasty retreat, suffering numerous casualties. Heroically, he picked up his gun, dashed forward on the heels of the fleeing enemy, firing on them as they withdrew, and continued firing until he was struck by enemy fire, falling mortally wounded. Private First Class Lincoln Ng, 32901529, Infaatry, Company "D", 410th Infantry Regiment. For heroism in action. During the daylight hours of 30 November 1944, in the vicinity of " \* \* \*, France, Private Ng and his company were subjected to murderous enemy artillery, mortar, and sniper fire, during a hostile counter-attack. During this severe concentration of hostile fire a fellow machine gumer was wounded. With utter disregard for his life, Private Ng unhesitantly braved this withering fire and fearlessly carried the machine gum to a more advantageous position. From this vantage point, he skillfully and courageously directed devastating fire into the enemy ranks, inflicting heavy casualties and forcing the enemy to withdraw. Private Ng, during this valorous act was fatally wounded by enemy fire. Throughout this entire action, his display of self-sacrifice and magnificent valor was in accordance with the highest traditions of the armed forces. Residence: New York, New York. Private Edward V. Ciricillo, 42002871, Infantry, Company "A", 41th
Infantry Regiment. For heroism in action. During the chylight tours of

company established a bridgehead across an enemy-held river. His company
was pinned to the open terrain by an intense barrage of mortar and machine
gun fire. Realizing his commades were cut off on the hostile side of the
river, Private Ciricillo, with utter disregard for his life, courageously
crawled forward under a fierce hail of hostile fire toward an enemy machine
gun amplacement. Taking advantage of the little cover that the exposed
bridgehead offered, he crawled forward to within a few yards of the hostile
cmplacement, when struck by a blast of hostile fire, falling mortally wounded. The men, inspired by Private Ciricillo's courageous act, moved forward
driving the enemy back. His magnificent valor was in accordance with the
