AWARD OF BRONZE STAR MEDAL I
AWARD, POSTHUMOUS, OF BRONZE OAK LEAF CLUSTER TO BRONZE STAR MEDAL II

I - AWARD OF BRONZE STAR MEDAL. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded to following named individuals:

Mr. Hock 10th
Private First Class Placide C. LeGros, 38656361, Infantry, Company "B", 411th Infantry Regiment. For heroic achievement in action. On 12 January 1945, near Gauvringen, France, Private LeGros crawled 150 yards under a mortar and artillery barrage to repair breaks in the communication wire. After repairing the breaks, he was subjected to small arms fire but continued on his mission successfully repairing the line, thereby re-establishing contact with battalion headquarters. His actions reflected the highest traditions of the military service. Residence: Jennings, Louisiana.

Private First Class Robert L. Sullivan, 34984341, Infantry, Company "A", 411th Infantry Regiment. For heroism in action. On 15 March 1945, near Muhlhausen, France, when his platoon was pinned down by sniper fire, Private Sullivan exposed himself to the fire in order to locate the sniper. Advancing from tree to tree, he knocked out two of the snipers, enabling his platoon to advance and capture 20 of the enemy. His actions reflected the highest traditions of the military service. Residence: Jackson, Tennessee.

Sergeant William V. Drzadik, 35513170, Infantry, Company "F", 411th Infantry Regiment. For heroic achievement in action. On the night of 23 November 1944, near St. Die, France, when the second battalion, 411th Infantry was given the mission of infiltrating through enemy positions to high ground, Sergeant Drzadik volunteered as scout to lead the battalion. Approaching an outpost, he discovered the enemy changing reliefs and, following the old guard, located a house occupied by the enemy. After reporting to the battalion commander he reconnoitered for a safe detour and, discovering another enemy occupied house, crawled closer to observe the enemy in a mess line. Counting 77 of the enemy, he reported to the battalion commander and continued on his mission. Sergeant Drzadik's actions reflected the highest traditions of the military service. Residence: Cleveland, Ohio.

Technician Fourth Grade Edward H. Endert, 36549153, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroic achievement in action. On the night of 15 December 1944, near Climbach, France, when enemy fire halted previous attempts of litter bearers to evacuate two members of a patrol, Technician Endert, medical technician, enlisted the help of four infantrymen and led the men past hostile outposts in search of the wounded. Finding them, he administered aid and assisted in the evacuation through the lines to the aid station. Technician Endert's actions reflected the highest traditions of the military service. Residence: Detroit, Michigan.

Private First Class John J. Kaufmann, 36643050, Infantry, Company "B", 411th Infantry Regiment. For heroic achievement in action. On the night of 24 January 1945, near Sossonheim, France, Private Kaufmann was leading a group of men to the battalion command post when they were halted by sniper fire. Crawling 50 yards to the left, he located the sniper and fired on the position. Again crawling forward and finding the sniper seriously wounded, he returned to the men and continued to lead them to the command post. Private Kaufmann's actions reflected the highest traditions of the military service. Residence: Wilmette, Illinois.

Private First Class Thomas J. Fagan, 37149088, Infantry, Headquarters Company, Third Battalion, 409th Infantry Regiment. For heroic achievement in action. On the night of 21 March 1945, near Reisdorf, Germany, informed that a seriously wounded man in a forward company was unable to be evacuated, Private Fagan led a litter squad over an area covered by machine gun, mortar and small arms fire coming from fortifications on the high ground. Although pinned down several times by machine gun and mortar fire, he led the squad over a wooded hill covered by fallen trees, mines and barbed wire to the company and then assisted in the evacuation of the casualty. Private Fagan's actions reflected the highest traditions of the military service. Residence: Lusk, Wyoming.

Technician Fifth Grade Ronald P. Treloar, 36125299, Infantry, Company "F", 411th Infantry Regiment. For heroic achievement in action. On 15 March 1945, near Bitschholza, France, Technician Treloar, acting as litter bearer, advanced a distance of two miles across open fields, under artillery, mortar and through unmarked mine fields to evacuate three wounded men. On one return trip, when mortar fire fell in the area, he placed the casualty in a covered position and, as the enemy lifted their fire, continued on to the aid station. Technician Treloar's actions reflected the highest traditions of the military service. Residence: Petersburg, Michigan.

Corporal Peter J. Boylan, 35423001, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroic achievement in action. On 15 March 1945, near Muhlhausen, France, although wounded in the shoulder and leg, Corporal Boylan, aid man, crawled 20 yards and administered aid to a comrade. Then with some assistance in tying bandages, he administered aid to seven more wounded before accepting treatment for his own wounds. Since the enemy fire prevented his evacuation, Corporal Boylan remained, treating the wounded for 23 hours. Working constantly with one casualty who was seriously wounded in the head, he kept the man alive until he could receive the attention of a doctor. Corporal Boylan's actions reflected the highest traditions of the military service. Residence: Dayton, Ohio.

Private First Class Lee N. Leary, 37245540, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 20 January 1945, near Schirrhoffen, France, intense enemy artillery had severed battalion communication lines. When two extremely urgent messages had to be delivered to the forward elements, Private Leary volunteered to deliver the messages. Although constantly exposed to intense enemy fire, he completed his mission and returned to find that another message had to be delivered. Again Private Leary braved the intense fire and for the second time completed his mission. His actions were in accordance with the highest traditions of the military service. Residence: Warrensburg, Missouri.

Private First Class Gerald A. Ramsey, 37120121, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroic achievement in action. On 22 April 1945, near Dottingen, Germany, when Company "F", 411th Infantry was pinned down by automatic weapon fire, Private Ramsey, litter bearer, observing two wounded men, crawled 30 yards through the hostile fire to one casualty and administered aid. Crawling 15 yards to the other casualty, he administered aid and, discovering the man partially protected from enemy fire, crawled back to the first casualty where he remained, administering further aid until the enemy positions were neutralized. Private Ramsey's actions reflected the highest traditions of the military service. Residence: Pittsburg, California.

Private First Class Raymond A. Pare, 32700204, Medical Department, medical Detachment, 411th Infantry Regiment. For heroic achievement in action. On 23 April 1945, near Linfenhoffen, Germany, when a concentration of mortar, artillery and small arms fire wounded six men in Company "G", 411th Infantry, Private Pare, an attached aid man, crawled 75 yards through the hostile fire and administered aid. He then moved each man to safety where evacuation was possible. Private Pare's actions reflected the highest traditions of the military service. Residence: Brooklyn, New York.

Private First Class George P. Vinson, 35920021, Infantry, Headquarters Company, Second Battalion, 411th Infantry Regiment. For heroic achievement in action. During the advance of the second battalion, 411th Infantry, on 15 March 1945, near Rothbach, France, the attacking company was suffering heavy casualties. Private Vinson, message center clerk, with full knowledge of the danger involved, exposed himself to enemy sniper, mortar and artillery fire to evacuate the wounded. Although many trips were necessary, and on each one he was subjected to enemy fire, Private Vinson remained at the task and was directly responsible for the saving of many lives. His actions reflected the highest traditions of the military service. Residence: Manistee, Michigan.

LIEUTENANT COLONEL CHARLES L. McMACKIN, 0383322, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 25 November 1944, in the vicinity of Maisongoutte, France, COLONEL McMACKIN, executed brilliant maneuvers and displayed outstanding leadership in probing and cracking strong enemy opposition in this sector. Leading the group over precipitous slopes and muddy ground COLONEL McMACKIN remained in the lead of the battalion, directing its every move. The capture of the city was due mainly to the untiring efforts and outstanding leadership of COLONEL McMACKIN. His actions reflected the highest traditions of the military service. Residence: Salem, Illinois.

Staff Sergeant Howard H. Hede, 31318054, Infantry, Company "E", 411th Infantry Regiment. For heroism in action. On 16 November 1944, near Labolle, France, Sergeant Hede, was leading his squad in the attack when mortar, machine gun and small arms fire was encountered, inflicting casualties and forcing the squad to seek cover. Sergeant Hede observed a wounded soldier lying in a position exposed to further enemy fire, without hesitation, he left his cover and, disregarding the enemy fire, reached the wounded man and brought him to safety. Sergeant Hede's actions reflected the highest traditions of the military service. Residence: Stockholm, Maine.

Technician Fifth Grade Allen H. Pearson, 11079454, Infantry, Service Company, 411th Infantry Regiment. For heroism in action. On 21 March 1945, near Bobenthal, Germany, Technician Pearson volunteered to lead ambulances forward when the casualties of the attacking units became numerous. Moving over mined roads and under intense enemy fire, he led the convoy into town. Technician Pearson remained exposed to enemy fire until the aid station was located and then guided the ambulances safely to their destination. Technician Pearson's actions reflected the highest traditions of the military service. Residence: West Hartford, Connecticut.

Technician Fourth Grade Von Dean Morlein, 37402392, Infantry, Service Company, 411th Infantry Regiment. For heroism in action. On 15 March 1945, near Muhlbach, France, Technician Morlein volunteered to establish contact between the regimental observation post and the First Battalion which was pinned down by unexpected enemy resistance. The mission undertaken by Technician Morlein was exceedingly perilous as the fields were heavily mined and enemy fire was constant and heavy. Forced to take cover on several occasions, Technician Morlein reached his destination and delivered the message, resulting in the enemy opposition being eliminated. Technician Morlein's actions reflected the highest traditions of the military service. Residence: Kansas City, Missouri.

Private First Class William H. Martin, 6566681, Infantry, Service Company, 411th Infantry Regiment. For heroism in action. On 27 April 1945, near Markt Waldt, Germany, Private Martin accompanied the regimental quartering party when pinned down by intense enemy action within the limits of the town. Private Martin volunteered to remain in an exposed position to draw enemy fire while the remainder of the group executed a flanking movement to overcome the enemy. As the flanking group charged from its position, Private Martin rushed forward and aided in routing the opposition. Private Martin's actions reflected the highest traditions of the military service. Residence: Riverside, California.

Private First Class Robert H. Sturgeon, 10601851, Infantry, Company "B", 411th Infantry Regiment. For heroism in action. On 19 January 1945, near Rothbach, France, Private Sturgeon, messenger, was pinned down in the forward elements during an attack by intense enemy fire. Realizing that a withdrawal was imperative and covering fire was necessary, Private Sturgeon dashed 60 yards over open and fire swept terrain to reach the remainder of the company. Upon reaching the company, he led two platoons in a flanking maneuver where effective fire enabled the lead platoon to withdraw to safety. Private Sturgeon's actions reflected the highest traditions of the military service. Residence: Belfast, Ireland.

Sergeant Leon M. Lambert, 37246297, Infantry, Company "L", 409th Infantry Regiment. For heroism in action. On 23 November 1944, near Provencieres, France, when attacking troops were being held up by enemy action, Sergeant Lambert set up two sections of mortars. As mortar and artillery fire fell near his position, he began laying wire to the battalion observation post. Despite small arms and machine gun fire, he established communications and returned to his position to direct fire on the enemy strongpoints. His actions which relieved the pressure on our troops reflected the highest traditions of the military service. Residence: Pittsburgh, California.

Private First Class Roswell F. Heme, 36553736, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On 25 November 1944, near Maisongoutte, France, when fire from an enemy machine gun forced the occupants of a vehicle to dismount, Private Heme and four others moved forward to eliminate the machine gun position and recover the vehicle. Obtaining a bazooka and several rounds of ammunition, Private Heme crawled to within 50 yards of the emplacement and firing rocket grenades, forced the enemy from the position, then pursuing the crew, he captured four. His actions reflected the highest traditions of the military service. Residence: Flint, Michigan.

Private First Class Sidney W. Tyler, 20939633, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On 25 November 1944, near Maisongoutte, France, when fire from an enemy machine gun forced the occupants of a vehicle to dismount, Private Tyler and four other men moved forward to eliminate the machine gun position and recover the vehicle. Obtaining a bazooka and several rounds of ammunition, Private Tyler crawled to within 50 yards of the emplacement and firing rocket grenades, forced the enemy from the position. His actions reflected the highest traditions of the military service. Residence: Green River, Wyoming.

Staff Sergeant Raymond H. Dotson, 15171037, (then Private First Class), Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 25 November 1944, near Lubine, France, when an attacking battalion was pinned down by machine gun fire and subjected to a mortar barrage, Sergeant Dotson volunteered to establish communications. Disregarding the enemy fire he carried a roll of wire over the fire swept terrain and then, running short, he returned for additional wire, returning, he spliced the wire and then made his way back to the battalion. His actions reflected the highest traditions of the military service. Residence: St Mary's, West Virginia.

Staff Sergeant Russell C. Rossmann, 36550066, Infantry, Headquarters Company, Third Battalion, 411th Infantry Regiment. For heroic achievement in action. On 26 December 1944, near Merlebach, France, Sergeant Rossmann led a patrol into hostile territory to reconnoiter enemy dispositions. When fired on by a machine gun, he deployed his patrol and crawled to within 30 yards of the emplacement, demanding the surrender of the enemy crew who continued to fire. Signalling his men to open fire, he rushed forward, capturing the three man crew and then continued on to accomplish his mission. Sergeant Rossmann's actions reflected the highest traditions of the military service. Residence: Detroit, Michigan.

Staff Sergeant Glenn C. Wainwright, 18149924, Infantry, Company "N", 411th Infantry Regiment. For heroic achievement in action. On 14 February 1945, when raiding elements of a company encountered a mine field near Nieffern, France, and became disorganized, Sergeant Wainwright ran through the mine field under machine gun and small arms fire to assist in reorganizing the company. After assisting in the evacuation of the wounded, he withdrew and discovered two men were missing. Once again braving the enemy fire, he reached the two men and led them to safety. His actions reflected the highest traditions of the military service. Residence: Roseland, Louisiana.

Private First Class Roy A. Clinka, 37589151, Infantry, Company "C", 411th Infantry Regiment. For heroic achievement in action. On 17 March 1945, near Schmiller, France, when Company "C", 411th Infantry was momentarily held up at a clearing covered by machine gun fire, Private Clinka led an assault platoon, as scout, into the open field. Observing an enemy machine gun position, he directed fire, knowing it out and then continued his marching fire as the platoon attacked the remaining positions. Private Clinka's actions reflected the highest traditions of the military service. Residence: North Fargo, North Dakota.

Sergeant Leonard Heller, 37542110, (then Private First Class), Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 15 March 1945, near Muhlhhausen, France, when the platoon sergeant and the squad leader of a demolitions squad were seriously wounded while clearing a path through a mine field, Sergeant Heller, disregarding mortar and machine gun fire, took charge and successfully cleared the area of mines. Then guiding the men through the field, he directed the evacuation of the two men. Sergeant Heller's actions reflected the highest traditions of the military service. Residence: Fredonia, North Dakota.

Private First Class John W. Hubert, 36288521, Infantry, Company "I", 411th Infantry Regiment. For heroic achievement in action. On 23 November 1944, near Coinches, France, when his company was subjected to an intense concentration of machine gun and small arms fire coming from the left flank, Private Hubert advanced 30 yards to an exposed position and emplaced his machine gun. As his company withdrew to safety, he fired on the hostile positions, killing 11 of the enemy and wounding several others. Private Hubert's actions reflected the highest traditions of the military service. Residence: Marinette, Wisconsin.

Private First Class Alvin L. Suduth, Jr., 14115761, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 19 March 1945, in the vicinity of Bobenthal, Germany, Private Suduth, wireman, volunteered to lay wire, under fire, from the rear battalion command post to the forward observation post as plans were completed for an attack on the Siegfried Line. Crawling forward through enemy territory, he succeeded in successfully establishing communications. On numerous occasions the lines were knocked out by intense enemy fire and on each instance Private Suduth crawled forward to make the necessary repairs. His actions reflected the highest traditions of the military service. Residence: Castoria, North Carolina.

Private First Class Herbert L. Thoma, 42073863, Infantry, Company "C", 411th Infantry Regiment. For heroism in action. On 17 March 1945, in the vicinity of Reichshoffen, France, Private Thoma, rifleman, upon seeing his platoon leader wounded, volunteered to carry him through intense enemy fire to medical aid. The seriousness of the officer's wounds necessitated constant attention and several stops were necessary enroute to give aid. When sniper fire forced him to cover, he placed the wounded officer in a safe position and returned the fire, killing one of the snipers and wounding another. He then returned to the wounded man and carried him to the aid station. Private Thoma's actions reflected the highest traditions of the military service. Residence: Yonkers, New York.

AWARD OF BRONZE STAR MEDAL (CONT'D).

Staff Sergeant Rodney L. Warner, 34673752, Infantry, Company "C", 411th Infantry Regiment. For heroism in action. On 17 March 1945, near Neuhwiller, France, Sergeant Warner, squad leader, organized an assault force to clear an open field of enemy opposition. In the process of the advance across the field, Sergeant Warner observed an enemy machine gun emplacement in a position to open fire on his group. He opened fire on the strongpoint, killing two of the enemy and silencing the strongpoint. Sergeant Warner's actions reflected the highest traditions of the military service. Residence: Raleigh, North Carolina.

Private First Class Richard G. Songer, 16185955, Infantry, Company "H", 411th Infantry Regiment. For heroic achievement in action. On 19 December 1944 when Company "H" was attacking heavily fortified positions near Bobenthal, Germany, Private Songer was knocked down by a shell burst which also wounded one of his comrades. Ignoring his own condition and the chance to take cover from direct automatic weapons and small arms fire, he crawled to the wounded man and administered first aid. He then assisted in observing, directing and adjusting friendly artillery fire on enemy pillboxes which were holding up our advance. Private Songer's actions were in accordance with the highest traditions of the military service. Residence: Decatur, Illinois.

Sergeant Harold F. Varnes, 37246893, Infantry, Headquarters Company, Third Battalion, 411th Infantry Regiment. For heroic achievement in action. On the night of 25 November 1944, near Maisongoutte, France, vehicles in a temporary motor park were fired upon by infiltrating enemy patrols and bypassed machine gun positions. Sergeant Varnes, realizing the danger to the personnel and vehicles began forming a column to move them from danger. When several vehicles became bogged down, he personally drove a 3/4 ton maintenance truck to the vehicles and winched them out. Forced to dismount and engage an enemy patrol, he momentarily silenced their fire and then continued to supervise the movement of the column until all vehicles and personnel were safely moved. His actions reflected the highest traditions of the military service. Residence: Olathe, Kansas.

Technician Fourth Grade Anthony V. Labato, 12184595, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On the night of 24 November 1944, near Lubine, France, vehicles of the Third Battalion, loaded with rations and ammunitions, were fired upon by enemy troops that had been bypassed. Technician Labato, motor mechanic, realizing the necessity for prompt action, began forming a motor column. Six vehicles having become bogged down, he drove a 3/4 ton maintenance vehicle into position, and for five hours worked under constant enemy small arms and machine gun fire until the vehicles were freed and the convoy was able to move forward. Technician Labato's actions reflected the highest traditions of the military service. Residence: New York, New York.

Private First Class Carlton L. Lohse, 37559269, Infantry, Company "H", 411th Infantry Regiment. For heroic achievement in action. On 3 December 1944, near Ebersheim, France, Private Lohse, then ammunition bearer, was a member of a group maintaining a road block which was receiving enemy mortar, sniper and machine gun fire. Running across open terrain under intense enemy fire, Private Lohse obtained a radio, and called for mortar fire on the enemy positions. Although forced to direct fire from a prone position, because of the enemy mortar fire, Private Lohse remained at his post until the enemy strongpoints were eliminated and the battalion was able to continue its advance. His actions

reflected the highest traditions of the military service. Residence: Minneapolis, Minnesota.

Technician Fourth Grade Joseph C. Moshart, 35037181, Infantry, Headquarters Company, Third Battalion, 409th Infantry Regiment. For heroic achievement in action. On 25 January 1945, near Oberach, France, when a patrol met heavy resistance from mortar and small arms fire, Technician Moshart moved 150 yds through the enemy fire to a position on the flank. Disregarding the hostile fire, he remained alone holding the enemy until the patrol had withdrawn, at which time he fought a rear guard action inflicting three casualties upon the enemy. His actions reflected the highest traditions of the military service. Residence: Upper Sandusky, Ohio.

Private First Class John Lynn, 19039523, Infantry, Company "B", 411th Infantry Regiment. For heroic achievement in action. On 16 November 1944, near LaBolle, France, after the first platoon of Company "B" had crossed an open field, it was cut off by mortar and machine gun fire. Private Lynn, disregarding the enemy fire, crawled 200 yards to a position near the enemy machine gun emplacements, and with accurate fire, killed three of the enemy and forced five more to withdraw, leaving their guns in position. His actions which enabled the platoon to regain contact reflected the highest traditions of the military service. Residence: Redlands, California.

II - AWARD, POSTHUMOUS, OF OAK-LEAF CLUSTER TO BRONZE STAR MEDAL. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Oak-Leaf Cluster to Bronze Star Medal is awarded, posthumously, to following named individual:

Staff Sergeant William Zwetsch, 36716251, Infantry, Company "C", 411th Infantry Regiment. For heroism in action. On 15 March 1945, in the vicinity of Muhlhausen, France, Sergeant Zwetsch, platoon guide, was leading an assault team in the attack on a heavily fortified pillbox when pinned down by intense enemy fire. He continued the advance despite the intense fire, shooting from the hip as he went along. Sergeant Zwetsch overran one enemy position killing two riflemen, and continued on until caught in machine gun cross fire, falling mortally wounded. Sergeant Zwetsch's actions reflected the highest traditions of the military service. Residence: Chicago, Illinois. Next of kin: Mrs. Peggy E. Zwetsch (Wife), 3012 Fletcher Street, Chicago, Illinois.

On 15 March 1945, near Muhlhausen, France, during an advance through machine gun, mortar and artillery fire, Technician Barnum, aid man, ran 40 yards through the hostile fire to a seriously wounded man and administered aid. Observing four more casualties 40 yards to his front, he crawled through the hostile fire and administered aid. Technician Barnum's actions reflected the highest traditions of the military service. Residence: East Lansing, Michigan.

Staff Sergeant John V. McKinley, 3950230, Infantry, Company "I", 411th Infantry Regiment. For gallantry in action. On 21 April 1945, near Schorndorf, Germany, when leading infantry elements were pinned down by enemy machine gun and mortar fire, Sergeant McKinley discovered a machine gun 75 yards to the company's front. Disregarding the enemy fire which tore the butt plate from his rifle and severed the sling, he ran forward 60 yards and, throwing two hand grenades, knocked out the machine gun, killing the three-man crew. His actions reflected the highest traditions of the military service. Residence: Butte, Montana.

CAPTAIN EDWARD BRAY, 01322418, Infantry, Company "K", 411th Infantry Regiment. For gallantry in action. On 23 March 1945, as CAPTAIN BRAY made a flanking movement on Ehlenbach, Germany, heavy enemy fire was encountered which inflicted heavy casualties. CAPTAIN BRAY, discovering the main source of fire to be an enemy machine gun nest, ran to a point 25 yards from the hostile strongpoint and threw a grenade, destroying the gun and crew. He then made his way back to the company through intense sniper fire, reorganized the men and led them into the town, cutting off two enemy battalions

and capturing 261 prisoners. CAPTAIN RAY's actions reflected the highest traditions of the military service. Residence: Houston, Mississippi.

FIRST LIEUTENANT SAMUEL S. MOY, JR., C.H.E.W., Infantry, Company "X", 409th Infantry Regiment. For gallantry in action. On 21 March 1945, near Reisdorf, Germany, LIEUTENANT MOY was wounded by a grenade during an attack on strongly defended enemy positions in the Siegfried Line. After administering aid to a wounded comrade, and then himself, he started moving up a hill to rejoin his platoon. Finding his men stopped by the enemy fire, he moved up and down the platoon front urging and commanding his men on. The men, inspired by his actions, resumed the attack and succeeded in driving the enemy from their positions. His aggressive action reflected the highest traditions of the military service. Residence: Atlanta, Georgia.

SECOND LIEUTENANT WILMER J. BEAM, 30327921, Infantry, Company "I", 411th Infantry Regiment. For gallantry in action. On 15 March 1945, near Buhlhausen, France, LIEUTENANT BEAM, platoon leader, while advancing with attacking elements was pinned to the ground by intense fire. Disregarding the enemy fire, he dispersed his men on a line to bring effective fire on the enemy. He succeeded in advancing a short distance, then again pinned down by enemy machine gun fire. Dashing at the machine gun nest, he single handedly knocked it out. Continuing on to the next strongpoint he was wounded by enemy fire, but continued to shout directions to his men. In the process of this activity, LIEUTENANT BEAM was again wounded by an enemy grenade rendering him incapable of movement. LIEUTENANT BEAM's actions reflected the highest traditions of the military service. Residence: Louisville, Kentucky.

II -- AWARD, POSTHUMOUS, OF SILVER STAR. Under the provisions of Army Regulations, 600-45, 22 September 1943, as amended, the Silver Star is awarded, posthumously, to following named individual:

Staff Sergeant Sam L. Muffoletto, 1416173, Infantry, Company "A", 411th Infantry Regiment. For gallantry in action. On 10 December 1944, near Greisbach, France, Sergeant Muffoletto was leading his squad as point for his company, when machine gun fire pinned down the company and, as the men sought cover, an artillery and mortar barrage inflicted several casualties. Sergeant Muffoletto, disregarding the enemy fire, crawled forward 100 yards and upon reaching a position close to the hostile machine gun emplacement, opened fire with his rifle, killing two of the enemy. As he was crawling back to rejoin his company, he was mortally wounded by sniper fire. Sergeant Muffoletto's actions reflected the highest traditions of the military service. Residence: Memphis, Tennessee. Next of kin: Mrs. Vincent Muffoletto, (Mother) 1211 Ferry Street, Palma, Arkansas.

Technician Fourth Grade James F. Riggsby, 34307150, Infantry, Company "I", 411th Infantry Regiment. For heroism not involving actual conflict with the enemy on 19 May 1945, near Metz, Alsace. When an American soldier, unable to swim, fell into the cold waters of a lake having a strong current, Technician Riggsby, without hesitation dived into the swift current to rescue the drowning man. When the drowning soldier obtained a death grip around Technician Riggsby's throat, he was forced to swim under water for ten yards through the swift current to bring the man to shore. Succeeding in bringing the man to safety, he then applied artificial respiration. Technician Riggsby's heroic action undoubtedly saved the life of the American soldier. Residence: Lawrenceburg, Tennessee.

IV - AWARD, POSTHUMOUS, OF BRONZE STAR MEDAL. Under the provisions of Army Regulations, 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded, posthumously, to following named individual:

Staff Sergeant Willard N. Hancock, 36412191, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On 18 December 1944, near Robenthal, Germany, Sergeant Hancock left his place of concealment to scout positions from which to give effective support to a rifle company which had been halted. Disregarding machine gun, mortar and small arms fire, he led his men on section to the positions he had selected and then crawled alone to an exposed spot to direct the fire of his men. Although drawing intense fire to himself, Sergeant Hancock remained at his post and directed accurate fire, knocking out 3 guns, silencing four, killing and wounding 13 of the enemy. His actions reflected the highest traditions of the military service. Residence: Mishawaka, Indiana. Next of kin: Mrs Elsie Hancock (Mother), 522 Turner Avenue, Grand Rapids, Michigan.

V - AWARD OF OAK-LEAF CLUSTER TO BRONZE STAR MEDAL. Under the provisions of Army Regulations, 600-45, 22 September 1943, as amended, a bronze Oak-Leaf Cluster to Bronze Star Medal is awarded to following individuals:

Private First Class Norman J. Walsh, 31296942, Infantry, Headquarters Company, Second Battalion, 411th Infantry Regiment. For heroism in action. On 20 March 1945, near Robenthal, Germany, when communications between a pinned down rifle company and the battalion command post were needed, Private Walsh volunteered to establish contact. Moving forward, he became the target of a group of bypassed enemy soldiers and was forced to crawl 500 yards across an open field under mortar and automatic weapons fire. He located the pinned down company and after assisting in repulsing an enemy counter-attack, returned to the battalion with the needed information. His actions reflected the highest traditions of the military service. Residence: Boston, Massachusetts.

Private William B. Chick, 1914005, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On the night of 10 February 1945, near Gutsendorf, France, Private Chick advanced 100 yards through a mine field, marking a path for other members of a combat patrol. Arriving at a stream, he secured a position to cover the men as they placed a plank across

Private First Class Patrick E. Dunnahoo, 38447342, Infantry, Headquarters Company, Second Battalion, 411th Infantry Regiment. For meritorious service in connection with military operations against the enemy from 16 November 1944 to 3 May 1945, in France, Germany and Austria. Residence: Benton, Arkansas.

I - AWARD OF BRONZE STAR MEDAL. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded to following named individuals:

Private First Class Robert S. Emory, 16120730, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroic achievement in action. On 15 March 1945, near Bitschholz, France, Private Emory, litter bearer, advanced a distance of two miles across open fields under artillery and mortar fire and through unmarked mine fields to evacuate three wounded men. On one return trip when mortar fire fell in the area, he placed the casualty in a covered position and, as the enemy lifted their fire, continued on to the aid station. Private Emory's actions reflected the highest traditions of the military service.
Residence: Harvard, Illinois.

Private First Class Arthur G. Moradian, 31454314, Infantry, Company "A", 411th Infantry Regiment. For heroism in action. On 21 March 1945, near Nieder Schlettenbach, Germany, when his company was pinned down by machine gun fire, Private Moradian, on his own initiative, moved forward to deliver fire on the hostile emplacement. Despite the constant fire and, although wounded, he continued to fire his automatic rifle, silencing the machine gun until the company passed by. He killed four of the enemy by his accurate fire. Private Moradian's actions reflected the highest traditions of the military service. Residence: Bridgeport, Connecticut.

Private First Class Theodore H. Stolp, Jr., 13157177, Medical Department, Medical Detachment, 410th Infantry Regiment. For heroic achievement in action. On 15 March 1945, near Uhrwiller, France, Private Stolp displayed great courage by braving artillery and small arms fire to reach and treat the wounded. On one occasion, he exposed himself to direct small arms fire to administer medical treatment to a wounded man and to assist him, under close observation of the enemy, to take cover. His actions, which resulted in many casualties being quickly treated, reflected the highest traditions of the military service. Residence: Pittsburgh, Pennsylvania.

Technical Sergeant David L. Cole, 36413051, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroism in action. On 19 January 1945, near Sessenheim, France, Sergeant Cole exposed himself to artillery and small arms fire to direct the anti-tank platoon to advantageous positions during an armored supported counterattack. Although seriously wounded by an artillery burst that landed within a few feet of him, he remained, directing his platoon until the defense line was secured. His actions reflected the highest traditions of the military service. Residence: Alpena, Michigan.

FIRST LIEUTENANT HUGH J. LYNCH, 0546871, Infantry, Company "D", 410th Infantry Regiment. For heroic achievement in action. On 25 January 1945, when LIEUTENANT LYNCH'S platoon was counterattacking Schilleredorf, France, it drove a hostile force into the town and became pinned down by automatic weapon fire. Disregarding the enemy fire, he moved over open terrain, placing and directing his men and pointing out targets. After placing a machine gun into position, he remained for two hours holding the enemy until he was ordered to withdraw. LIEUTENANT LYNN then directed the withdrawal and assisted in the evacuation of the wounded. His actions reflected the highest traditions of the military service. Residence: Palfurrias, Texas.

Staff Sergeant Edward L. French, 11054553, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 6 March 1945, near Rothbach, France, when the anti-tank platoon positions were subjected to heavy mortar fire, Sergeant French discovered a camouflaged armored car being used by the enemy as an observation post. Ordering his squad to remain covered, he personally manned his gun, under fire from the enemy, and scoring four direct hits at a range of 1200 yards, he silenced the enemy fire. His actions, which enabled a rifle company and his platoon to secure the battalion's defenses, reflected the highest traditions of the military service. Residence: Winchester, Massachusetts.

Private First Class James Kitabjian, 39560995, Infantry, Company "D", 411th Infantry Regiment. For heroic achievement in action. On 21 March 1945, near Nieder Schleitzenbach, Germany, when his company commander was wounded, Private Kitabjian crawled forward 200 yards under small arms and artillery fire to administer aid. Capturing three enemy soldiers, he made a litter and forced the prisoners to help him carry the officer to safety. His actions reflected the highest traditions of the military service. Residence: Alhambra, California.

Private First Class Sidney W. Tyler, 20939639, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On 24 April 1945, near Munsingen, Germany, when a motorized column encountered machine gun, anti-tank and small arms fire, the lead vehicle was wrecked by a direct hit from an anti-tank gun. Private Tyler, disregarding the enemy fire, drove forward from his position in the column, picked up two men and continued on to the lead vehicle. Despite several hits on his truck, he loaded the casualties on the vehicle and removed them from the danger zone. His actions reflected the highest traditions of the military service. Residence: Greenriver, Wyoming.

Sergeant Melvin C. Mason, 37430748, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On 24 April 1945, near Munsingen, Germany, when a motorized column encountered machine gun, anti-tank and small arms fire, the lead vehicle was wrecked by a direct hit from an anti-tank gun. Sergeant Mason, disregarding the enemy fire, moved to an exposed position and directed the withdrawal of his squad to safety. Returning to the column, he summoned the aid men and led them forward 1000 yards, then assisted in giving aid and placing the casualties on the litter vehicle. For meritorious service in connection with military operations against the enemy from March 1943 to 8 May 1945, in North Africa, Italy, France, Germany and Austria. Residence: Everett, Washington.

Technician Fifth Grade Patrick H. Cahalan, 37447550, Medical Department, Medical Detachment, 411th Infantry Regiment. For heroism in action. On 20 March 1945, near Nieder Schlettbach, Germany, Technician Cahalan, working in the aid station supporting attacking troops, was delivered a seriously wounded officer who needed immediate evacuation. To evacuate the wounded man necessitated crossing an area under sniper fire. Captain Stanley H. Sahn, 0552849, Medical Corps, Medical Detachment, 409th Infantry Regiment. For meritorious service in connection with military operations against the enemy from 9 November 1944 to 8 May 1945, in France, Germany and Austria. Residence: Brooklyn, New York.

Private First Class Lloyd J. Brown, 32762382, Infantry, Headquarters Company, Third Battalion, 409th Infantry Regiment. For heroic achievement in action. On 29 January 1945, near Oberach, France, Private Brown had led his combat patrol to a friendly outpost house after completing a mission when a barrage of mortar and direct artillery fire struck the building, causing six casualties. Enlisting the aid of seven men, Private Brown improvised a litter from two cumbersome bed springs and led the men in carrying two of the seriously wounded 1200 yards through the hostile fire over an open road. Upon arriving at a foot bridge, the intensity of the fire forced the men to cover. On his hands and knees, Private Brown pushed the litter across the foot bridge and then continued on with the aid of the men. His actions reflected the highest traditions of the military service. Residence: Newark, New Jersey.

For meritorious service in connection with military operations against the enemy from 13 March 1943 to 1 January 1945, in North Africa, Italy and France. Residence: Long Island, New York.

Sergeant Christopher E. Darcy, 31224471, Infantry, Company "B", 411th Infantry Regiment. For heroism in action. On 19 March 1945, near Bobenthal, Germany, when his company was pinned down by enemy fire coming from a pillbox, Sergeant Darcy secured a charge of high explosives and crawled 100 yards to the emplacement. He then placed the charge close to the pillbox, killing seven of the enemy and forcing four others to surrender. Sergeant Darcy's actions reflected the highest traditions of the military service. Residence: Boston, Massachusetts.

Private First Class John C. Nettling, 33941217, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroism in action. On 15 March 1945, near Schillersdorf, France, Private Nettling, observing a truck loaded with ammunition with a tire punctured by artillery and mortar fire, left his place of cover and rushed to the vehicle. Although the truck was again struck by enemy fire, he changed tires and then drove the vehicle to cover. Private Nettling's actions reflected the highest traditions of the military service. Residence: Steelton, Pennsylvania.

Staff Sergeant Amodeo A. Burrell, 0157377, Armor, Company "D", 71st Tank Battalion. For heroism in action. On 25 January 1945, Sergeant Burrell placed the tanks of his platoon in carefully selected positions from which fire could be effectively delivered on Kuhlhausen, France. Seeing a column of about 100 SS troops, he ordered his tanks to open fire, inflicting many enemy casualties and forcing the remainder to withdraw. On 26 January 1945, Sergeant Burrell effectively supported attacking infantry troops in capturing the town of Schillersdorf, France. His leadership and calm efficiency reflected the highest traditions of the military service. Residence: Boston, Massachusetts.

CAPTAIN JAMES D. VIBRANLY, 01296135, Infantry, Headquarters, Second Battalion, 409th Infantry Regiment. For meritorious service in connection with military operations against the enemy from 6 January to 2 May 1945, in France, Germany and Austria. Residence: Gulfport, Mississippi.

FIRST LIEUTENANT JOHN D. SCHRAMM, 0141908, Infantry, Company "C", 409th Infantry Regiment. For heroic achievement in action. On the night of 25 April 1945, near Ob Eichingen, Germany, LIEUTENANT SCHRAMM made a reconnaissance through mortar and sniper fire for a route in the crossing of the Danube River. Returning to his company, he led them across the river in assault boats and, after establishing a beachhead, disregarded fire of his own men in the darkness to lead the company to its objective. On 12 December 1944, in Prinsendorf, France, when four enemy tanks overran the outposts of our defenses, Private Thomas sighted the tanks and gave their position and range to his squad leader. Disregarding personal safety, he then advanced to within a few yards of the lead tank and halted it with bazooka fire. As he expended his ammunition, he was pinned down by machine gun fire from the tanks. While the anti-tank guns demobilized the tanks, Private Thomas fired at the crew with his carbine, preventing their escape. His actions reflected the highest traditions of the military service. Residence: Belton, Texas.

Private First Class John A. Valley, 34918045, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For heroic achievement in action. On 22 March 1945, near Nieder Schlettenbach, Germany, when intense enemy fire prevented previous attempts to evacuate the wounded, Private Valley organized a group of men and attempted to reach the casualties. Pinned down by machine gun and sniper fire, he continued on alone to the casualties and, crossing the fire-swept terrain three times, dragged or guided the wounded to cover. Private Valley's actions reflected the highest traditions of the military service. Residence: Vicksburg Bend, Alabama.

After administering aid, he assisted in placing a wounded man on a litter and carrying him 1000 yards to the safety of a woods where he was evacuated. Disregarding artillery, mortar and small arms fire, he made his way a distance of 1000 yards regaining the breaks. Observing eight, heavily armed, enemy soldiers approaching, he opened fire, killing two, wounding four and forcing the remainder to withdraw. His actions reflected the highest traditions of the military service. Residence: Arlington Heights, Illinois.

SECOND LIEUTANT D. MILTON WRIGHT, 02005992, Infantry, Company "G", 411th Infantry Regiment. For heroic achievement in action. On 15 March 1945, near Zinswiller, France, when an adjacent company was halted by mortar and machine gun fire, Lieutenant Wright led his platoon in a flanking movement against the enemy positions. The platoon, under his leadership, captured ten of the enemy and enabled an isolated group to rejoin its company. Directing the withdrawal of his platoon, he remained alone, directing artillery fire to cover their withdrawal. His actions reflected the highest traditions of the military service. Residence: Austin, Texas.

Sergeant John Gossela, 36548539, Infantry, Company "H", 411th Infantry Regiment. For heroic achievement in action. On 1 December 1944, near Ebersheim, France, Sergeant Gossela voluntarily crossed 200 yards of open terrain under artillery, mortar and small arms fire to act as flank security against an anticipated counterattack. Reaching a position, he observed a squad of twelve, heavily armed, enemy soldiers approaching. Holding his fire until they were within 25 yards, he fired a bazooka, killing three, wounding two, and forcing the remainder of the enemy soldiers to flee. His actions reflected the highest traditions of the military service. Residence: Rockwood, Michigan.

Staff Sergeant Raymond T. Grantland, 33341733, Infantry, Company "M", 411th Infantry Regiment. For heroic achievement in action. On 19 January 1945, near Sessenheim, France, when mortar support was needed for an attacking battalion, Sergeant Grantland established an observation post close to

On 15 March 1945, near Muhlhausen, France, when the communications sergeant was wounded by a mine and his radio was left in a mined area, Sergeant McPheeters attempted to secure the radio. Cautiously entering the mine field and, despite sniper fire, he secured the radio. Returning to the company, he maintained communications with adjacent units enabling a coordinated attack to be made. His actions reflected the highest traditions of the military service. Residence: Cleveland, Tennessee.

Technical Sergeant Kenneth L. Shafer, 37541925, (then Staff Sergeant), Infantry, Company "W", 411th Infantry Regiment. On 16 November 1944, near Les Mortiers, France, when Company "H", was subjected to artillery, mortar and small arms fire it suffered several casualties. Sergeant Shafer, seeing two wounded men lying in an exposed position, crawled 200 yards over open terrain and, disregarding the enemy fire, administered aid. He then evacuated the two casualties to safety. His actions reflected the highest traditions of the military service. Residence: Kintyre, North Dakota.

Technical Sergeant Myron C. Hartman, 36288867, Infantry, Headquarters Company, Third Battalion, 411th Infantry Regiment. For heroism in action. On 19 March 1945, near Bobenthal, Germany, when the third battalion was held up by mortar, small arms and machine gun fire, and a roadblock prevented tanks from supporting the troops, Sergeant Hartman moved forward to blow up the obstacle. Carrying 25 pounds of dynamite, he crawled 100 yards under the hostile fire, set his charges, and blew up the roadblock. His actions, which enabled the tanks to move forward in support, reflected the highest traditions of the military service. Residence: Medford, Wisconsin.

FIRST LIEUTENANT ERIN P. SCOTT, JR., 0546875, Infantry, Headquarters Company, First Battalion, 411th Infantry Regiment. For meritorious service in connection with military operations against the enemy from 23 November 1944 to 6 May 1945, in France, Germany and Austria. Residence: Atlanta, Georgia.

Staff Sergeant Franklin D. Robbins, 19153172, Infantry, Company "B", 411th Infantry Regiment. For heroic achievement in action. Private First Class John E. Prieston, 12067286, Infantry, Anti-Tank Company, 411th Infantry Regiment. For heroic achievement in action. On 21 April 1945, near Kirchheim, Germany, a motorized task force was subjected to intense enemy fire and an anti-tank prime mover was struck and immobilized. Without hesitation and despite the intense enemy fire, Private Prieston disengaged the 57mm gun from the prime mover, "hoisted the gun in position and opened fire on the enemy. He continued to fire until a direct hit on his gun forced it out of action. Private Prieston's actions drew the larger part of the enemy fire on his position and enabled other members of the task force to take cover. His actions reflected the highest traditions of the military service. Residence: Bronx, New York.

Private First Class John L. Uschlbee, 35531134, Infantry, Company "E", 411th Infantry Regiment. For heroic achievement in action. On 4 May 1945, near Gomeling, Germany, Private Uschlbee, a P.M.R. man, was participating in a company attack when the entire company was pinned down by intense enemy machine gun fire. Despite enemy observation and the intense fire, Private Uschlbee crawled over 100 yards to within 75 yards of the enemy positions. He then opened fire, effectively silencing the enemy weapon, killing two and capturing five of the enemy. Private Uschlbee's actions were in accordance with the highest traditions of the military service. Residence: Cleveland, Ohio.

SECOND LIEUTENANT JAMES F. MC KEE, 02011583, Infantry, Company "E", 411th Infantry Regiment, (then Technical Sergeant). For heroic achievement in action. On 13 February 1945, near Muhlhausen, France, LIEUTENANT MC KEE was leading a combat patrol with the mission of obtaining information of enemy action when the patrol was subjected to intense enemy fire. Skillfully leading his patrol to safety, he then returned to rescue a man who had been seriously wounded by a mine. Although under direct enemy observation and intense fire, LIEUTENANT MC KEE carried the wounded man over 150 yards to a position of safety. Continuing his mission, he secured valuable information concerning enemy positions, strength and supporting weapons. LIEUTENANT MC KEE's actions reflected the highest traditions of the military service. Residence: Ridgely, Tennessee.

Private First Class John V. Rauseo, 11131736, Infantry, Company "F", 411th Infantry Regiment. For heroic achievement in action. On 24 November 1944, near St Die, France, Private Rauseo, as lead scout for the point, moved forward despite almost constant small arms fire. Surprising eight enemy soldiers, he engaged them in a fire fight and held them pinned down until other men of his company assisted in their capture. Continuing on, he engaged three more of the enemy, wounding one and capturing all three. His actions reflected the highest traditions of the military service. Residence: Everett, Massachusetts.

* Staff Sergeant Brian I. Waudby, 37447011, Infantry, Company "E", 411th Infantry Regiment. For meritorious service in connection with military operations against the enemy from 16 November 1944 to 8 May 1945, in France, Germany and Austria. Residence: Sterlee, Iowa.

II - AWARD OF BRONZE OAK-LEAF CLUSTER TO BRONZE STAR MEDAL. Under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Oak-Leaf Cluster to the Bronze Star Medal is awarded to following named individuals:

Technician Fourth Grade Leonard Radjewski, 36549277, Medical Department, Medical Detachment, 411th Infantry Regiment. For meritorious service in connection with military operations against the enemy from 16 November 1944 to 15 March 1945, in France. Residence: Detroit, Michigan.

CAPTAIN LOUIS J. WADLE, 0435920, Field Artillery, Company "A", 776th Tank Destroyer Battalion. For heroism in action. On 17 October 1944, near Dragoni, Italy, CAPTAIN WADLE was moving forward with the advance platoon of his company when the platoon leader, platoon sergeant and two others were wounded by a mortar barrage. Without hesitation, he went forward under intense enemy fire and dragged each of the wounded men 75 yards to a gully where he administered aid. Again moving through the hostile fire, he secured litter bearers for the men. After supervising the evacuation of the wounded men, CAPTAIN WADLE returned to the company, reorganized it, and then continued the attack. His actions reflected the highest traditions of the military service. Residence: Adrian, Massachusetts.

Staff Sergeant David L. Feiser, 37245366, Infantry, Company "E" 411th Infantry Regiment. For heroism in action. On 19 March 1945, near Bobenthal, Germany, when his platoon encountered intense fire from an enemy flak gun, Sergeant Feiser led the men to cover, and moved forward alone to locate the gun. Advancing 300 yards and locating the position of the gun, he returned, organized his platoon and, directing effective fire, silenced the gun and killed three of the enemy. Sergeant Feiser's actions reflected the highest traditions of the military service. Residence: Kansas City, Missouri.

Private First Class Charles H. Lockhart, 1804532, Infantry, Company "E", 411th Infantry Regiment. For heroism in action. On 16 March 1945, near Zinswiller, France, when his platoon was cut off from the company by intense fire, Private Lockhart organized a three man patrol and went in search of the company. Encountering about 50 of the enemy coming in their direction, he ordered his men to cover and, crawling forward 50 yards, held off the enemy, killing three and wounding several others. As soon as darkness fell, he covered the withdrawal of the squad and located the company. Private Lockhart's actions reflected the highest traditions of the military service. Residence: El Paso, Texas.

AWARD OF SPOTTY STAR MEDAL (CONT'D)

Staff Sergeant William R. Michael, 17069671, Infantry, Company "E", 411th Infantry Regiment. For heroic achievement in action. On the night of 7 March 1945, near Bitschholz, France, Sergeant Michael was leading a combat patrol to gain information of enemy activity when he discovered the enemy laying mines and, hearing voices on both flanks, decided to withdraw. Pinned down by enemy machine gun and rifle fire as the men withdrew, he crawled 50 yards and neutralized an emplacement, killing four of the enemy and enabling the patrol to withdraw. Sergeant Michael's actions reflected the highest traditions of the military service. Residence: Oelwein, Iowa.

Sergeant James E. Hayes, 20230363, Infantry, Company "B", 411th Infantry Regiment. For heroic achievement in action. On 24 April 1945, near Memmern, Germany, when his platoon was unexpectedly surrounded by enemy troops, Sergeant Hayes voluntarily covered the platoon as it withdrew a distance of 350 yards. Engaging the enemy with rifle fire and grenades, he killed and wounded several of the enemy, enabling the men to reach safety. Sergeant Hayes' actions reflected the highest traditions of the military service. Residence: San Fernando, Calif.

Private First Class Merle A. Shepp, 13092735, Infantry, Company "E", 411th Infantry Regiment. For heroic achievement in action. On 16 November 1944, near LaBolle, France, when a heavy artillery and mortar barrage wounded several men in his platoon, Private Shepp, also wounded, exposed himself five times to administer aid to his comrades. Then refusing to leave the firing lines, he remained with the platoon until receiving a direct order to fall back. Private Shepp's actions reflected the highest traditions of the military service. Residence: York, Pennsylvania.

FIRST LIEUTENANT FLOYD C. MILLER, 01325292, Infantry, Headquarters, Second Battalion, (then Cannon Company), 411th Infantry Regiment. For heroic achievement in action. On 8 January 1945, during an attack on Schrun, France, when Company "C", 411th Infantry was pinned down by small arms and mortar fire, Lieutenant MILLER, Cannon Company observer, advanced to a building on the edge of the town. Cautiously climbing to the attic, he killed two of the enemy and, setting up his radio, directed fire on the hostile positions. When a concentration of mortar and bazooka fire struck the house and demolished his radio, Lieutenant MILLER crossed 500 yards of open terrain under hostile fire, spliced into the battalion communication line, and continued to direct fire. His actions reflected the highest traditions of the military service. Residence: Marlinton, West Virginia.

SECOND LIEUTENANT KENNETH D. HERZBERG, 02011751, (then staff Sergeant), Infantry, Company "B", 411th Infantry Regiment. For heroic achievement in action. On 10 December 1944, when his company was pinned down by hostile fire, Lieutenant HERZBERG, with a squad in a draw, led the men forward 500 yards and, observing an enemy self-prop 110mm gun, opened fire, killing two of the enemy and capturing one. He then led the squad into Schirlehof, France, and secured a position so that his company could advance into the town. Lieutenant HERZBERG's actions reflected the highest traditions of the military service. Residence: Chicago, Illinois.
