The third mistake is a name spelling. Our Editor is Harold Branton and not Blanton.

We welcome and honor our descendants becoming a part of this organization. They should be equally honored to be a part of the plans for them to become members and to help preserve this vital part of our history for future generations.

I recently visited Dallas, Denton and Gainesville, Texas working on plans for our 2002 reunion.

In Dallas, we were offered and have accepted some super arrangements for hotel accommodations for the reunion to be held 25-29 September 2002. Also, we surveyed the Preston Wood Country Club for our golfers. Rates are \$74.00 per night and if things go as planned, we will only be required to pay the occupancy tax. We have also arranged to book and hold all hospitality rooms at the same \$74.00 rate. All companies or other units with sufficient attendance should be able to obtain satisfactory accommodations for their individual groups. A computer sort by company unit level revealed that only 5 units had 10 or more members registered at the last reunion. The hotel will be able to assign the larger hospitality suites to larger units.

In Denton, we met with the Chamber of Commerce and they are checking into a possible reception at the college honoring former ASTP members and others who may wish to visit during their stay.

### SEARCH COMMITTEE RECOMMENDATIONS

#### **ORGANIZATION**

According to the vote at the 2000 reunion in Little Rock, Arkansas, it is agreed that we will continue our

organization and the annual reunions.

CURRENT NAME: The current official name according to the Constitution is 103rd Infantry Division Association of WW II.

NEW NAME: We propose that we shall be reorganized effective 01 January 2002 and make the following official name change to 103d INF DIV ASSOC OF WW II.

NEW LOGO: It is recommended that the reorganized unit adopt the official following logo. The font used in this logo is Antique Olive (a sign of peace). 103d is the official army abbreviation that was used during our combat action. Shown on letter head at top of page.

FINANCES: We recommend that our President, Ray Menuey, order that an official detailed audited financial statement be prepared for the annual period ending 31 December 2001. Remaining treasury funds to be transferred to the new organization 01 January 2002. Statements for dues for following years will be in THE CACTUS PATCH NEWS.

INCORPORATION: Our findings are that we are not currently incorporated. We therefore recommend that we incorporate in the State of Texas, where we trained before combat, as a non-profit organization. We should also apply to the IRS for the necessary tax-free status. One Division that we surveyed indicated that their members did not pay room tax for their reunion meeting.

ARTICLES OF INCORPORATION: A Texas State agency, TALA, will prepare the preliminary papers that are necessary for State approval. The President to appoint a committee of three to review and submit their written approval to the President for review and approval by the Executive Committee.

BY LAWS AND/OR CONSTITUTION: The president to appoint a committee of three to review our constitution and review others to arrive at a recommend one suitable for our planned revised organization. This final document to be reviewed and approved by our Executive Committee. It is always open to amendment.

MEMBERSHIP: It is recommended that we, instead of encouraging our descendants to establish a new organization, welcome them into our organization with full participation privileges. This includes the right of sons and daughters to be an officer or board member. We encourage them to accumulate and preserve our history for their future generations. We recommend assigning a Class letter for our records and to show on their ID cards what their relationship is to us. The following classes are recommended for inclusion in our Rosters for Historical Purpose.


The Memorial group of the 103d Infantry Division, WW II, gathered in Washington, D. C., on 7 November 2001. Again, survivors of the epoch World War II were to lay a wreath at the TOMB of the UNKNOWN scheduled for the late morning, 8 November. Although Veterans Day this year was Sunday 11 November, the schedule of ceremonies at Arlington Cemetery placed the 103d Division event on the preceding Thursday.

On that Wednesday evening, on 7 November before the event, the group of former members of the 103d went to dinner together at the Fort Meyers Officers Club. It was a fine dinner, and was enjoyed by Dick Pearson, Co F, 410th Infantry, Leonard Sattler and wife, Betzi, Co C, 410th Infantry, Nick Melas, Recon Company, 410th Infantry, John Kaiser and wife, Ann, Co F, 410th, Carl Boltz and wife, Joan, Co B, 411th, Mike Toohig and wife Barbara, Co B, 411th Infantry, and Dick Ball, B Battery, 382nd FA Battalion.

The first memorial erected by survivors of the Cactus Divisions wartime experience was accomplished by Company "A", 411th Infantry. Company "A" Association's Memorial, which was ceremoniously dedicated on October 22, 1989, is located immediately to the southeast of the Vosges Village of Saulcy-Sur-Meurthe. The small community is situated 6.5 Kilometers south of Saint Die.

The 411th Infantry men remained in Division Reserve during the period 18-21 November 1944 on the high ground southeast of and overlooking St. Die. Intensive patrolling along the south bank of the Muerthe River continued, and attack plans were refined. Upon division order, the Regiment attacked on 22 November to the northwest and crossed the river Muerthe. Movement through Saulcy by the 1st Battalion was initially unopposed. Bitter fighting beyond the town ensued, however, and the expansion of the bridgehead was consolidated with difficulty under heavy concentrations of artillery, mortar and machine gun fire. Casualties were heavy with Company A alone sustaining eight killed (and 17 wounded). Their names: ROSENDO CARDENAS, FRANK CARRACCIO, JR., EDWARD CIRICILLO, BAYARD DODGE, JR. RUSSEL FUCCY, HENRY GAYNOR, WILLIAM JAMES, AND JAMES VANOVER. They were members of A Company, 411th Inf., 103d Division. They were members of A Company, 411th Inf., 103d Division. the town. To ensure that their act of bravery will never be forgotten, homage is paid to them every year at the monument erected in their honor near the WW I Cemetery. This year again, civilian and military officials, along with local citizens, amongst whom some elders, remember the terrible moments.

The community band played the national anthems. Representatives of local veteran associations, bearing their unit flags rendered the honors, while 3 memorial wreaths were presented at the base of the monument. The mayor of Saulcy, Madame Deklhoume, and the Town concellors were present, as well as Claude Jacquot, National Representative, Roland Bedel, Vice President of the County Council, Serge Vincent, County Concellor, the local Army Commander, the Commander of the St. Die Police, and Superintendent Prieur. Doug Stellner and Simon Dargols, 2 WW II U, S. veterans. Doug was a member of A Company, 411th INF. In his address, Doug reminded the audience of the rough battle he and his comrades had gone through, on that cold and rainy day in 1944. Madame Delhoume read the names of the 8 heros who had come from over the seas, full of enthusiasms, to die here, so far from home and their families. "The ideal that brought them here, in our isolated village of the Vosges mountains, is the same ideal that is taking them now to the other side of the world, in Afghanistan", said the mayor of the town, Madame Delhoune, in expressing thanks and gratitude to the people of the United States for what they have done, yesterday and for what they are prepared to do again, tomorrow.

#### LETTERS TO THE EDITOR

From Mel Wright, Co. G, 409th Infantry:

"WERE YOU THERE Zinswiller, France, 15 March 1945?" The 2nd Bn, 411th was lined up on a small hill preparing to attack when or Battalion Commander received word that several men from the 410th Infantry on our left flank were out front and their company had lost contact with them. As junior officer of Co. G, 411th I was selected to take a squad from my 1st platoon, cross the stream before entering the edge of Zinswiller, turn left and go north up the hill to find the missing men. Half way up the hill north of the city we were challenged by a rifle shot over our heads and a yell, "Are you Gis?" We had amazingly gone straight to the missing men. As well as I can remember, there were about 6 missing and only 3 were in the bunker with several German prisoners. The remaining men had gone back to establish contact with their company.

As we were considering what to do next, our radio operator, whom I remember only as "Bing", received a message from the Battalion Commander ordering us to continue the search for the remaining men. Leaving half my squad and taking two of the 410th men, we followed a logging trail to a ravine leading down the hill. Shortly, we found the other missing men and picked up some more German P.Ws. We started back up the little road when low and behold! about 50 yards away there before us was what appeared a company of German soldiers taking a "break". The radio operator stayed with me behind a pile of logs while the others continued on to the first discovered

Having a detailed map in hand, we radioed our position to the Forward Observer; the FO then by radio, gave both his and our coordinates to the Fire Direction Center, DIVARTY, and pretty soon the site of the German's rest

area was a roaring inferno. As a side light to the above affair, and during the time we were on that hill, I recall watching two of our lead scouts in the town below running on a road through the city. As they ran the German artillery was felling, just behind them. They would stop and hit the ground, then up and go just ahead of the next `88. We were yelling, "Run faster, faster!"
